MINUTES OF SPECIAL MEETING OF BOARD OF TRUSTEES OF

YOUNGSTOWN STATE UNIVERSITY

Tod Administration Building Monday, April 26, 1999

Pursuant to written call of the board chairperson, a special meeting (the one hundred and ninety-fifth) of the Board of Trustees of Youngstown State University convened at 4:00 P.M., Monday, April 26, 1999, in the Board Room in Tod Administration Building.

Eight trustees were present at the meeting, to-wit: Mr. Bruce R. Beeghly, Chairperson of the Board, who presided, Mr. Martin J. O'Connell, Dr. Y. T. Chiu, Mrs. Ruth Z. Wilkes, Mrs. Eugenia C. Atkinson, Mr. Joseph S. Nohra, Dr. Chander M. Kohli, and Mr. Larry E. Esterly. Also present was student trustee David N. Myhal. Absent was Mr. Charles B. Cushwa III.

Also present were: Dr. Leslie H. Cochran, President; Dr. James J. Scanlon, Provost; Dr. G. L. Mears, Executive Vice President; Dr. Cynthia A. Anderson, Vice President for Student Affairs; Dr. Charles A. McBriarty, Special Assistant to the President, and Franklin S. Bennett, Jr., Secretary to the Board of Trustees. Also present were approximately 20 persons, including deans, members of the faculty, students, administrators, and members of the news media.

The Chairperson called the meeting to order.

ITEM I - PROOF OF NOTICE OF MEETING.

Evidence was available to establish that pursuant to Article II, Section 2, of the board's <u>Bylaws</u>, notice of the chairperson's call for the special meeting was timely provided to each of the nine trustees, the student trustee, and to the president.

ITEM II - DISPOSITION OF MINUTES FOR REGULAR MEETING HELD MARCH 12, 1999.

The chairperson stated that disposition of the minutes of the board's regular meeting held March 12, 1999 would be deferred until the next regular meeting of the board.

ITEM III - REPORT OF THE BOARD OF TRUSTEES CHAIRPERSON.

- 1. <u>Search Process Guidelines.</u> Mr. Beeghly distributed a document entitled "Preliminary YSU Presidential Search," a copy of which is attached to these minutes. Mr. Beeghly stated that the preliminary guidelines are for purposes of thought and discussion, noting that the search consultant should be involved in the preparation of final guidelines. The board discussed the preliminary guidelines in detail, and no formal action was taken.
- 2. <u>Presidential Search Advisory Committee.</u> The board discussed the chairperson's recommended list of appointees to the Presidential Search Advisory Committee, included with the board's agenda.

Resolution Appointing Members to the YSU Presidential Search Advisory Committee

Following discussion, Mr. O'Connell moved that the board approve by resolution the chairperson's recommended appointees to the Presidential Search Advisory Committee, as included with the agenda. The motion was seconded by Mrs. Atkinson. The motion received the affirmative vote of all trustees, and was declared carried by the chairperson.

3. <u>Selection of Advisory Firm.</u> Mr. Beeghly reported that five firms were requested to submit proposals as consultants to the presidential search process, and that four of the firms had submitted proposals (A list of the five firms from which proposals were requested is attached to these minutes.) The board discussed the relative strengths of the proposals. After discussion, and upon motion made by Mrs. Wilkes, seconded by Dr. Kohli, the board unanimously agreed, with Mr. O'Connell abstaining, to invite Dr. Allan Ostar of Academic Search Consultation Service to meet with the board to discuss his firm's proposal.

ITEM IV - COMMUNICATIONS, MEMORIALS

The were no communications or memorials considered by the board.

ITEM V - UNFINISHED BUSINESS

There was no unfinished business considered by the board.

ITEM VI - NEW BUSINESS

There was no new business considered by the board.
