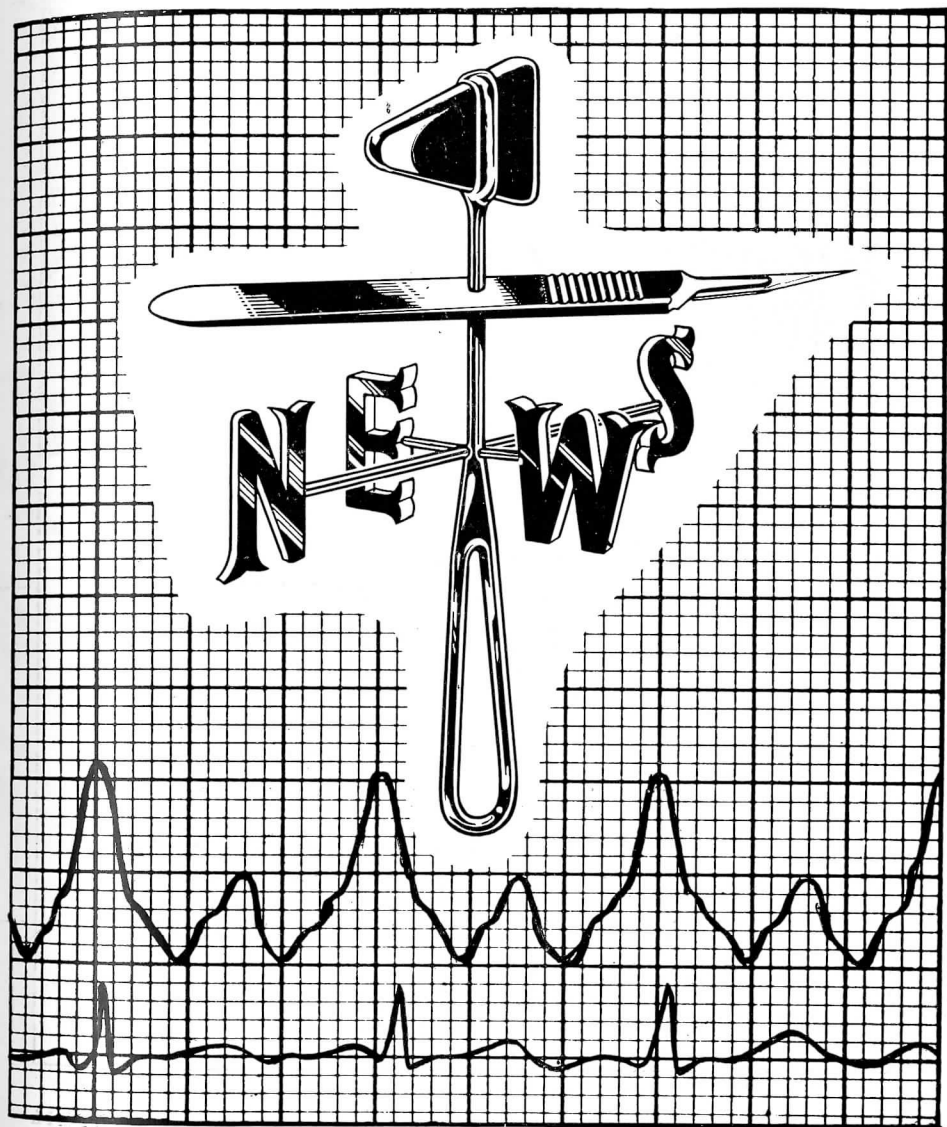

From the Desk of the President

An unfortunate situation has developed in the past few years in the relationship between the Mahoning County Medical Society and the Mahoning Valley Health Planning Association. In my opinion, during this time, physicians have been discriminated against and ignored by the Planning Association on a number of occasions with resultant downgrading of the role played by physicians in the Planning Association. Consequently, I recommended withdrawal from this organization by the Mahoning and Trumbull County Medical and Osteopathic Medical Societies.

In the past two months I presented this matter to the Councils of these societies and to a general meeting of the Trumbull County Medical Society. After the presentations to these societies, the majority opinion was not to withdraw from the Planning Association. Since the Mahoning County Medical Society had no regular general meeting last month, a report will be given at the April 15th meeting.

On March 25th the Councils of the Mahoning and Trumbull County Medical Societies and representatives of the two Osteopathic Medical Societies had an informational meeting with representatives of the Planning Association. During this meeting, the 'grievances' of the medical societies were thoroughly discussed, and we were invited to send representatives to the next meeting of the Board of Trustees of the Planning Association to present our plea for greater representation on the Board. This was done and the results will be included in the report at the Mahoning County Medical Society's April 15th meeting.

To refresh the memory of our members with regard to the background and formation of the Planning Association, plus some of the complaints that have arisen, I am herewith giving a brief summary.

The Mahoning County Medical Society was interested in community hospital and health planning for a long time, crystallizing some of its ideas in November and December 1962 when the Council passed a motion urging the establishment of a hospital planning association for the Youngstown area. Discussions along these lines continued for a number of years and emphasized the importance of area-wide hospital planning. On June 14, 1966, our County Society passed a motion that we join with the Trumbull County Medical Society and the Mahoning County Osteopathic Medical Society in the formation of a hospital planning group.

Through the efforts of our Society, Sister Consolata, Administrator of St. Elizabeth Hospital, and Mr. John F. Latcham, Administrator of Trumbull County Memorial Hospital, various community groups were invited to an organizational meeting on November 17, 1966, when the Mahoning Valley Health Facility Planning Association was formed. Operating funds for this organization were secured as gifts from the local organizations that formed the Planning Association (or were later to be admitted) and from grants from

the Public Health Service or from the Federal Government under the Hill-Burton Act. Mr. Latcham became the Acting Project Director.

In December 1966 the Mahoning County Medical Society Council voted to contribute \$1,000 in 1967 and \$1,000 in 1968 to the Planning Association, these actions being approved by the Society in April 1967. This \$2,000 was subsequently contributed to the Planning Association.

In August 1967, the Planning Association appointed Mr. J. Stanley Johnstone to the post of Director of the Association, to assume his duties in October 1967. Mr. Paul E. Martin, of Warren, was elected President of the Association.

Also in August 1967, Dr. Harold Reese, then President of the Mahoning County Medical Society, wrote to Mr. Martin requesting greater representation for physicians on the Planning Association's Board of Trustees, the governing body of the Association. The Board of Trustees is made up of 38 members, ONLY SIX OF WHOM ARE PHYSICIANS. As a result of physicians thus being outnumbered, it is obvious how easily they can be outvoted on any issue. Dr. Reese and Dr. Allan Shaffer (Past President of the Trumbull County Medical Society) had been promised at previous meetings of the Planning Association that more physician representatives would be appointed to the Association's Board of Trustees. This was voted down by the Board of Trustees, and Dr. Reese expressed serious misgivings about the small representation of physicians on the Board of Trustees, stating that the Mahoning County Medical Society would "not be satisfied with a medical-affiliated organization run by laymen with a minimum of physician representation." Not only do I agree that the medical profession should have a stronger representation in this organization, but I believe that we should have the majority voice since we are by far the majority of the suppliers of health care in this or any community.

Since then, no additional physicians have been added to the Association's Board of Trustees. Other organizations were and will be admitted to the Association, since efforts are being made to have the Planning Association include other counties adjacent to Mahoning and Trumbull Counties. Obviously, this will further dilute the voting power of physicians on the organization's Board of Trustees, since it is apparent to me that the flavor of the Planning Association's policy is to downgrade the influence of area physicians in the organization by refusing to appoint more physicians to the Board and to keep the percentage of physician voting strength the same or possibly even to reduce it.

One of the physicians on the Board of Trustees of the Planning Association is Dr. Sidney Franklin, originally appointed as the representative of the Youngstown Board of Health in his capacity of Health Commissioner, and since his resignation sometime ago, regarded by the Mahoning County Medical Society as one of its two representatives on the Association's Board of Trustees. Our other representative is Dr. Richard Murray. In 1967 Dr. Franklin was appointed to the Nominating Committee of the Association. He has never afterward received any notification of any meeting of this Committee, though it has made some nominations. Also, and worse still, he has never been appointed to any other committee of the Association. Considering the facts that Dr. Franklin has a Master's degree in Public Health from Columbia University and that he has considerable experience in the Public Health field, having served as Health Commissioner of the city of Youngstown, it is indeed incongruous that the Association did not avail itself of his experience! After all, he has more experience in the health field than any member on the Board of Trustees.

On February 20, 1969, Mr. Martin, President of the Planning Association, appointed attorney David Hill, Youngstown urban renewal director, to head a committee to study the organizational structure of how best to accomplish the objectives of the Association. Mr. Johnstone, Director of the Planning Association, stated, in a special meeting with representatives of the Mahoning County Medical Society on February 25, 1969, that the newly appointed committee had erroneously been described publicly as planning a study of health needs here. The committee consists of six members in addition to the Chairman. The only physician on this Committee is Dr. George Sudimack, of Trumbull County. At the special meeting with Mr. Johnstone, the Mahoning County Medical Society's representatives protested several things about this committee. First, it was appointed without the knowledge of the Society or the Society's representatives. A study dealing with accomplishing the objectives of the Association, which are all in the health and medical fields, is certainly of great importance to the Medical Society. Ignoring us in the matter of forming such a Committee, let alone failure to notify us of its formation prior to publication, are certainly in the realm of discriminating against us. Despite the fact claimed by Mr. Johnstone that the formation of such a Committee was provided for in one of the Association's Board of Trustees' meetings of a year or more ago, I believe that we were not even shown the common courtesy of being informed of the Committee's formation. Secondly, though Mahoning County is the more populous county in the Planning Association's membership, there was no physician representative from Mahoning County on the Committee. Third, and most important of all, there was only one physician on a Committee of six people, which is about the same percentage as for the Board of Trustees, and which is grossly inadequate representation of physicians.

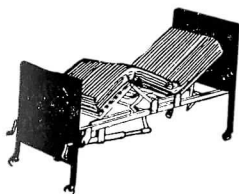
It seems to me that a health planning organization should be formed of a majority of physicians and other 'health providers', since the simple truth of the matter is that physicians and other 'health providers' deliver all of the health care in a community. The physicians are the ones who coordinate all health care, and should of necessity therefore be at the head of the team that directs health planning needs. It must come as a shock to two important groups delivering health care in this community—e.g. dentists and pharmacists—that they are not even represented on the Health Planning Association!

Now it might be asked why create such a fuss about Health Planning Associations, for of what importance are they? Where do they derive their power? The answers are simple. Health Planning Associations are now empowered by law to plan for all health facilities, services, manpower requirements for physical, mental and environmental health. The law specifically de-

tailing these powers is Section 314(b) Public Health Service Act, as amended by Public Law 89-749(1966). The powers are quite broad and will certainly affect the practice of Medicine and the building of hospitals, clinics, health centers, medical schools, etc. in the future, if not already doing so. When the Planning Association in any area is approved of or recognized by the local city government, the State Department of Health, and finally by the U. S. Department of Health, Education and Welfare (as our local Association already is), it then becomes the official health planning organization of the region. This designation entitles the planning association to make recommendations for the distribution of Hill-Burton and other federal funds in the area it represents. This financial power can be used as a deterrent against any health facility or organization, including hospitals, displeasing or in any way thwarting the will of the local health planning association. Without a planning association's approval, no Hill-Burton funds would be made available to a hospital or other organization's building or development program.

The law also provides that the majority of the membership on the Board of Trustees or governing body of a health planning association "must be consumers of health services broadly reflecting geographic, socioeconomic and ethnic groups in the area." This is the greatest injustice to and discrimination against physicians ever perpetrated. As suppliers of most health care, it is only logical and intelligent that physicians be at the head of any health planning group, rather than relegated to a minor role. I have never heard of the consumer running any business, manufacturing venture or organization supplying a business service! Private enterprise and freedom to conduct private enterprise made America the great country that it is. This law reverses this philosophy, and in my opinion, might be used to help subjugate the medical profession to eventual complete governmental control.

I believe that our county, state and national medical societies should seek repeal of this law, to be replaced by one that puts health care planning where it properly deserves to be—in the hands of the medical profession! Meantime, medical societies should form their own community health planning committees, as the Mahoning County Medical Society has already done.

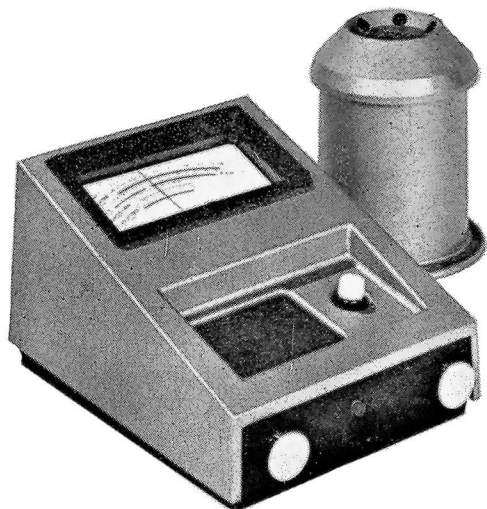
S. Q. LAYPIUS OBSERVES:

FROM THE BULLETIN

THIRTY YEARS AGO — APRIL 1939

Leading the group from the University of Pennsylvania who came to us for Post-Graduate Day that April was our old friend Charlie Wolferth, then Clinical Professor of Medicine. Charlie was Pathologist at the Youngstown Hospital in 1916 and went with Base Hospital 31 to France. When Dr. C. R. Clark was elevated to Consultant, Charlie took over as Chief of Medicine. After the war he went to Philadelphia to study at the University and soon became known as a national authority on heart disease.

Dr. Wolferth was succeeded in the laboratory by David L. Farley who also left to join our Base Hospital. After the war he too went to the University of Pennsylvania and became an authority on blood diseases. He is the co-author of the book "Practical Hematological Diagnosis" by Pepper and Farley.

Excerpts from a paper on "Medical Management of Peptic Ulcer" by Dr. L. S. Shensa: "Despite some opinions to the contrary, belladonna or atropine are the most satisfactory antispasmodics . . . Among the many forms of treatment, Sippy diet, alkali regimen together with the use of sedatives still ranks the highest . . . Treat the patient together with the ulcer . . . Do not temporize with hemorrhage or perforation."

TWENTY YEARS AGO — APRIL 1949

Another old friend came to us with the group from the University of Buffalo for our twenty first Post-Graduate Day. 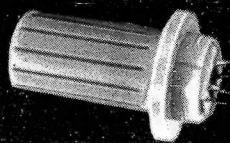

OSMA POLICY ON BANK CREDIT CARDS

The following policy on bank credit cards was adopted by The Council of the Ohio State Medical Association, November 16-17, 1968, upon recommendation of the Judicial and Professional Relations Committee of the Ohio State Medical Association:

- "1. The county medical society must be satisfied with the integrity of the plan or plans.
- "2. Any plan or plans should be open to all physicians on the same terms.
- "3. The individual physician may not, because of his participation in the plan or plans, increase his fee for medical service rendered to the patient.
- "4. The physician may not use the plan or plans to solicit patients, nor may he encourage patients to use the plan or plans. The plan shall be used only at the request of the patient.
- "5.(a) Plaques or other devices indicating participation in the plan are in poor taste displayed within the physician's office.
- (b) Plaques or other devices visible outside the physician's office are improper and unethical.
- (c) Imprinting of any indication of participation in a plan or plans on a physician's stationery, billhead, card or other device is improper and unethical.
- "6. Permitting his name to be used in a directory of participants in the plan or plans is an unethical act on the part of the physician."

TORT MALPRACTICE DEFINED

Professional misconduct is unreasonable lack of skill or fidelity in professional or fiduciary duty. Applied to physicians and surgeons, this term means, generally, professional misconduct towards patients, or failure to exercise the requisite standard of care.

More specifically, it means sub-standard treatment of a patient professionally and in respect to the particular disease or injury, resulting in injury, unnecessary suffering, or death.

Malpractice may be applied to medical practitioners, chiropractors, chiropodists, podiatrists, dentists, nurses, hospitals, nursing homes, veterinarians, other paramedical groups, druggists; various branches of engineering; drug, and other manufacturers and distributors; also accountants, chemists, bacteriologists, etc.

Much of trade negligence stems from inadequate testing before marketing. Government drug hypersensitivity regulations may materially assist and incidentally more directly relate to physician malpractice. Conversely, mechanical defects, only remotely related, endanger life in wholesale manner.

Their comparability to certain phases of medical malpractice may nevertheless be striking. Laboratory evidence of negligence is far more convincing than medical opinion, the latter subject to shading and various interpretations. Laboratory evidence may defeat or circumvent any "conspiracy of silence", in which individuals refuse to testify against fellow-practitioners or competitors.

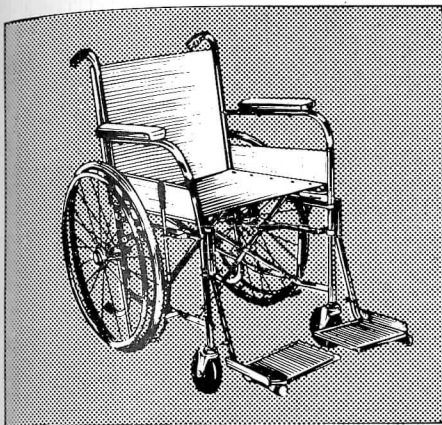

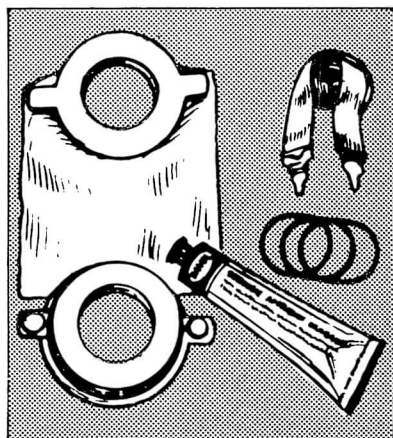

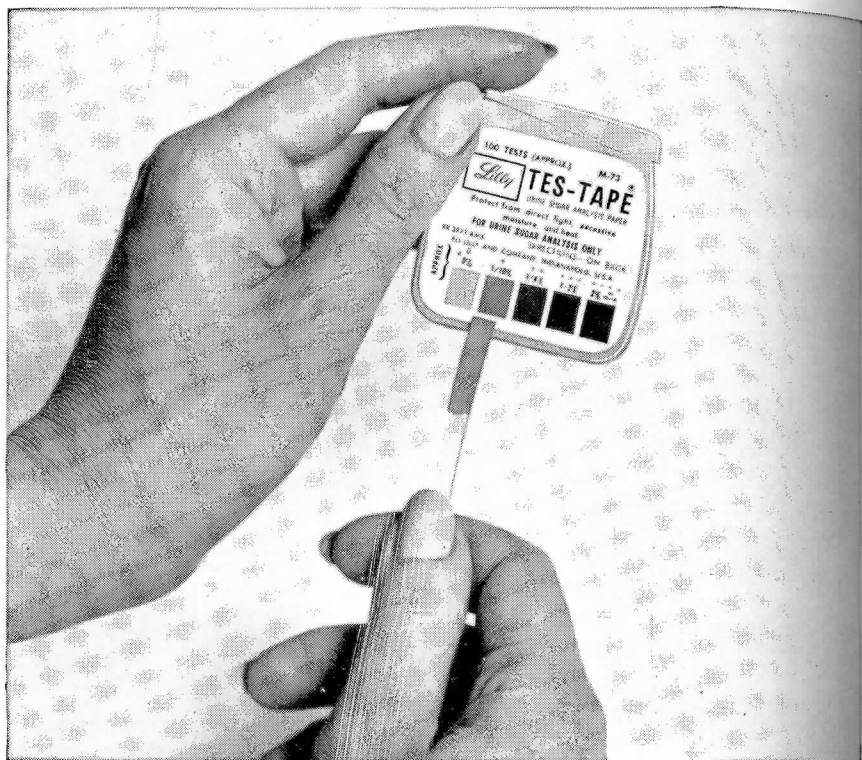
