Editorial**UNITED WE STAND — OR ELSE**

The current news media states that "indisputably and irreversibly on the way in the United States, is a National Health System" (Socialized Medicine). It is believed by many that socialized medicine will be of the highest priority in the next Congress. The proponents of socialized medicine cite the increasing cost of medical care. Too frequently, however, medical care means the physician, and yet, really includes many areas of medical care, such as drugs, dentistry, hospital cost as well as the physician's fee. It is true that many physicians during the past three, five or ten years have increased their fee, but so has the cost of living gone up in many other areas. Paycheck figures from the Labor Department averages for all non-farm workers in private industry show that the cost of living of all items has increased 32% during the past decade. The cost of commodity has increased 24%, services 47% and the weekly pay check by 52%. These were quoted recently in the Wall Street Journal. At the same time it shows physician fees has increased 58%, dental fees 47% and hospital daily services 160%. Even the cost of movies has gone up, that for an adult quoted as being 102% and that for children 108%. A large insurer recently hiked his rates for major medical (catastrophe) coverage 250%! as quoted by a recent newspaper columnist.

The cost of National Health Insurance Program for the first year is quoted from 62 billion up to 75 billion dollars a year. A very recent article stated that the total national budget will be approximately 215 billion dollars.

This issue of Socialized Medicine requires the time and attention of all physicians. Physicians need to be united now more than ever to prepare for the coming battle. To be prepared, we must be informed. The method of acquiring information and to show our togetherness is regular attendance at the meetings of the Mahoning County Medical Society. The large attendance of members at a recent meeting, where an important and highly controversial matter was discussed, is what we need more frequently. The next few meetings will be the election and installation of officers. We need the expression of thought on the vital issues of our day. This is, however, no place to denounce or insult one's opponent and critics, but rather to defend one's own stand on the issue and to stick to the issue. It is frequently said "United We Stand, Divided We Fall". This is true, today as it has been on many occasions in the past, during the course of the history of our country. Phy-

sicians need to be united in a common cause to provide adequate medical care for all of our citizens. We need not submit to compulsory socialized medicine or legislative regimentation. The Medical Society must resolve this issue without surrendering its' rights as a profession in a free society. To accomplish this, we need the co-operation of all physicians in a united front rather than being divided over local issues and thereby weakening our stand.

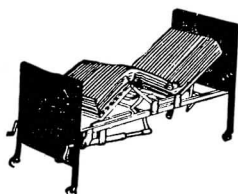

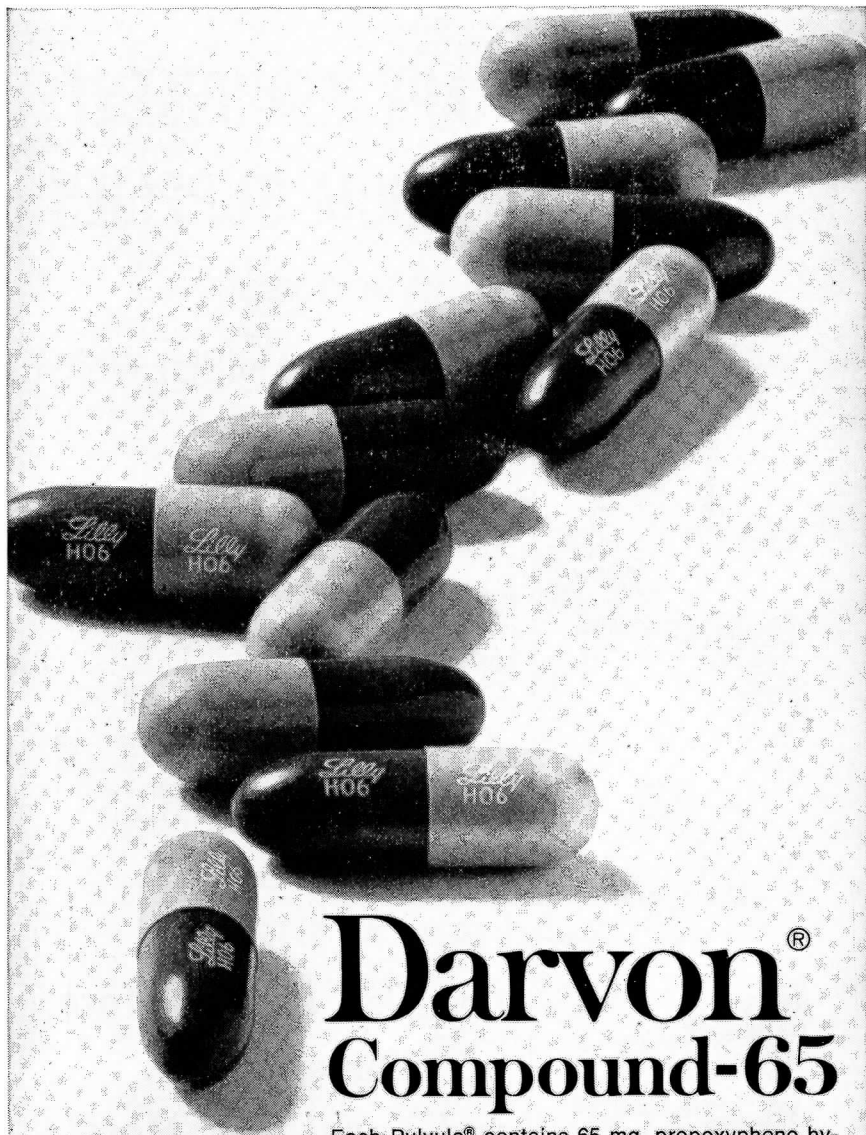

From the Bulletin



THIRTY YEARS AGO — DECEMBER 1940

The program committee was unhappy because they had brought Dr. Bockus here from Philadelphia for a series of five lectures on gastro-enterology and at the same time the Youngstown Hospital put on their open-house exhibit and the St. Elizabeth's nurses put on a big dance, both of which interfered with our attendance at the lectures.

The social committee reported the great success of the dinner for the state president, the late William Skipp, and of the dinner-dance at the Youngstown Country Club. They did not mention the hundred dollar deficit which had to be made up from the treasury and the subsequent criticism by some of the members.

The public health committee inspected the Contagious hospital on East Indianola Ave., and found it in deplorable condition. They made sweeping recommendations for its modernization. It is now the Woodside Receiving Hospital.

Dr. Harold J. Reese was elected to membership in the Society.

Norway, Holland, Belgium and France were occupied by Hitler's armies. German planes were swarming over England. The Burke-Wadsworth bill was passed, providing for registration and conscription of all American men between the ages of 21 and 35. President Roosevelt wanted two million men and induction boards were busy.

A significant notice in the *Bulletin* read, "If you are called to military duty will you please notify Dr. John Noll, Secretary?"

TWENTY YEARS AGO — DECEMBER 1950

In December, 1950, the forces of the United Nations, mostly Americans, were in precipitous retreat from the Yalu River in Korea before the Chinese Communist army. Many of the doctors in Mahoning County, some who had served in World War II, were being called into the armed services. The cold war had become a hot war.

A \$15.00 assessment over the 1950 dues was passed by the members. Mr. Feuer reported that the Mahoning County Welfare Department had paid \$22,900 to physicians for house calls, \$177,925 for hospital care and \$894,953 for clothing, food and shelter.

Dr. D. E. Beynon and Dr. Henry L. Shorr were elected to membership. President Nelson congratulated the members on their activity in the November election which returned Robert Taft to his seat in the Senate. The Women's Auxiliary under Mrs. W. H. Evans sent out 36,000 letters and aided in transporting voters to the polls.

Dr. Hugh Bennett opened his office on Market St. for the practice of internal medicine. Paul McConnell, Brack Bowman and A. J. Brandt were elected fellows of the International College of Surgeons.

The Medical Service Foundation received its first payment of \$1,800 from the County Welfare Department. The trustees voted to use the money for nursing scholarships in the two hospitals.

TEN YEARS AGO — DECEMBER 1960

President Schlecht summed up the year in a brief remark: "Apathy" he wrote "is still our most dangerous foe."

And Editor Schreiber added: "It is not enough just to practice medicine—we must also serve the profession itself!"

The new Radio Program "Diagnosis" was on every Tuesday night on WFMJ, the work of our public relations chairman Detesco and McDonough. It supplemented the program "Consultation" on WKBN.

John Jacob Turner became a Fellow of the American College of Surgeons. His father, a long time Fellow, attended the ceremony.

November first in Struthers was proclaimed by the Mayor to be Dr. R. W. Fenton day. Ray was the new Health Commissioner for Mahoning County after 40 years of private practice.

PROCEEDINGS OF COUNCIL NOVEMBER 10, 1970

The regular meeting of the Council of the Mahoning County Medical Society was held on Tuesday, Nov. 10, 1970, at the Hotel Ohio, Youngstown.

The following physicians were present: R. L. Jenkins, president, presiding; R. A. Abdu, J. J. Anderson, Louis Bloomberg, R. P. Brucoli, K. E. Camp, D. J. Dallis, G. E. DeCicco, S. F. Gaylord, Henry Holden, J. C. Melnick, R. D. Murray, J. V. Newsome, C. E. Pichette, M. C. Raupple, Jack Schreiber, J. F. Stotler, J. W. Tandatnick, Kurt Wegner, and R. A. Wiltsie. The following physicians were absent: L. P. Caccamo and L. J. Zehr. Also present were: Gordon F. Ogram, M.D., John R. Dahmen, D.V.M., Warren Rollins and Detective Richard Friednamer.

The meeting was called to order at 7:30 p.m. Dr. Jenkins introduced Dr. Dahmen and Mr. Friednamer.

Mr. Friednamer spoke concerning the drug abuse problem in this area. He stated that the police department, in conjunction with the health department, would like to establish a registration of all known addicts.

Dr. Jenkins introduced Dr. Ogram, assistant commissioner of the Ohio Division of Mental Hygiene, who discussed the Mahoning Mental Health Center. The Center is interested in using beds in hospitals having psychiatric units. Dr. Ogram has discussed this with hospital administrators. The purpose of his presentation was to keep the medical community informed.

The following applications were read:

Intern-resident: Joseph J. Naples, M.D., C. B. Reddy, M.D.

The motion was made, seconded and duly passed that the secretary dispense with the reading of the minutes of the last meeting.

Bills were read. The motion was made, seconded and duly passed that each bill be paid.

Discussion ensued regarding the recent medical society vote to withdraw support from the MVHPA. Council agreed that the former representatives from the Mahoning County Medical Society may attend meetings on their own, but not as representatives of the Medical Society.

Dr. Raupple reported that one member has not paid his 1970 dues. Dr. Wegner offered to talk to the doctor concerned.

Dr. Jenkins reported that the Medical Assistants Dinner was a tremendous success.

A letter was read from the Ohio State Medical Board concerning Chiropractor advertising. The letter is attached to the minutes.

A letter was read from the Youngstown Police Department regarding prescribing narcotics for addicts and pushers. The letter is attached to the minutes.

Dr. Jenkins asked council members to attend and to bring someone with them for the Nov. 17 meeting.

Dr. Raupple, treasurer, reported for the ad hoc committee to study medical society finances. The motion was made by Dr. Bloomberg, and properly seconded, that council recommend to the membership an increase of dues amounting to \$25 per year to offset the deficit that the medical society is now experiencing. Motion was passed.

The motion was made by Dr. Tandatnick, and properly seconded, that council approve billing for 1970. Motion was passed. The secretary was asked to hold up on billing until after the Nov. 17 meeting.

The motion was made by Dr. Tandatnick that council write to the Mahoning Valley Health Planning Assn., asking that association to return the \$1000 that they have been holding in escrow. Motion was passed.

The motion was made by Dr. Bloomberg, and properly seconded, that

the council approve the Youngstown Board of Health forming a registration of drug addicts and making drug addiction a reportable disease in Mahoning County. Following discussion, the motion was made by Dr. Bloomberg that the motion be tabled. The tabling motion was passed.

The motion was made and properly seconded, that the Regional Medical Program on strep cultures be approved. Motion was passed.

Meeting was adjourned.

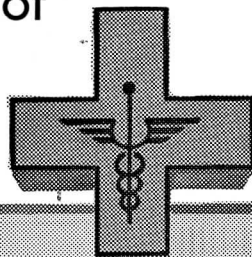
FOUNDATION MAKES FIFTH LOAN

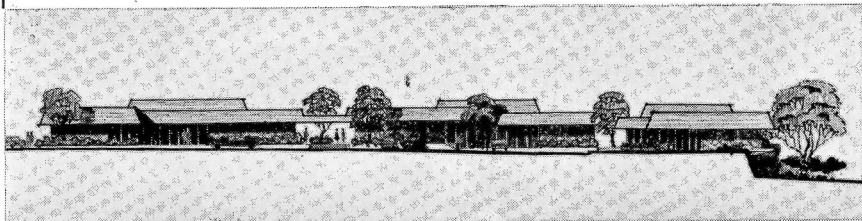

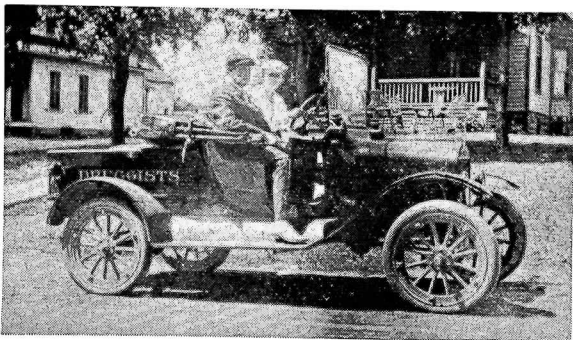
