THREE OBJECTIVES

The third objective will be the other side of the coin—health and welfare of the physician without bureaucratic interference.

Any good thing that I can do
or any kindness that I can show
Let me do it now!
Let me not defer it nor neglect it
For I shall not pass this way again.*

With God's help and yours, I hope to emulate the above.

Editorial

GREETINGS

As we begin a new year, it seems appropriate to reiterate the annual invitation for greater participation in the medical society. Unfortunately the past responses appear to have been less than overwhelming.

Indeed, the impression is that most members do not bother themselves with the society at all. This is especially apparent when fewer than twenty percent attend the Annual Meeting and election of officers. The actual governing of the society has been done by the council, yet the recent slate of nominees for office was not challenged in even one single position. This is certainly a nadir for a republican form of governing.

Admittedly, we cannot each be personally available to help shape each society decision, but a democracy of three hundred members should be nearly attainable. Possibly it has become too easy to delegate authority and thereby rationalize not contributing to the society. It is far easier to pay dues but reserve the much more important contributions of time, effort and individual intellect.

In the absence of a strong membership, there is a vacuum in the decision making, and a strong executive council will arrogate more and more authority. If there is to be a medical oligarchy, why bother with the sham of a medical society? Why bother with the large membership rosters? Why bother with committee appointments?

How can participation be expanded? Should membership be dependent on attendance at meetings, as at the hospital staff meetings? This would probably be contra-productive since personal involvement needs to be voluntary. There really needs to be an entire re-thinking and re-dedication on the part of the entire membership. How can we, as a whole, effectively serve the community and help plot the course for the practice of medicine if we are unwilling to participate. This is the level at which we can make ourselves heard.

There have been sporadic episodes of healthy debate at the regular meetings, but not enough to indicate the type of commitment that is needed in the current medical crisis. There seems to be a certain inertia of lethargy and despair in this area. Rather than confront the situation, the consensus seems to be . . . why bother?

In some ways I feel like the radio disk jockey who cries out at three a.m., "Is there anyone out there listening?" If anyone is listening, let's hear what you think.

TRUSTEES BREAK GROUND FOR MEDICAL SCHOOL

Weather was chilly and skies were cloudy as the caravan of eight buses and a number of private cars left Kent for Rootstown on the morning of Dec. 17th. But when the Board of Trustees stepped forward to shovel the first sod in the ground-breaking ceremony, the sun burst forth—surely a good omen for the Northeastern Ohio Universities College of Medicine as ground was broken for the basic Medical Sciences Campus.

Representing Youngstown State University as a trustee was Dr. Leonard P. Caccamo. Dr. Robert E. Tschantz, a past-president of OSMA, was there as a trustee representing Kent State University. Ground-breaking ceremonies were conducted by Dr. Stanley W. Olson.

A number of physicians from Youngstown attended the ceremony and the luncheon which followed at the Kent State campus.

As construction proceeds it will probably be visible to those traveling on interstate route 80. The school property is located on state route 44, just south of 80. The present entrance is directly opposite the Rootstown High School.

A special mention is due the Rootstown High School band, which led the parade of buses back into the construction site and rendered several numbers prior to the official ceremonies.

From the Bulletin

FORTY YEARS AGO — JANUARY 1936

Robert L. Jenkins was Editor of the *Bulletin*. The Society had new head-

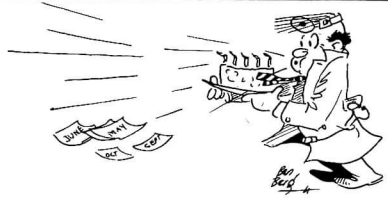
quarters in the Bel-Park Bldg. and Howard Rempes was Executive Secretary.

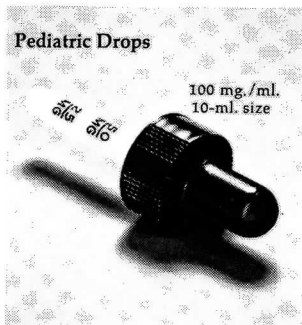
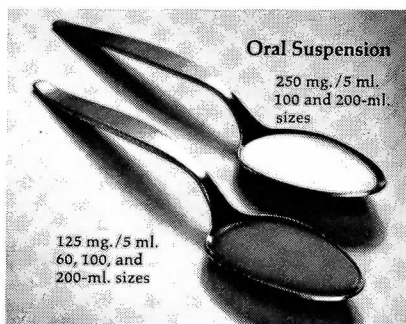
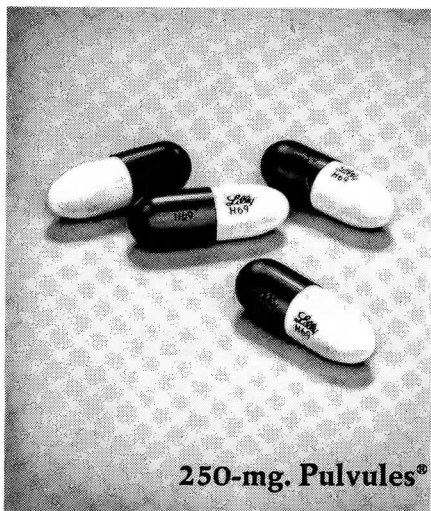
