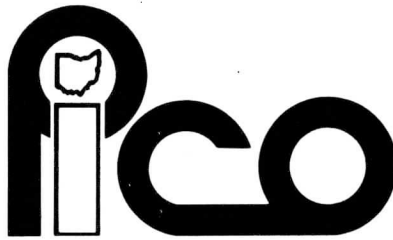

From the Desk of the President



A SENSE OF RESPONSIBILITY AND DEDICATION

The current rash of crippling strikes, both nationally and locally, continues to have an adverse effect upon our country and community. Rich and poor alike can feel the devastating consequences generated by the inflation that spirals with each wage settlement, whether it be in the public sector (policemen, teachers, etc.) or in the private (coal miners, steelworkers, etc.). Of course each group seeking a wage increase does so to "catch up with inflation." Certainly a group that has settled the strike or arrived at a new wage contract cannot consider itself as responsible for inflation — after all, they are trying to catch up.

This spiral reminds me of the greyhound dog races. The mechanical rabbit (inflation) runs ahead of the dogs at a speed faster than the swiftest dog. This has the effect of making the dogs run. Obviously these dogs are running with the ultimate goal of catching the mechanical rabbit. The spectators know that the dogs will never catch the rabbit; but the dogs do not. It's merely a means to make the dogs run as fast as they can.

The mechanical rabbit of inflation is totally elusive. A dog without intellect cannot reflect and deduce that the rabbit is uncatchable. We of the human species, with an intellect, unfortunately have the same lack of reasoning when it comes to that elusive rabbit, inflation.

If we lack reason to know that the rabbit cannot be caught, we will continue to run until we are totally exhausted. Fortunately for the dumb animal (dog) there is a finish line and the rabbit no longer runs. Will we ever reach a finish line of price stability, or stability in general? Personally, I doubt it. Exhaustion, which can be metaphorically equated with "depression and collapse" seems to be the inevitable end result of our economy. It seems to me we are headed in one unrelenting direction. The only limiting factors in this "inclined plane" is how long is the plane, and how steep the angle.

Dedication and responsibility to preserve some resemblance of an orderly society seem to have been abrogated by our selfishness and materialistic cravings. There is no apparent end.

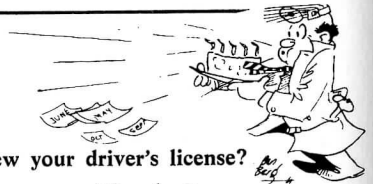
CME REMINDER

In Memoriam

CURTIS J. FISHER, M.D.**1926 - 1978**

Dr. Curtis J. Fisher, 51, died on Tuesday, Jan. 3, of a heart ailment at Youngstown Hospital Association North Unit.

Dr. Fisher was born in New York City. He earned his undergraduate degree at Moravian College, Bethlehem, Penna., in 1945, and received his M.D. degree at Hahnemann Medical College in 1953.

He served a residency at State University of New York from 1953 to 1957 and taught there from 1957 to 1958, after which he came to Youngstown and opened a practice in internal medicine. At his death he was in association with Dr. Hugh Bennett and Dr. E. R. McNeal at 5437 Mahoning Ave.

PICO ANNOUNCES NEW RATING SYSTEM

COLUMBUS, OHIO — The Physicians Insurance Company of Ohio has eliminated its premium charges to medical partnerships or corporations for medical professional liability primary coverage, provided that all members of the partnership or corporation have individual primary policies with the company.

Joseph K. Gilmore, president of PICO, said the rate reduction is effective immediately on new policies written and on the respective renewal dates of policies in effect.

Explaining PICO's action, Gilmore stated: "It has been standard procedure in the insurance industry to extend medical professional liability primary coverage to a partnership or corporation for a premium charge equal to 20 percent of the aggregate annual premiums of its members for their individual policies. We believe, based on a careful and extensive analysis, that we can extend this coverage for the premiums generated by the individual policies only."

Gilmore said that PICO's action will result in significant savings to the growing numbers of physicians and surgeons who are members of medical partnerships or corporations.

PICO provides medical professional liability insurance to more than 2,500 Ohio physicians. The company also offers physicians a complete line of property and casualty insurance products, including a Physician's Office Protection Policy, Homeowners insurance and Family Automobile insurance.

PSRO Area XIII consists of Mahoning, Stark, Columbiana and Trumbull counties.

From the Bulletin

FORTY YEARS AGO — FEBRUARY, 1938

During the great Depression of the 1930's the hospital dispensaries had been closed due to lack of funds. The indigent had been cared for by the Emergency Relief which paid doctors \$1.00 for an office call and \$2.00 for a house call. Now they were planning to reopen and there was much discussion about their function in the medical scene. It was agreed that they were needed for teaching purposes and the Society approved the acceptance of patients on a subsistence level whose medical care was not provided by any other agency. The same arrangements exist today.

THIRTY YEARS AGO — FEBRUARY, 1948

The latest thing in medicine was the Papanicolaou detection test for Cancer of the Uterus.

A. R. Cukerbaum wrote about the antihistamine drugs. He mentioned Torantil and Antergan which first appeared in Europe in 1942. Benadryl and Pyribenzamine were produced in our country in 1946.

W. J. Tims as Health Commissioner reported that Influenza due to type A virus was on the increase.

New members were: Clyde K. Walter, Kenneth E. Camp, Rollis R. Miller, and Anthony J. Bayuk.

Harold Reese topped the doctor's bowling league with a score of 263.

Gabriel DeCicco was appointed Chairman of the Membership Committee of The American Academy of General Practice in Cleveland and was assigned to organize a chapter in Mahoning County.

TWENTY YEARS AGO — FEBRUARY, 1958

President Detesco wrote: "The modern physician should develop three qualities: He should be a cultured man, he should be capable of compassionate and perceptive responses, and above all he should be a scientist."

Editor Morris Rosenbaum wrote: "The advance in the treatment of heart disease has been phenomenal. What will it be 300 years from now?"

Kurt Wegner had an important article on "The Infant With Congenital Heart Disease."

The annual banquet in January was held at the Youngstown Country Club. It was the first time that wives were invited. There was an informal cocktail hour and the main course was Cornish hen stuffed with wild rice. It was a gala affair.

TEN YEARS AGO — FEBRUARY, 1968

President Bob Fisher described the new Regional Medical Program as "unique in that it represents the first Federal aid directed exclusively to the Medical Profession." Dr. Ed. Pichette warned concerning the dangers of the Federal proposal for re-examination of physicians.

The regular meeting of the Council of the Mahoning County Medical Society was held on Tuesday, Jan 10, at the Youngstown Club.

Dr. Pichette, Sixth District Councilor, reported on the special meeting of the OSMA House of Delegates, held Sunday, Dec. 18, and attended by our delegates. The House passed a resolution which stated that it could no longer support H.R. 1818, the AMA's national health insurance bill, as it is now constituted.

The HSA Liaison Committee meeting with the HSA Committee and a group of attorneys was reported by Dr. Kiskaddon and Dr. Sovik. The meeting held was to discuss Dr. Kiskaddon's proposal to have plaintiffs and their attorneys pay some portion of the physician's expense in the event that they should lose a malpractice suit.

The Geriatrics Committee reported that their work with the Mahoning County Health Department is completed.

A letter from Dr. Reed to Atty. Eugene Fox concerning meetings of the medical-legal committee with the attorneys was read.

Dr. Anderson noted that the deadline for resolutions to the Ohio State Medical Association is March 8th.
