YOUNGSTOWN, Ohio - Dr. Bernard T. Gillis, provost at Youngstown State
University, has been chosen to serve as a consultant-evaluator for the Commission
on Institutions of Higher Education of the North Central Association of Colleges
and Schools.

The North Central Association provides institutional accreditation to postsecondary educational institutions in a 19-state region which includes Ohio. Dr. Gillis was one of 74 persons selected from more than 200 applicants.

Consultant-evaluators make up the visiting teams that obtain the information upon which the evaluation is based and provide initial recommendations for accreditation actions.

Dr. Gillis participated in a special training program for new consultantevaluators conducted by the Commission in mid-April. He will begin serving on evaluation teams in the 1987-88 academic year.

Dr. Gillis has been involved in every aspect of university operations, including serving as interim president of Indiana University of Pennsylvania (IUP).

He was born in Pierre, S.D., and received his Bachelor of Science degree in chemistry in 1952 at Loras College, Dubuque, Iowa. He received his Ph.D. in organic chemistry from Wayne State University, Detroit, in 1956, and the same year was a post-doctoral fellow at Massachusetts Institute of Technology.

He accepted an assistant professorship at Duquesne University in 1957, rose to professor of Chemistry in 1964 and was appointed associate chairman of the Department of Chemistry in 1965. In September 1968 he was appointed acting

assistant dean of the Graduate School and in December was made dean.

Dr. Gillis joined IUP in September 1970 as dean of academic affairs and faculty, and in 1971 was appointed academic vice president and provost. He directed programs that led to agreements with Jefferson Medical College for a program to alleviate the rural physician shortage, with Drexel University and the University of Pittsburgh for engineering programs, and with many other institutions to form a criminology consortia.

Dr. Gillis joined YSU in 1980 as the university's academic vice president. He and his family reside in Boardman.

He was active in the formation and served as first president of Southwestern Pennsylvania Higher Education Council, Inc., which consists of 48 institutions of higher education in that area. He also served on the state Education Advisory Council, which conducted the study, "Two Year Post Secondary Education in Pennsylvania."

Among other positions, Dr. Gillis was an officer and national councilor of the Pittsburgh Section, American Chemical Society; chairman of the Pennsylvania Association of College Chemistry Teachers, and president of the Pennsylvania Institute of Chemists.

He was awarded the Sigma Xi Research Award by the Wayne State University Chapter, and has been listed in "Outstanding Educators of America," "American Men in Science," "Leaders in American Science," and "Who's Who in America: Men of Achievement," among others. Nearly 50 of his papers, reviews and manuscripts on chemistry have been published.
