Historical Background

The Board of Regents

The Ohio Board of Regents, a nine-member advisory board to the Chancellor with two ex-officio representatives from the state legislature, was created in 1963 by the General Assembly. Members of the Board of Regents are appointed by the Governor with the advice and consent of the Senate. The Board of Regents is under the auspices of the Ohio Department of High Education and is headed by the Chancellor.

The charge of the Ohio Board of Regents according to the O.R.C. 3333.04 [A] is as followed: To make studies of the state policy in the field of higher education and formulate a mast plan for higher education for the state, considering the needs of the people, the needs of the state, and the role of individual public and private institutions within the state in fulfilling these needs.¹

Responsibilities of the Board include, developing an independent annual report on the Condition of Higher Education in Ohio, and issuing an annual performance review of the Chancellor. The Board is also responsible for advising the Chancellor on issues of statewide importance affecting higher education.²

When Youngstown State University became a state-assisted institution in 1967, YSU became obligated to comply with the law established by the Ohio legislature and the Ohio Board of Regents.

Scope and Content

The materials in this collection dates from 1970-2004. Most of the material is from the late 1970s to mid 1990s. The collection is mostly kept in orginial order with one box of minutes and a second box of various materials (correspondence, news and reports). The largest series is Minutes. It dates from 1970-1997; however there is a gap between 1971 and 1984. The News and Correspondence series both have dates from the mid to late 1980s to early to mid 1990s. The reports series is rather large and dates from 1972-2004. A detailed description is given before the item listing.

Colophon

It appears this collection came together from two sources. The minutes of the Ohio Board of Regents were deposited in Maag library by the YSU Adminsitration according to the accession file UA 2004.7. The rest of collection is not mentioned in the file. Some of the reports were cataloged at one time and kept in the closed reserves of Maag Library. It is assumed that after the reports were expired and a place in the Archives was made available, they were transferred

SERIES IV: Reports and Manuals

Most of these reports are self contained reports, manuals, or master plans created by or for the Ohio Board of Regents. Dates range from 1972-2004. The Access Challenge Grant folder contains a YSU proposal to receive a grant provided by OBOR. The Challenge is Change is a master plan for higher education from the OBOR. "The Concepts and Perparation of a Funcational Mission" report encourages each college and university to set its own mission and goals in concert with state and regional priorities. "High Performance Campus" contains a campus model for institutional stability, performance and changes for the future. "Ohio Basic Data Series" contains datat collections concerning Ohio's state-assisted colleges and university. The data refects on subjects which recur in conversations among the instutitions and OBOR. "Ohio Colleges and Universities, 2001" was issued by Governor Bob Taft for potential student use to determine which state college or university is best suited for him/her. It was also used for benchmarking and tax payer justification for state funding. The "Ohio's Postsecondary Enrollment Option" pertains to the program to permit high school students to earn college credit through completion of college courses. "Organizing for Economic Development" links public and private resources to promote local development. Various materials relate to OLIS (Ohio Library and Infomration System) which is the integrated library information system to meet the courrent and future needs of academic institutions in Ohio. "Performance Report for Ohio's Colleges and University" is similar to folder 16, just updated to 2003. "Personnel Management Manuals" focuses on management practices concerning institutional planning, program budgeting, personnel management, computer services and schedule building and registration. The "Report of the Regents' Advisory Committee of Faculty Workload" seeks to create a state-wide framework for faculty teaching expectations. "Securing the Future of Higher Education in Ohio" suggests ways in which public higher education could become more effective and efficient. The final report in the series refers to the 1976 OBOR master plan which focuses on the role of higher education in human development.
