In preparation for the OCA Leadership Conference, it is important that chapters and divisions submit to the central office a directory of all officers with addresses and phone, fax, and email addresses as soon as possible. The leadership manuals will go to press on June 15, and this information is critical. Thank you for your cooperation!

Newly elected OCA officers for the year 2000-2001 are President-elect Carol Pohly and Treasurer David Di Lullo.

In response to the concerns of All Ohio Counselors Conference attendees, the planning committee is investigating other centrally-located sites which might have sufficient capacity to provide all services for conferees. The 2000 conference must take place at the Adam's Mark, but a new contract is necessary for the conference sites beyond that date. We'll keep you informed!

#### **OCA Dues Increase**

The OCA Executive Council has reluctantly determined that

financial demands upon the organization necessitate an increase in dues, to take effect on July 1, The new dues for a professional or associate member will be \$80. OCA Bylaws provide that dues for a retired member (a person having once been a professional member of OCA) be one-half the professional rate and student membership be one-fourth the professional rate. Therefore, the new dues for retired members will be \$40 and for students, \$20.

Seeking for better member benefits. the executive committee has instructed the executive director to investigate whether the ACA Insurance Trust would provide professional liability insurance for OCA student members who are not members of ACA. While professional liability insurance for professional members of OCA who are not members of ACA is available, the ACA Insurance Trust does not permit OCA to provide like services to student members. This restriction has been of significant concern to the executive committee.

### Legislative Update

Interesting things are happening in Columbus as a consequence of recent term limits legislation. Of 99 House seats, 42 will be filled by new members. Republicans are expected, however, to retain their majority.

Sixteen seats are up for grabs in the Senate, with at least seven of the sixteen destined to go to new senators. Republicans are likely to retain control of the Senate as well.

Legislation of interest:

 HB53 Parity of insurance for physical and mental illness; stalled, and dead for this year.

- HB71 The Morgan legislation, previously enacted; training materials are available on this outlines (which the statutory responsibility of counselors to warn third parties about outpatient threats of violence); contact Debra Belinky, ODMH Chief Legal Counsel at (614) 466-8288.
- HB212 Would require State Board of Psychology to license masters-prepared individuals as "psychological associates"; stalled in House Commerce and Labor Committee.
- HB221 Would create a "mandated benefits review commission" to study any bill which mandates insurance coverage; strongly opposed by business community and insurance lobby; passed the House, under study in the Senate.
- SB75 Would require OCSWB to license marriage and family therapists; marriage and family therapists who meet board criteria are already so licensed; stalled in Senate Health Committee.
- SB253 Would impose criminal penalties on mental health professionals who engage in sexual contact with patients; may pass Senate prior to summer recess, as well as move on to the House before the end of the year.

The OCSWB has filed some administrative rule changes with the Joint Committee Agency on Rule Review. Contact OCSWB for draft copies of the proposed changes.

# Questions and Answers from CSWB

Board "Supervising Counselor"
Update

Beginning June 30, 2000, all PC's and PCC's providing training supervision must have the "Supervising Counselor" status. There have been some questions regarding the information posted in the last **Guidelines**. The board would like to offer the following paragraphs to clarify the previous information.

Supervising Counselor status may be obtained by PCs and PCCs. The PCs may only supervise individuals working towards the PC license. Clinical residents or those obtaining the 3000 hours post PC must be supervised by PCCs.

Individuals who have requested "Supervision Counselor" status by checking the box on their renewal application or forwarding letters will receive a letter from the board in May, 2000, granting the designation "Supervising Counselor." This letter may be used as your verification of status

until you receive your next renewal card showing the designation.

Once the designation is listed on your renewal card, it will be necessary for all licensees to document six hours of approved continuing professional education in supervision to retain the designation. There will be a box provided on your renewal attesting to the fact that you have completed these hours.

For those who will be qualifying for "Supervising Counselor" after June 30, 2000, application forms will be available through the Counselor and Social Worker Board office beginning July 1, 2000.

As to training supervision, the board's policy states that trainees who have completed 2/3 of their hours (with one or more supervisors) and are **currently** registered with a psychologist, psychiatrist or LISW may request to have the supervision under that supervisor extended to complete the remaining 1/3 of the hours.

Requests for "hardship" considerations will be reviewed by the board on a case by case basis. In order to request a "hardship", it will be necessary for you to document your efforts to find PCC supervision. Please note that the board has eliminated the restriction payment for supervision services. This will allow you to pay for supervision by a counselor who is offsite as long as the agency will allow access to the records. needed, you may call the Department of Administrative Services at (614) 455-4357 for a list of PCCs in your area. There is a charge for the names through this office. After June 30, 2000, the board will have a list of Supervising Counselors available at no charge.

The board trusts that this information will prove helpful to the PCs and PCCs of Ohio.

Supreme Court Holds That Schools May Be Held Liable Under Title IX for Student-On-Student Sexual Harassment

The Supreme Court ruled on May 24, 1999, that schools receiving federal funding may be held liable under Title IX for student-on-student sexual harassment (*Davis v. Monroe County Board of* 

Education et al., 1999 WL The ruling imposes a 320808). relatively stringent standard of proof for would-be plaintiffs. According to the court, liability may only be imposed where schools are (1) "deliberately indifferent to sexual harassment of which they have actual knowledge," and (2) the harassment "is so severe, pervasive, and objectively offensive that it can be said to deprive the victims of access to the educational opportunities benefits provided by the school."

Responding to the dissent's assertion that the court's decision would open the floodgates to civil suits against schools. Justice O'Connor identified several factors she contended would act to limit liability under Title IX. liability exists under Title IX only where the funding recipient has disciplinary authority over or otherwise has the ability to control the harasser Second, to be actionable, the harassment must take place in a context subject to the school's control. Together, these factors restrict liability to those circumstances "wherein the [funding] recipient exercises substantial control over both the harasser and the context in which the known harassment occurs."

Turning to the type of harassing conduct sufficient to rise to the level of actionable discrimination, the court drew upon Title VII concepts and stated that for schools to be held liable, the harassment must be "so severe, pervasive, and objectively offensive that it can be said to deprive the victims of access to the educational opportunities or benefits by the schools."

The *Davis* decision raises nearly as many questions as it answers. Among the many issues which will have to be clarified through

subsequent litigation in the lower courts are: which school officials must know of the harassing conduct before the harassment becomes actionable; what does or does not constitute a "clearly unreasonable" response to peer harassment on the part of school officials; and what are the parameters of behavior that will rise to the "severe and pervasive" level in different school environments? Given availability of unlimited damages under Title IX, it is reasonable to assume that the plaintiffs' bar will be pushing the envelope on this new cause of action.

Crowell & Moring is Washington based law firm which manages the legal help line for those counselors and human development professionals who are insured in the Professional Liability Insurance Program administered by the ACA Insurance Trust. This is one of the many risk management services which the trust provides to the more than 25,000 insureds in the ACA Insurance Trust program.

Paul Nelson, Executive Director of the Trust advises that there are implications for school counselors and other human development professionals employed by public and private schools:

- It is important to have personal professional liability insurance;
- Make sure that the policy form addresses counselor/human development issues and not only classroom/playground/ educational activities or allied health care/medical incidents;
- Be part of the policy development to implement steps for recognizing and

responding to harassment, whether teacher-on-student or peer-on-peer;

Keep in mind that more claims are arising over time. These claims involve sexual harassment at school, violence on school property, as well as issues related to families such as abuse.






