Discipline Committee to hear charges against Hettler

The Student Council Discipline Committee will consider whether or not Chuck Hettler, Council chairman and representative-atlarge, is eligible to retain his seat following charges that Hettler is illegally a member of a Greek organization.

Council yesterday passed by a 12-9 vote a motion that Council's Discipline Committee consider the allegations after Student Government president Dan Crishon urged Council to send the case to the committee to "clear the name of either Council or Hettler."

Council's action subsequently gave rise to the following developments:

*The temporary suspension of Hettler's privileges as Council chairman and representative.

*The temporary suspension of Andy Bresko as Student Council Discipline chairman since Bresko is a member of the fraternity (Phi Delta Theta Colony) of which Hettler is allegedly a member.

*Charges before Interfraternity Council against Phi Delta Theta Colony by Pete Isgro, former Student Government president and

IFC member, that Phi Delta Theta Colony has violated IFC regulations. *The possibility of disciplinary

action against Hettler by the University Discipline Committee.

The suspension of Hettler's privileges occurred immediately following Council's decision to send the case to the Council Discipline Committee. Dave Fleisher, business representative, suggested the action be taken and quoted from Robert's Rules Of Order that "after charges are preferred against a member and the assembly has ordered that he be cited to appear for trial, he is

theoretically under arrest and is deprived of all the rights of membership until his case is disposed of."

Following the deprivation of Hettler's privileges, the chairmanship was assumed by Pat Galterio, Council secretary, who is also reported to be Hettler's girlfriend. Bill Mahoney, vice chairman of Council, was not at the meeting.

Council member Bobbie Ropar then moved to prohibit any Phi Delta Theta member from serving (Cont. on page 8)

First History Week speaker notes need for assimilation

The Black History Week Program at YSU got off with an electrifying start yesterday afternoon with an address in the Lincoln Project Building from Prof. Wilbur Watson and concerned citizens. He spoke on "Black Thought in the Historical Context." Malcoim X, W.E.B. Dubois and Marcus Garvey were used as the focal points for his lecture.

"We today-Blacks-are a people who are not only faced with the grips of a long history of oppression and alienation but...many of us believe that somehow we can be assimilated into this system, independent of oppression, that somehow we can pull ourselves up by our boot-straps." This was the

way Prof. Watson summarizes the "Main Currents of Black Sociological Thought" in America today.

Prof. Watson reminded us that in order for the Black Man in this country to make any significant progress toward "Freedom" it will of Rutgers University before a require a certain social, political capacity crowd of students, teachers and economic transformation by white Americans. "Before this can happen it will be necessary for white people to become humanitarians, they will have to believe in the concept of liberty justice and equality; they will have to become endowed with compassion and LOVE."

> Prof. Watson concluded his address by citing 4 modes of thought that are currently reflected among the masses of Black people today:

1) Seclusion and withdrawal (Cont. on page 7)

Threats to Jambar staff follow Phi Delt story

Jambar staffers were subject to a variety of threats and insults over the weekend, apparently as a result of the Jambar's disclosure that Chuck Hettler, chairman of Student Council, is an active member of Phi Delta Theta colony.

Jambar editor, Dale I. Peskin, and news editor, Pete Wilms received threatening phone calls and were verbally insulted at the "Sig Ep Fite Nite" on Friday evening.

Wilms, who was photographing the event, was told by an unidentified student that the (Cont. on page 2)

Jambar's camera equipment would be destroyed.

Peskin was warned in two phone calls not to show up at "Fite Nite." He did appear, but was met with just one gesture of insult.

Ray Jackson, sales manager of the *Jambar*, was seated at the event among a group of Phi Delt's. He was informed that they "weren't after him, but were after you-know-who."

Daniel J. Dunmire, Jambar staff writer whose eye-witness account of Hettler's participation in Phi Delt rushing activities appeared in last Friday's Jambar, said he simply walked away when he was accosted by a Phi Delt

Last Fall, when the Jambar disclosed that the Phi Delta Theta organization claimed national affiliation when, in fact, the national headquarters disclaimed any knowledge of their status, the Jambar staff was subject to more serious threats. These included threats to burn down the Jambar building, to beat up a photographer, and threats to parents of a student who had charged that Hettler then was a pledge.

Stanford student urges approval of draft abolishment

WASHINGTON (AP) - A
Stanford University student accused Congress today of giving up its right to declare war and urged the Senate Armed Committee to approve legislation to abolish the draft.

Peter Knutson, chairman of the Stanford Draft Repeal Council, said his draft age friends are frustrated because of being forced to fight and die in an undeclared war in Southeast Asia.

The moral dilemma facing young men today would be similar to American men having to fight on the side of Germany in World War II, he said.

He questioned why the Congress failed to declare war and asked rhetorically whether it could be because a majority felt that the war wasn't "just enough" to warrant a declaration

Knutson made his remarks on the third day of hearings before the Senate Armed Services Committee on legislation to end the draft.



Record of Intent

Some people have wondered why the Jambar is making such a fuss about Chuck Hettler and the Phi Delta Theta Fraternity. After all, they say, he's an active chairman of Student Council; and if he wants to join a fraternity, let him.

We don't agree; and we're glad to see that the majority of the members of Student Council don't agree. Overlooking these charges (as some members of student council apparently wish to do) is like looking the other way while the till is being robbed.

No doubt the record will reveal that Chuck Hettler is not on the fraternity's roster of pledges. No doubt the pledge paddle with his initials on them has already "disappeared." No doubt national headquarters of Phi Delta Theta will never have heard of Chuck Hettler. After all, we were informed last fall, during that dust-up, that "all fraternities have under-cover pledges."

In short. Hettler may be in a position to make a very good defense "on the record." What he cannot defend is the matter of intent. His constant association with Phi Delta Theta, his presence at the rush party, his systematic appointment of Phi Delta Theta Brothers to committee positions on Student Council, suggest where his heart is. It is in a place no "member-at-large" has any right to put it. And it has been there for months.

We hope that Hettler will resign his position. But if he does not, we intend to keep reminding Student Government that rules mean nothing if there is no intention to enforce them. Hettler might be an excellent member and chairman—if one can be "excellent" by fraud.

Letters to the Editor Denounces 'Jambar' Phi Delt story

To the Editor of the Jambar:

Who says the Jambar is antigreek? Last Friday's edition of the Jambar gave an insight into the values of belonging to a fraternity. The house was described well along with some of the social aspects of belonging to a fraternity. It was pointed out very well that all of the brothers were very sociable, even to someone that they didn't know. This is the main point of belonging to a fraternity, a nice place to spend spare time with people you get along with.

I feel the Jambar was very generous giving us all of the free Rush publicity, but there are a few discrepancies that must be pointed out. First of all, when I am quoted, I would like to be quoted correctly. Friday's issue stated that I said Chuck Hettler

has not attended any fraternity functions. This is a riciculous statement and false. Everyone knows that most of our brothers: are friends with Chuck. As Mr. Dunmire noted, our rush parties are open to the public. (All those truly interested in joining, not those interested in making a name for themselves with a sensationalistic story based on half truths or rumors) It is our policy to let non-members in our house if he knows the brothers and it is also our policy to have guests at our parties. This in my opinion does not mean that a man is a brother merely by being seen with us.

I would like to say that Chuck Hettler is not a brother, a pledge or a rushee and cannot be such until the time that he is no longer a Representative at Large. The Jambar proved this them-

selves by saying he was not registered with I.F.C. or National Headquarters.

It was also noted that after the Jambar caused such a stir about the Colony of Phi Delta Theta misrepresenting itself during the fall and summer quarter that they saw fit to give us full chapter status by omitting the word "Colony" ten times. It seems strange that the Jambar could make such a mistake. Are they interested in printing the truth and making valid criticisms of wrongs on campus or are they merely putting out a scandal sheet based on half truths and rumors. A little research into this problem could have saved a lot of misconceptions, but no one at the Jambar seemed willing to talk before the article was printed.

(Editor's note-Mr. Weaver's statements warrant specific responses. First, he underestimates us if he thinks the purpose of the Jambar article was to give "insight into the values of belonging to a fraternity." If he is being facetious, then he misjudges us, for we are extremely serious about the allegations. Second, Mr. Weaver offers no evidence that he was incorrectly quoted. No less than three people heard and witnessed what he said. Third, staff writer Dunmire was sent to the rush party in full knowledge of his duties as a reporter and did not attempt to falsify or sensationalize a story. He was sent to the rush party to clarify a persistent rumor. Fourth, Jambar reporters contacted Mr. Weaver and fraternity advisor Mr. Ralph Burkholder prior to the release of the story and printed their statements of the issue. It was Mr. Weaver who was not willing to "talk before the article was printed."

We stand by our two stories on Friday and maintain they are accurate. We urge students to reread Mr Weaver's letter and our stories of last week, then reach their own decision.)

Finds Hettler situation outrageous

To the editor of the Jambar:

In reference to your articles appearing in February 5th's Jambar there are many things that can be said about Mr. Hettler and the Phi Delta Theta colony, but the first thing that comes to mind is "How dare they?"

Many people have spent a great deal of time in Student Government and on Student Council. It is outrageous that charges must be brought against the Chairman of Council for not regarding that body's Constitution of which he surely must be aware.

He has denied having any affiliation with the Phi Delta Theta colony; yet the way he spoke to your reporter doesn't indicate this in the least. He has also spoken to other people about being affiliated with the colony.

At Monday's Council meet-

ing, the memoers of Council who also belong to the Phi Delta Theta colony engaged in block voting to prevent Mr. Hettler's case from being considered by the Discipline Committee of Council. They also voted against a motion which would prevent members of Phi Delta Theta Colony from serving on the Discipline Committee while the Hettler case is being handled. This can be interpreted as an admission of guilt by the brothers.

Hettler has also given indications of his affiliation with the Phi Delta Theta colony when he appointed three of the five newly elected to council brothers to chairmanships of Council Committees and completely disregarded the qualifications of old members of Council who in the interest of the student body should have been appointed first. In the selection of members on the Nominating Commit-

tee for students to serve on student faculty committees, he has placed three Phi Delts out of seven committee members. This could give block nominations for students to serve on these committees. This does a great deal of damage to the student body for these committees are the legitimate channels for student recommendations. With one organization in charge it is possible that only one side could be heard instead of all sides of student opinions and furthermore, the possibility of favoring one student organization by it exercising complete domination: of the committee system. Instead of representing all facets of the University-Greek and Independent-this situation leaves Student Council nothing but a pawn and not the representative body it should and must be.

Hettler case "Matter of Magnitude"

YSU is faced with a problem at the moment unparalleled in magnitude within its recent history. The question has been raised as to the right of the present chairman of Student Council to hold his position. It is now the responsibility of the Student Council Discipline Committee to investigate these charges, and to pass judgment on their validity.

It has become the immediate concern of the Discipline Committee to investigate this matter honestly, openly and as objectively as possible. For it is not only the chairman of Student Council that is being challenged here, but the entire value of Student Government.

There can be no question of the need of this investigation. Even more so there must be no question of the impartiality of those who will conduct this investigation. If Student Council sees fit to whitewash this affair, if there is any evidence of vested interests on the part of those dealing with this matter, the results will be disastrous.

The question of the relationship of the student to Student Government is the essence of this action. There are now entering this university young freshmen in unprecedented numbers. Men and women who will find a need to express themselves on matters concerning their life in the university. They must have a cohesive, well run, government to turn to. Student Government must begin to demand the respect and power its due from the university community on behalf of the student. It must be in the forefront in the battle for student rights. It must once and for all challenge the charges of being a do nothing group with vested interests and prove them false.

The point here is not so much as whether the charges are true or not, but whether council is mature enough to investigate one of their own objectively. Here lies the vital question. No one is condemning Council for any oversite that may have occurred, we are only asking that they seek justice and the truth in their investigation.

If they prove unable to cope with these internal problems, it will destroy all faith that the students may have in council now. But should they succeed in dealing with these charges in an acceptable way, they will open up a new era of involvement on the part of students and council. They will help begin the creation of a system that the individual student can work through and feel that he is part of the university through.







because of self-degradation which is largely responsible for the great numbers of Blacks who fill penal and mental institutions.

2) Assimilation-an attempt by some Blacks to be totally integrated into the white American society.

3) The building of autonomous political and economic systems in America.

4) The Pan-Africanists' Movement, which states simply that nothing can be done for Blacks in America until Blacks build a stronger Africa and eventually separate from this country and migrate to the Mother Country-

The program for the remaind-

er of the week will consist of films, lectures, Black poetry readings, an art show on Friday, and the weeks' activities will be capped with the presentation, on Saturday, of the Black play: "Ceremonies In Dark Old Men."

The play will be performed primarily for the 300 Black high school students who were selected from over 700 applicants, on the basis of financial need and their response to a questionaire, to attend the Saturday Seminar and subsequently attend YSU.

These 300 students, in keeping with the main objective of the Black History Week Program, will be given the necessary information concerning admission procedures and requirements, financial aids and academic programs at YSU. Furthermore, an all-out effort will be made by the YSU "Big Brother & Sister Teams" to secure admission to the university

for the 300 students who will attend the Seminar. Members of the Big Brother and Sister Teams have devised a "Follow-Thru" program, whereby each high school senior who is admitted to YSU will be advised, tutored and generally looked after during their sophomore year by a Big

Brother or Sister.

An example of the charismatic relationship between the Big Brother and Sister YSU Teams and the selected high school seniors was demonstrated in an assembly last Thursday at South High School. The students were asked for general comments on the Black History Week Program: "I can relate to the Team Leaders because of their age and experiences," said Curtis Nother. "The Team Leaders and Mr. Alfred Bright are showing us how to get it together," replied Miss Gail Womack.

Students consider private lots to be possible solution to parking dilemma

Many students at Youngstown State University have taken steps to solve their parking problems on their own. While some risk tickets and others come hours early, numerous students have turned to private parking lots instead of entering the battle for space on campus.

There are five privately owned parking lots in the vicinity of Rayen and Clingan-Waddell, near the Wood-Champion street intersection. These lots alone handle approximately 600 cars together with the present number of students using them being about 261. The charges average about eight dollars a month or twenty-four dollars per quarter. There are also weekly and daily rates, the latter which are rather beneficial for students who only come to school a couple of days a week.

It is usually not too difficult to get a parking space and there are usually attendants on duty, at least until the hours when the
