SENATE MINUTES CONT'D.: (May 1, 1970)

Mr. Peter Isgro, III asked the President if he could address the Senate before a vote was taken on the Document, Senate Standing Committees. Mr. Isgro's talk as follows:

- 3 -

"It is with deep concern that I take this opportunity to address you. It is my feeling that the Administrative Council and the Executive Committee of the Senate, which on the one hand speak of wanting and needing student opinion on the various Senate Standing Committees, do on the other hand, stifle the expression of that opinion by the rules they have formulated to select the student members of those Committees."

"This can be readily seen by the various statement, for example, I quote: "A student may not serve on more than one Standing Committee at the same time." To be effective student leaders, the elected representatives of the student body must have first hand knowledge with the activities of the various Committees. They cannot effectively lead the student body unless this opportunity is permitted to continue.'

"According to these regulations the President of Student Government and the Chairman of Student Council are not permitted even to select the Committee where they feel they might best serve. The rule for membership as given in the paragraph listing the members of the Student Affairs Committee specifies that these two student leaders must be members of this committee. The general regulation on Page #2 thus precludes their serving on any other Committee."

"A review of the proposed Committee appointments will reveal that both faculty members and administrators serve on more than one Committee, presumably to keep abreast of more than one area of concern. Should this opportunity be denied the Student leader?"

"I am in complete agreement with the principle of having all Schools represented among the students on Committees which have six (6) or more student members. I object to the Joint Committee requiring one of Student Government's own Committees to have each of its members represent a different School. The rule proposed for assigning members to the Discipline Committee reads "six (6) students according to Rule of Distribution by Schools to include three (3) from the Discipline Committee of Student Council."

"An interpretation that has been proposed states that these six (6) would all be from different Schools, thus the three (3) members of the Discipline Committee of Student Council would be required to be from different Schools."

"A review of the proposed appointments to the Standing Committees shows that no fewer than ten (10) and perhaps more which have six (6) faculty members do not have all six (6) undergraduate Schools represented. Of these, there are five (5) Committees which have six (6) student members (or more). For these, the Student Government is required to make selections to represent all Schools although the Joint Committee has not done so with regard to faculty."

<u>SENATE MINUTES CONT'D.</u> (May 1, 1970) <u>Mr. Peter Isqro's talk Cont'd.</u>:

"It has been stressed repeatedly to the student members of the Student Affairs Committee that the justification for requiring this School distribution is found in the effort made to select faculty representatives from the various Schools."

"I have no objections on attempting to provide a broad student representation, but to leave a student seat vacant and thus completely silencing the expression of student opinion from that seat is disgraceful,"

"In reference to denying representation to part-time students, it should be noted that all part-time students are affected by the actions of the various Committees; yet they are denied the opportunity to give their constructive opinions. Although part-time students may not reap all of the advantages received by full-time students, they do receive some of them. For example, the student who is registered for less than a full-time load may be recognized for outstanding academic achievement. Should not these students who receive this recognition also be heard?"

"It appears it is definitely the intention of the Joint Committee to guarantee all Schools the opportunity to participate in Committee action. This goal has yet to be achieved. Many of the Committees do have sufficient seats for the students of all Schools to be represented."

"Some Committees are such that faculty membership has not been given. Perhaps there are some Committees which do not need full student representation; but some could benefit from additional members."

"I would **recommend** additional representation on the following Committees:

- 1) Academic Affairs --- (3 now)
- 2) Curriculum Committee --- (3 now)
- 3) Library Committee -- (2 now)
- 4) Calendar and Coordination Committee -- (3 now)
- 5) Foreign Students Sub-Committee (4 now) (International

Students)

- 6) Health and Safety Committee (2 now)
- 7) Management and Control of Physical Facilities (3 now)"

"I recommend that the Senate give consideration to the recommendation of the Student Affairs Committee that students comprise one-half $\binom{1}{2}$ of its membership; a recommendation which has been denied two (2) years in a row,"

"I recommend to this body that the rule that a student may serve on only one (1) Committee be eliminated; the implication that the three (3) members of the Discipline **Committee** of Student Council must - 5 -<u>SENATE MINUTES CONT'D.</u>: (May **1**, 1970) <u>Mr. Peter Isgro's talk cont'd.:</u>

be from three (3) Schools be removed; that the <u>requirement</u> that all Schools be represented on those Committees with six (6) or more student members be revised to <u>recommend</u> this action; thus, if a sufficiently interested and qualified student is not available, from that particular school, that the seat will not <u>have</u> to remain vacant; and, that part-time students (minimum of 8 hours) as well as fulltime students be permitted to serve on Committees."

STUDENT MEMBERS: Mr, Glenn Pixler Mr. Jim Moffit

Mrs. Crites stated that earlier in the year the committee reviewed the Charge and decided they would like to take on a project which, they hoped, would add prestige to the University and thus enhance the value of each diploma.

After much study and discussion, members of the Committee decided to recommend inaugurating a Who's Who Among Youngstown State University Alumni. Since this is a "B" Committee, our proposal must be evaluated by both the Administration and the University Senate. This is a preliminary report; no action is expected from the Senate today. However, we expect to have the complete report mailed to you before the next Senate meeting, at which time, we will seek your approval."

<u>Dr. Pugsley</u>: All are familiar with the interest of this University in having the Medical School, preferably with the association of this University. We are the only Institution in the country that has received the endorsement of the County Medical Association. They took the initiative to raise \$30,000 to make a feasible study. Presented to Board of Regents and the Legislature and other Public Officials. Other studies were prepared by Akron and Kent State. They all had some consultants and also since then Cleveland State has become interested.

The Governor made a statement that he thought it should go to the University of Akron. We began to take some further action here,

The Chancellor said the Board of Regents would make recommendations on the Medical School; the Board of Regents appointed a consultant; he has not yet made a recommendation; he has not yet visited this University but will in the near future.

Bringing this to our attention means public interest is essential. Is the Community interested in supporting such a Project? This is not under Dr. Pugsley's direction. The Mahoning Valley Planning Health

Association took action at their meeting about ten (10) days ago and it was unanimous to endorse the proposal that the Medical School be located and connected with Youngstown State University. Other agencies support it also.

Dr. Pugsley stated he had attended a meeting today at noon of this Citizen's Committee and they have arranged for the Chancellor to speak at a Public Meeting on Wednesday, May 13 at the Mahoning Country Club. They are seeking endorsement and presence at that meeting as the feasible evidence of support from this Community for the Medical School. I urge you to attend if at all possible, Buy the \$4.00 ticket but your presence is more necessary than just buying the ticket.

I OF ACADEMIC AFFAIRS OMMITTEE

This report was given by the Chairman, Dr. Esther P. Niemi. Distributed earlier to Senate members for study was the following:

> The members of the Academic Affairs Committee submit, for your approval, the following policy statement on the relationship of attendance/grading, effective with the Summer Quarter, 1970:

The problem of excessive class absence concerns Instructor and student, and consequently requires their mutual effort in solution. The student must realize that for his own welfare he is expected to attend all class meetings of a course in which he is enrolled.

The Instructor, however, has the prerogative of determining the relationship between class attendance, achievement, and course grades, and the responsibility for communicating that relationship to his students at the beginning of each Quarter.

This matter was referred to the Deans and the Senate Council, Referred back to the Academic Affairs Committee. Following through the Academic Affairs Committee drafted a statement.

Dr. Niemi reported as follows:

"The Academic Affairs Committee Proposal, Policy on Relationship of Attendance/Grades the following observations were made:

1) The phrase, "he is expected to attend", has the effect of command rather than anticipation, in this context.

<u>SENATE MINUTES CONT'D.</u> (May 1, 1970) REPORT OF ACADEMIC AFFAIRS COMMITTEE CONT'D.: (Dr. Niemi)

- 2) On the point of "communicating that relationship" this **Committee** feels, as it did in discussing the question in its study of January 1969, that the communication to be effective must be in writing and at the beginning of the term.
- 3) In the interests of avoiding arbitrary use of the Instructor's "prerogative", a line of appeal should be established.
- 4) The statement as it stands is unilateral. What about "expected" attendance by the Instructor.
- MOTION: Dr. Esther Niemi moved on behalf of the Academic Affairs Committee adoption of this policy statement on the relationship of attendance/grading, effective with the Summer Quarter, 1970, Seconded.

COMMENTS:

1) If attendance is to be counted, etc., the student should be there. Performance is something else.

- 2) Why was the phrase "not in writing" not included?
- Dr. Niemi Ans.: If a syllabus is made, for example, for English courses. It would come through a common outline. It would be impractical to have it in writing also. There will be many Instructors who will wish to make it in writing,
- 3) Better to say "prudent" for his own welfare, etc.
- Dr. Niemi Ans .: What is before you is what we ended up with.
 - MOTION TO <u>AMEND MOTION</u>: Dr. Clyde Hankey moved to amend Motion by deleting "all" from sentence. Seconded. <u>NO'S HAVE IT</u>.

4) What is a student misses an announced test or an unannounced test?

<u>Dr. Niemi Ans</u>.: The teacher makes his own policy. Each Instructor has the ability and the right to formulate his own statement.

<u>AMEND MOTION:</u> Dean Dykema moved to make an amendment: "and the responsibility for communicating that to the students in transcribed form," (In transcribed form to be in the final sentence.)

<u>SENATE MINUTES CONT'D,</u>: (May 1, 1970) <u>REPORT OF ACADEMIC AFFAIRS COMMITTEE CONT'D.</u>: (Dr. Niemi)

COMMENTS CONT'D. :

5) Will this statement be in the Catalog?

<u>Dr. Niemi Ans.</u>: Cannot be in the next one since that is at the press at the present time; but will be in the next if this passes; and if passed effective Summer Quarter 1970.

6) Student: Speaking against this. If given in writing no flexibility whatsoever, The student may be in research work but cannot make an exception for him.

7) Miss Pfau asked if this passes how this information will be communicated to the Limited Service Instructors in time for the start of the Summer Quarter on June 18, 1970. How will they be informed?

Dr. Pugsley stated: We will find a way to have it mimeographed,

8) An Instructor has a responsibility to **communicate** in writing but only when for him absences will affect the grade,

<u>Dr. Pugsley</u>: If a teacher says absence in itself does not affect his grade? What if a shotgun quiz was given? He would not have to let him make the shotgun quiz up, No obligation on the part of the teacher to do this.

9) One Instructor stated if he gives a "pop quiz" and they are absent they do not ask to make it up because they know they cannot.

10) What is meant by "in transcribed form"?

11) Dean Dykema: We have an obligation to make it as clearly as possible as to what our relationship is in regard to attendance, examinations, between teacher and student in transcribed form.

ADD AMENDMENT <u>TO MOTION</u>: Add: in transcribed form on "at beginning of each, etc," seconded, <u>NO'S HAVE IT</u>.

12) Faculty member stated he was confused on two (2) points:

1) Students welfare, etc., out of place,

2) Little bit soft where attendance is concerned. Attendance is expected at all classes. This Professor thinks this is necessary, If we have a class the student should be there. Take out the phrase "for his own welfare".

REFORI ON THE BOARD C REGENTS FACULTY ADVISORY COMMITTEE MEETING OF

APRIL 15, 1970

BY F. J. Tarantine, Department of Mechanical Engineering

The Chancellor passed out copies of the first two editions of the Newsletter of the Ohio B.O.R. He instructed the members of the committee to raise the question of distribution of the news letter on our respective campuses.

The Chancellor also distributed a statement on higher education prepared by Mr. Cloud, a Republican gubernatorial candidate. The Chancellor informed the committee that distribution of this material did not imply endorsement but that he knew of no other statement on higher education of any of the other candidates.

MASTER PLAN: The Chancellor was questioned on the progress being made by the committees working on the Master Plan Revision. He replied that Mr. William B. Coulter, Program Officer of the B.O.R., is presently meeting for a second time this month with all the Master Planning Committees. He stated further that the exact progress to date, and standing of various matters, is not known to him.

OHIO COLLEGE ASSOCIATION MEETING: The Chancellor commented on a speech he made on April 4, 1970 to the Ohio College Association. He said he cited the facts and figures, including estimates on the Decade of the Sixties he had given our Committee at an earlier meeting (see Minutes of the December 11, 1969 meeting). Also included in his remarks was that the decade of the seventies is expected to be one of expansion; that we will have 50% more college age youth in the seventies than we had in the sixties; that a study made by the Battelle Memorial Institute predicts an increase of 185,000 students to give a total F.T.E. public enrollment of 450,000 students in Ohio by 1980.

The Chancellor said he raised the following questions in his speech: Why is there such a limited enrollment in private schools? Also, are the factors for limiting enrollment other than economic? He said he was unable to get satisfactory answers to these questions. He cited the fact that Kenyon College has an enrollment of 1000 currently, and has set a limit of 1500 students by 1980. He said, however, of this increase, many will be out-of-state students. He noted that Ashland College is the only private College that has managed to keep pace with the current expansions; they have doubled their enrollment in the sixties.

The Chancellor said he suggested that the private schools work together to make a master plan similar to the one now being prepared for the public schools. He offered his cooperation in executing such a plan.

FACULTY ADVISORY COMMITTEE REPORT CONT'D.: (Dr. Tarantine)

The Presidents of some of the private schools said that the state branch campuses are affecting their growth and, therefore, are strongly opposed to their expanding to include four year degree granting programs in Education and Business Administration. The Chancellor said that most of the private schools want public (state) support with no strings attached.

<u>SENATE BILL 488</u>: The Ohio Senate has passed S. B. 488. There have been two hearings by the House Committee on Higher Education. The Chairman of the House Committee has appointed a Sub-committee of three members to draft a revision to the bill which will make it more satisfactory and meet the approval of the B.O.R. The General Assembly will be meeting the last two weeks of May. The fate of the bill should be decided at that time.

The Chancellor has taken this opportunity to ask that S.B. 488 be changed to call for a four year program in Elementary Education only rather than in both Education and Business Administration. He and the B.O.R. rewrote the bill which will provide for the above expansion if the school has the necessary facilities and at least 125 F.T.E. students to enter the Elementary Education program. It must also be at least 30 miles away from the nearest four-year public campus.

FUTURE PROBLEMS FOR HIGHER EDUCATION IN OHIO: The Chancellor emphasized the fact that public higher education in Ohio needs more money. He estimates that we will need about 100 million dollars more per year for the next biennium. This will raise our present expenditure of 510 million to 710 million dollars per biennium. The Chancellor said we must make the public aware of our needs and enlist their support for additional tax monies. He doesn't believe that we can use the argument that our faculties will leave our Universities and go to other states if we don't receive their added support. Instead, we must use the approach that the citizens of Ohio deserve more; i.e., additional funds are needed in order to provide better programs and more service.

The Chancellor cited the problem of not having a unified voice for communicating our needs to the citizens and Legislature. For example, there are 265,000 students, approximately 12,000 faculty members, 12 University Presidents, the Chancellor and the B.O.R., from which several different points of view can be obtained from any one issue.

The Chancellor said he asked each University President to submit a paper listing the goals of each institution. He said the paper should be prepared in consultation with both student and faculty groups.

MR. PRESIDENT, may I address my fellow members and offer a Motion1

In their recent report on campus unrest, the American Council on Education made some 43 recommendations predicated on the assumption that each academic community, with its students, faculty, administration and trustees share and abide by some major principles. Among them were fair play, civility, a respect for privacy, and a faith in rational discourse. During recent weeks this academic community has experienced some major differences of opinion and the consequent violation of some or all of these principles, This may be our final meeting for 1969-70 and it is the first meeting with the newly elected members present. Because I believe such distressing conditions have and must receive some comment of record from this body, I have asked permission to address myself to some aspects of it.

During WW 11, when the Nazis invaded Denmark they immediately ordered all Jews to identify themselves by wearing the star of David publicly, The next day, their Christian king appeared with a similar star on his uniform. Please hear me today as one who is "not the holder of an earned doctorate" and as one who has deplored the unfairness, the incivility, the total disregard for privacy and the absence of a faith in rationality that has permeated the processes of disagreement in our community and hampered the very functions for which we are primarily responsible. My years on this campus are long enough to state quite firmly that never has the base of participatory democracy here been as broad as it is today. Within the past two years our President formally appeared in the Kilcawley Student Lounge weekly for discussion of any and all problems arising from the student body while students, selected by their fellow students, now serve on almost every University Senate committee and sit in this body with the right to be heard in their representative capacities. Not the least salutary result of this cooperation has been the lessons of gracefully accepting the gains and losses and of patience with the often painfully slow processes of democracy.

My fellow members, old and new, I should like to go on record as expressing my respect and appreciation to DR. PUGSLEY for 'keeping his cool' under fire, for his continued fairness, civility, respectfulness and rationality under stress, Similarly am I grateful to our students and colleagues who practiced any of these virtues during these past days, Certainly our problems have not been resolved, but it is my firm belief the ground rules for pursuing differences among us must rest on such principles. From our new SENATE MEETING (Mrs. Botty) - 2 -

May 1, 1970

members we hope for added light in the governance of our community, that together we may restore the peace and good repute that are absolutely essential if we are to effectively seek after the truth demanded of us by our students and colleagues.

Mr. President, ladies and gentlemen! You have been most gracious to me at the end of a busy week, but our own involvement with the issues of these days have almost made us neglect the kind of civility we seek to observe. We are losing the services of two members who will leave behind them a considerable void -- Dr. Coffield and Dean Gillespie. At this time I move that we authorize the Secretary of this body to formally convey to them our appreciation and best wishes. THANK YOU.



SUBJECT: OPEN HEARING ON DISMISSAL PROCEDURES

Attached are two (2) documents presently being favorably considered by the Faculty Affairs Committee:

- 1. Statement on Loss of Tenure (Dismissal Procedure)
- 2. Proposed Statement on Formation of a Faculty Grievance Committee

It should be made clear that the Committee has not given final approval to either proposal. In order to solicit views and observations from members of the University community, including Faculty and Administration, an <u>Open Hearing is being scheduled WEDNESDAY</u>, <u>May 27</u>, 3:00-5:00 p.m. in the FACULTY LOUNGE IN KILCAWLEY CENTER.

Your attendance and participation is urged so that the Committee may consider the points of view which may differ from the proposed statements.

PROPOSAL ON LOSS OF TENURE

BYLAW III.

(

1

Section 4. Loss of Tenure.

The appointment of a tenured faculty member may not be terminated by the University prior to retirement except for adequate cause. The definition of adequate cause for loss of tenure cannot be made precise. The general areas of concern that may generate charges of misconduct sufficient to warrant loss of tenure are professional incompetence, unprofessional actions, and unethical or immoral conduct.

When the **fitness** of a faculty member is under question, appropriate administrative officers shall ordinarily discuss the matter with him directly. If a mutually satisfactory resolution does not result, subsequent procedure can consist of: (1) referral to the Faculty Grievance Committee, and (2) referral to the Judicial Committee.

A. FACULTY GRIEVA COMMITTEE:

The Faculty Grievance Committee (FGC) shall be the standing committee of the University by that name. The duties of the FGC, involving dismissal of tenured faculty, shall be to make an informal inquiry, to advise the faculty member of his rights, and to assist in arriving at a mutually satisfactory solution, if possible. If no solution is agreed upon, the Chairman shall promptly notify the administrative officials and the faculty member of such fact.

If the administrative officials decide to initiate formal proceedings, their representative shall formulate a statement setting forth grounds for their desire to terminate tenure. This statement shall be sent to the FGC and to the faculty member. It will then be the duty of the FGC to determine if the faculty member wishes a hearing before a Judicial Committee, and if so to form such a committee.

B. JUDICIAL COMMITTEE:

The ad **hoc** Judicial Committee (JC) shall consist of seven (7) members, including the Chairman. The members shall be selected at random from the membership of the tenured faculty of the University. The faculty member involved and the administration may exercise one preemptory challenge and unlimited challenges for cause against the JC membership. The Chairman of the JC shall be elected from its own membership and may vote. Five (5) members shall constitute a quorum and a majority vote of four (4) is required for decision. The Committee shall set its own rules for matters not specifically prohibited or required.

FACULTY AFFAIRS COMMITTEE CONT'D.: (Dr. Hurd) PROPOSAL ON LOSS OF TENURE CONT'D.:

B. JUDICIAL COMMITTEE CONT'D. :

The JC shall proceed by informing the administrative officials and the faculty member of the time and place of its meetings. At its first meeting the JC shall consider the statement of grounds for loss of tenure already formulated, and the faculty member's written response. The Committee shall establish procedures consistent with accepted principles of due process, and shall include calling and examining of witnesses, and the receiving of depositions where personal appearance is impracticel, and the hearing of arguments by the principals of their representatives.

At the request of the faculty member or the JC a faculty representative of the American Association of University Professors shall be permitted to attend the hearings as an observer. The administration and the faculty member may each designate a member of the University faculty to assist in developing their cases. The JC shall determine the order of proof, normally conduct the questioning of witnesses, and if necessary secure the presentation of evidence. The faculty member shall have the aid of the Committee in securing the attendance of witnesses.

The meetings of the JC shall be private, except when the faculty member specifies, with the concurrence of the JC, that the meetings shall be open to the University Faculty.

On the basis of its investigation, the JC shall reach its decision in conference. The Committee shall arrive at findings with respect to each of the specific charges against the faculty member. The Administration and the faculty member shall each promptly receive a copy of the results of the hearing. The decision of the JC is final.

C. SUSPENSION:

Until the final decision upon termination of an appointment has been reached, the faculty member will be suspended only if immediate harm to himself or others is threatened by his continuance.

D. <u>PUBLICITY</u>:

Publicity concerning the deliberations shall be limited to simple announcements as may be required. Public statements about the case shall be avoided until the final decision is reached and until the Administration has been notified of the decision.

PROPOSAL FOR A FACULTY GRIEVANCE COMMITTEE

1. That a Faculty Grievance Committee, known as the Youngstown State University Faculty Grievance Committee, be duly constituted on this campus.

2. That it consist of a Chairman, voting only to break ties, elected by the faculty-at-large for a term of one year; and three members, elected at-large and serving for terms of three years; provided that in the first election, the three members shall be elected for terms of one, two, and three years respectively.

3. That the Chairman, and the three members, be tenured members of their faculties, and eligible for election to the University Senate.

4. That the Chairman receive appropriate released time from his teaching duties in order to attend to the business of the Committee.

5. That the Chairman be empowered, whenever he feels it appropriate, to appoint from among the faculty-at-large an <u>Ad Hoc</u> Committee for a more thorough investigation and recommendation.

6. That the Committee be convened for initial consideration of any matters that come before it by written petition within one week of receiving such petition; provided, however, that the Chairman, at the request of the petitioner, be empowered to seek redress without recourse to the Committee.

7. That a quorum of the Committee consist of the Chairman and two other members.

YOUNGSTOWN STATE UNIVERSITY SENATE STANDING COMMITTEES FOR THE 1970-71 ACADEMIC YEAR

INTRODUCTION

1. The following statement was adopted by a Joint Meeting of the Administrative Council and the Executive Committee of the Senate on April 24, 1970, outlining the sources of authority for Committees:

STATEMENT OF CLASSIFICATION OF COMMITTEES ACCORDING TO LINES OF AUTHORITY

A. <u>COMMITTEES DERIVING AUTHORITY FROM THE SENATE:</u>

Policy matters are subject to approval by the Senate. Appointments to committees are made by the Executive Committee of the Senate and reviewed in a Joint Meeting with the Administrative Council.

B. <u>COMMITTEES DERIVING AUTHORITY JOINTLY FROM THE SENATE AND</u> <u>ADMINISTRATION</u>:

Policy matters are subject to approval by both the appropriate administrative reference and the Senate. The order for referral of policy recommendations Sf Type "B" Committees is charged to a Six Member Council composed of three members of the Senate Executive Committee, elected by the Executive Committee and three members appointed by the President. The Six Member Council shall render judgment on the proper reference of the actions taken by the standing committees.

Appointments to committees are made jointly by the Administrative Council and the Executive Committee of the Senate.

C. COMMITTEES DERIVING AUTHORITY FROM THE ADMINISTRATION:

Policy matters are subject to approval by the appropriate administrative reference. Appointments to committees are made by the Administration, or according to the accepted practice, except as specified in the committee description.

2. The following statement governs the selection and appointment of student members to Committees:

On standing committees of the Senate which call for student participation, only one student representative may be a member of Student Council, **unless** otherwise specified in the **committee** description. When the number of student members on a Committee is six, one member must be appointed from each of the six (6) Schools in the University. When the number of student members

SENATE STANDING COMMITTEES CONT'D. : (1970-71)

is eight (8) or more, the eighth appointee shall be from a different school than the seventh (7th), etc. When the number is below six (6), no more than one (1) may come from a single College or School. Only fulltime students (12 or more quarter hours) with a minimum cumulative academic average of 2.25 in work taken at Youngstown State University may hold committee appointments.

A student may not serve on more than **one** standing committee at the same time. The term of offiae for student members is for the academic year with the exception of the one member of each committee who may be from Student Council and the three members of the Discipline Committee who are from Student Council.

Student members on committees may only be replaced during the academic year only for the following reasons:

graduation of the student, withdrawal from the University, or failure to maintain full-time status,

All Appointments of students to committees of the Senate must be made by Student Council and ratified by Student Council in a formal meeting, The Chairman of Student Council shall present the slate of ratified student appointees to the Dean of Student Affairs who is responsible for confirming their eligibility and notifying committee chairman of the confirmation. If appointees are not eligible and not replaced, the seat shall remain vacant. A student shall not serve as Chairman or Temporary Chairman of any Standing Committee of the University.

- 3. The President of the University is an Ex-Officio member of all Committees, and he shall receive a copy of the approved Minutes of all Committee meetings, Any other Ex-Officio members are identified to the Committee on which they serve,
- 4. Each Committee, except the Discipline Committee and the Textbook Subcommittee of Academic Affairs, shall send a copy of its approved Minutes to the University Librarian, These Minutes will be filed and made available to the Faculty, Staff, and Students.
- 5. Ex-Officio members are Voting Members of all Committees unless otherwise specified,

POLICY FOR THE OPERATION OF UNIVERSITY COMMITTEES DURING AND FOLLOWING THE SUMMER QUARTER

In principle it is the expectation of the University that, like the University Senate itself, most committees of the Senate and of the Administration will not be operative during the summer months. However, some committees will have responsibilities that require action during this period. In such cases provision must be made far limited operation: when this is needed the committees will convene es many faculty members and administrative representitives who served during the preceding year as are available. Student membership also shall be drawn from the membership of the preceding year, but may inevitably constitute a smaller proportion of the total membership than during the regular year.

Quorum requirements **will be waived** for summer operations; however, if the number of members available is not sufficient to give adequate consideration to matters before **the** committee, additional ad **hoc** appointments may be made by **the chairman** of **the** Executive **Committee** and the President of the University.

If he is available, the **chairman** from the **previous** quarter wtll **con**tinue to serve during the summer quarter, If the **chairman** is not **available**, a **temporary** chainnan shall be appointed from **among** those faculty and administrative members who can be present, **The** appointment **will** be made by the chainnan of the Executive **Committee** and the President,
