ACADEMIC SENATE MINUTES

OCTOBER 1, 1986

CALL TO ORDER

D. Rost, Chairman, called the meeting to order at 4:04 p.m.

APPROVAL OF MINUTES OF JUNE 4, 1986

D. Rost announced one change to the Senate Minutes—the addition of the date of the meeting, June 4, 1986. The minutes were then approved as distributed and corrected.

REPORT OF SENATE EXECUTIVE COMMITTEE

D. Rost reported. Senator changes since the June 4 Senate meeting are: Beverly Gartland resigned as Senator from Sociology and Lee Slivinske has been elected to take her place. Sid Roberts and Tom Rakestraw are at-large Senators from Arts & Sciences and the School of Business.

Members of the Senate Executive Committee were announced as were current items for consideration by the Senate Executive Committee.

- D. Rost then introduced Provost Gillis who had agreed to make remarks about the North Central Association of Colleges and Secondary Schools accreditation activites by Youngstown State University.

Remarks by Provost Gillis

In February, 1988, a visitation team will come to Youngstown State University for a reaccreditation visit. Each department (Academic and Administrative) must perform a self study to prepare for this Visitation.

A time table has been set and a form has been prepared with a list of questions to be addressed. This form has been disseminated to each department. That form is the basis for the self study.

The Provost urged each faculty member to participate in the self study; its purpose is to determine strengths and weaknesses. It is intended that the institution will be strengthened through the self-examination process.

After each department provides a written self-study report, the report will be forwarded to the Dean of the College; the Deans will prepare a synopsis and add to the reports, if necessary, and forward to the Provost.

An editor will compile a final report to be submitted to the visitation team. The report will be about 80 pages long. All self-study reports will be appended to the final report. Departments should begin to write the self-study reports by February, 1987.

The Provost will attempt to keep everyone informed. Students will be made aware that the team will be on campus.

Report by Dr. Khawaja on FAC Meeting of September 16, 1986

I. Khawaja, representative to the Faculty Advisory Committee to Chancellor Coulter, reported on the September 16, 1986 meeting. Program Excellence concerns were discussed. Those concerns included: lack of wide participation, selection of reviewers, and description of categories.

The recommended budget was discussed. Additions to the recommended budget include: single parent grants, Independent Academic College Challenge program, and construction of a super computer center at Ohio State University. The Chancellor feels there is a good chance the budget will pass with few changes. (See Appendix B for a full report.)

Report of FAC's Meeting on September 16, 1986

Morning Session

Election of Officers:

Program Excellence:

A letter was sent to the Chancellor in July 1986 outlining the recommendations of the FAC about the structure and selection process of this program. These recommendations emphasized three points: (i) Importance of participation by a wider spectrum of academic areas. (ii) Need for a broader academic categorization than the present four catagories. (iii) Assurance to the applicants that the reviewers not only have a perspective which embraces the total university but also have a familiarity with the disciplinary area.

Several members indicated that the quality of 'feedback', sent back to the applicants after the final cut, was not satisfactory. The communication was usually very brief and in many cases could not be used beneficially.

Subsidy Formula and 1987-89 Budget:

Vice Chancellor Daune Rogers met with the group and gave an outline of the subsidy calculation for the Universities and Colleges. He pointed out that the formula has two components: (i) Enrollment related which includes instructional costs, administrative costs, and student service costs. (ii) Non-Enrollment related which includes library acquisition and plant operation and maintenance. There are 16 different models for the state institutions for the 1987-89 biennium. Board of Regents have approved the Budget recommendation for the 1987-89 biennium:

FY 1987 \$1,455,347,400; FY 1988 \$1,628,914,700 This figure includes \$42,336,167 for FY 1988 and \$46,257,859 for FY 1989 for Y.S.U.

Afternoon Session

Chancellor Coulter met with the Committee and discussed the status of the Biennial Budget and the Program Excellence Recommendations made by the FAC.

Biennial Budget:

Chancellor informed the group that the Board of Regents feels confident that the recommendation for the next biennium has a good chance of being accepted. It includes several new items such as: Single Parent Grants, Super Computer Center, and Independent College Challenge program. Facility renovation and equipment replacement which has been under the capital budget is included in this operational budget. Student share of the costs in this budget is calculated at 32% compared to 36% at the present time.

Program Excellence:

Chancellor reacted favorably to the FAC's recommendations. He agreed with the FAC that Universities must be assured that all disciplines are on an equal footing and that there is no slant in favor of any area. Recommendation for 1987-89 Budget includes a \$1,500,000 increase for program excellence.
