## ARTICLES OF INCORPORATION OF THE YOUNGSTOWN COLLEGE

The undersigned citizens of the State of Ohio, desiring to form a corporation not for profit under the General Corporation Act of Ohio, do hereby certify:

FIRST: The name of said Corporation shall be "THE YOUNGSTOWN COLLEGE".

SECOND: The place in this State where the principal office of the Corporation is to be located is the City of Youngstown.

THIRD: The purposes for which said corporation is formed are to conduct an institution of learning; to provide education designed to meet the cultural, vocational, spiritual, social and physical needs of youth, especially in those branches of learning usually included in collegiate and university courses; to confer degrees and to have all powers provided by law for colleges and universities; to acquire, hold, and dispose of property; and to do all things reasonably necessary or convenient to the accomplishment of such purposes.

FOURTH: The following are the names and post office addresses of the persons who shall serve as Trustees of the corporation until the first annual meeting, or other meeting called to elect Trustees:

FIFTH: The members of the corporation shall be of two classes, to be designated respectively as Members and Elected Members. The Members shall be those persons who at the time are duly acting as Trustees of The Young Men's Christian Association of Youngstown, Ohio. The General Secretary of the Young Men's Christian Association of Youngstown shall also be a Member. The Elected Members shall be such persons as are elected to such membership by the Members. The term of the membership of all Members shall be for the duration of their respective terms of office as Trustees or as General Secretary of the Young Men's Christian Association of Youngstown, Ohio. The term of the Elected Members shall be three years. On the expiration of their terms of membership all Elected Members shall be eligible for reelection.

The persons above named as Trustees who are not Members of the corporation, shall be Elected Members of the corporation until the first annual meeting or other meeting called to elect Elected Members.

SIXTH: The voting power of the corporation shall vest in the Members and each Member shall be entitled to one vote. Both Members and Elected Members shall be eligible for election as Trustees.

All budgets, expenditures, policies concerning operating relationships with the Young Men's Christian Association of Youngstown and the use of its properties and facilities, and the appointment of the President of the College, shall be subject at all times to the approval of the Members.
