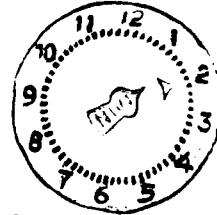

## I Report of Trip to Chicago and Eastern Colleges.

The contacts which were made by your director on the trip to the eastern colleges should be of real value to Youngstown College. The colleges visited were: Williams, Amherst, Northeastern, M.I.T., Harvard, Yale, and Bucknell. The purpose of the trip was to attempt to set up credit relations with these schools so that students would be transferred and also to endeavor to ascertain more facts about the program of some of the eastern universities.

Letter from Robert Eddy.

At a meeting of the North Central Association held in Chicago on April 18, 19, 20, and 21, a new set of regulations and standards were adopted by the North Central Association, which I think should make it more nearly possible for Youngstown College to apply and hope for accreditation.

These new standards do not specifically state how much endowment a school should have, but concern themselves more with how much income per student a school receives. In endeavoring to apply these new regulations to Youngstown College, there is one outstanding weak spot in our program: namely, that of the inadequate library. The library is supposed to be the very heart of an institution and we have practically no library, except for the law college. At the present time the law school library is adequate. What steps should be taken to supply the liberal arts college with an adequate library?

## II Scholarships.

Last year a policy was adopted whereby 20 scholarships with a total value of \$1,000 with no scholarship to exceed \$50 in amount, was voted by the college board and dispersed by the faculty committee. The regulations for allocating these scholarship funds were drawn up by a committee of the Board. It is the recommendation of your director that instead of offering 20 scholarships of \$50 each this year, that it be changed so that we would offer 10 scholarships of \$75 each and 10 of \$50. What does the board desire to do in this matter.

## III Report of Teacher Training

At the present time, there are 26 students taking teacher training. Of this number 6 are already employed in the city schools. At the present time positions have already been offered to 3 of the students who will complete their training in June.
