College of Business offers VITA tax assistance

It's tax time again, and that means it's also time for Youngstown State University's Volunteer Income Tax Assistance Program.

The Lariccia School of Accounting & Finance in the YSU Williamson College of Business Administration is again working with trained business students and professional volunteers to offer free tax preparation services through the VITA program.

VITA, begins on Saturday, Feb. 4, and runs through April 7, and is held in computer labs on the first floor of Williamson Hall, 221 North Hazel St. between Rayen Avenue and Wood Street on the YSU campus. Dates and times are listed below.

VITA offers free assistance to taxpayers, including but not limited to persons with disabilities, students and older taxpayers who file Form 1040EZ, Form 1040A or a basic Form 1040 Federal tax return. VITA volunteers also alert taxpayers to special credits and deductions for which they may be eligible. Taxpayers who visit a VITA site should bring wage and earnings statements (Form W-2) from all employers, interest statements from banks (Forms 1099), a copy of last year's tax return if available, and other relevant information about income and expenses. VITA volunteers must complete an IRS training course in basic income tax return preparation before they can assist taxpayers. Free electronic filing is also available.

Artist lectures on Thursday at McDonough

Hasan Elahi, an associate professor of art at the University of Maryland whose tussle with the federal government brought him national attention, will lecture 5:30 p.m. Thursday, Feb. 2, in the McDonough Museum of Art on the campus of Youngstown State University.

The free lecture is sponsored by the YSU Department of Art.

Elahi is an interdisciplinary artist whose work examines issues of surveillance, simulated time, transport systems, borders and frontiers. His work has been presented in numerous exhibitions at venues such as SITE Santa Fe, Centre Georges Pompidou, Sundance Film Festival, Kassel Kulturbahnhof, The Hermitage, and at the Venice Biennale. He was recently invited to speak about his work at the Tate Modern, Einstein Forum, the American Association of Artificial Intelligence, and at TEDGlobal.

His awards include grants from the Creative Capital Foundation, a Ford Foundation/Phillip Morris National Fellowship, and an artist grant from the Asociacion Artetik Berrikuntzara in Donostia-San Sebastian, Spain. His work is frequently in the media and has been covered by *The New York Times, Forbes, Wired,* CNN, ABC, CBS, NPR, Al Jazeera, Fox, and he has appeared on The Colbert Report. At the University of Maryland, he is Director of Digital Cultures and Creativity in the Honors College. He was a 2010 Alpert/MacDowell Fellow and in 2009 was Resident Faculty at Skowhegan School of Painting and Sculpture.

In 2002, Elahi's name was mistakenly added to the federal government's watch list. He was detained in Detroit after a flight from the Netherlands, suspected of hoarding explosives in a Florida locker. Lie detector tests subsequently cleared him. He decided, however, "to turn the tables and cooperate - with a vengeance," according to *Wired* magazine. The process grew into an art project as Elahi began posting photos of his minute-by-minute life - hotel rooms, train stations, airports, meals, beds, receipts, even toilets - generating tens of thousands of images in the last several years and proving "his point that the best way to protect

privacy is to give it away," *Wired* reported. He says: "By putting everything about me out there, I am simultaneously telling everything and nothing about my life."

White-collar criminal speaks on campus

Sam Antar, convicted felon, former certified public accountant, and former chief financial officer of Crazy Eddie, focuses on "Lessons about White-Collar Crime from a Master Criminal" during a visit Friday, Feb. 3 to Youngstown State University's Williamson College of Business Administration.

Antar will speak at 7:30 a.m. in Rooms 3422 and 3423 of Williamson Hall as part of the Williamson Symposium Lecture Series sponsored by the WCBA. The breakfast and presentation are free and open to the public. To make a reservation, visit www.ysu.edu/wcba and use the Williamson Symposium Link or call Christine Shelton at 330-941-3068. Free parking is available in the lot on Wood Street across from the southern entrance to Williamson Hall.

Antar also will speak at 12:30 p.m. in the first floor auditorium in Williamson Hall. This presentation, part of an Ethics Conference presented by WCBA in collaboration with the Institute of Management Accountants and the Dr. James Dale Ethics Center at YSU, is for YSU students and is not open to the general public.

The ethics conference, which runs from 8:45 a.m. to 1:30 p.m., is intended to create a shared focus among students and faculty on the importance of business ethics, corporate social responsibility, and sustainable business.

"We're teaching students how businesses can be agents of ethical, social and environmental change in society, and we are equipping students to be part of that change," said David Law, professor of accounting who is spearheading the planning for the conference.

Antar, as the CFO of Crazy Eddie, helped Eddie Antar and other family members mastermind one of the largest securities frauds uncovered during the 1980s. His responsibilities at Crazy Eddie included skimming, money laundering, insurance fraud, securities fraud and other criminal activities. He eventually pleaded guilty to three felonies. He was sentenced to six-months of house arrest, 1,200 hours of community service and paid approximately \$10,000 in fines. In his settlement with the Securities and Exchange Commission, he agreed to a lifetime bar from being an officer or director of a public company and paid \$20,000 in disgorgement of losses that were avoided by selling his Crazy Eddie stock at inflated prices.

Today, Antar advises federal and state law enforcement agencies such as the U.S. Department of Defense, the U.S. Treasury and the SEC about white-collar crime. He teaches about white-collar crime for colleges, universities, professional organizations and businesses.
