My dear Mr. Kirwan:

This is in response to your communication of December 6, 1940, enclosing a letter addressed to you on November 29, 1940 by Mr. Thomas J. Bartinsky, 330 North Garland Avenue, Youngstown, Ohio.

A careful search has been made in this office, but no claim for disability benefits has been located. There are enclosed for Mr. Bartinsky's use Form 526, Veteran's Application for Disability Compensation or Pension, and Signature Card, Form 1099. When these forms have been completed, they should be forwarded to the Veterans' Administration, Brooksville, Ohio, where your letter and enclosure are being referred. That office will take all necessary action and will keep you informed of the progress in the case.

If Mr. Bartinsky or Mr. Harold Snell, who is in charge of the Veterans' Relief in Mahoning County, Ohio, will forward to this office a copy of the letter which accompanied the application that the veteran stated was forwarded to Washington last August, a further search of the records will be made to ascertain whether the original letter was received in this office.
