

From the Desk of the President

As this administration is drawing to its close, it is time to review the past months. I must admit that there has been little dullness and much excitement. Even the duller times were only so by comparison not by

their actuality.

Who, last December, would have dared to predict what the following months had in store for us? Such things as hospitals having to contend with strikes by professional employees and by non-professional workers. Unhappiness of doctors with hospital administration and of hospital administration with doctors. Everyone unhappy with themselves and with everyone else.

What about our unsuccessful effort to foil the State Medical Board's reorganization bill with its biennial registration of physicians? The avowed purpose of this bill was to keep track of all the doctors and also to decrease infraction of the State Medical laws. It also must have been pushed as a means to relieve unemployment for, only a few days ago, our papers carried an item that the State Medical Board was asking for an appropriation of over \$50,000 to hire 5 more inspectors.

Who can forget the installation dinner with entertaining Dick Modzelewski of the Cleveland Browns as our speaker? What about the fantastically successful Dinner-Dance in February? If those who attended

had their way, it would still be going cn.

Much more took place. Our Medical School Committee has worked long and hard and considerable progress has been made in the effort to get a medical school in Youngstown as a part of Youngstown State University.

Our society has become an integral part of the Area Regional Hospital Planning Association. We are closely involved in the Regional Medical Program which will be based in Cleveland, but encompass a 10 county area.

Much time at repeated meetings was spent in working out our agreement with Insurance Company representatives in implementing the new

Steel Health Contract. This hasn't been completed yet.

Two other matters should be brought to your attention. Our Bulletin has become a "must" reading for our doctors and their families. What a wonderful thing it is to know that our medical family wants to read this fine publication, understands it, and goes out of its way to comment. Moreover, for the first time, an excerpt from the Bulletin has gone "coast-to-coast."

Finally, another wonderful thing has taken place. Thus far, not a single member of our Medical Society has refused an assignment when

called upon to do a job. What cooperation!

Another administration is about to take over with Dr. Robert Fisher as its capable leader. What may be ahead of it we can't tell. We can promise though, that if 1968 is like 1967, they will never forget it.

During the past year, there were 6 deaths. Three members moved from Mahoning County, and two members retired from active practice.


PRESIDENTIAL HOPEFULS SPEAK OUT

SIDE EFFECTS of significance have not been reported. However, the risk of vaccine-induced poliomyelitis, estimated to be from 1:2,500,000 to 1:50,000,000 should be considered.

MCMS SPONSORS ATHLETIC INJURIES CONFERENCE

An outstanding Athletic Injuries Conference was presented by the Mahoning County Medical Society in conjunction with the Northeastern Ohio Teachers Association annual meeting on Friday, November 3, at Chaney High School Auditorium. A total of 65 coaches, trainers, athletic personnel and physical education instructors from the schools attended the meeting. For the first time, α number of women instructors were present.

Moderator for the meeting was Dr. D. R. Dockry, chairman of the Athletic Injuries Committee. The program included the following subjects:

"Fundamental Movements and Conditioning" — William Podoll, Asst. Prof., Director, Men's Division of Health and Physical Education, Youngstown State University.

"Athletic Training" - Willard Webster, Athletic Director. Trainer.

"Injuries of the Knee" — Dr. H. J. W. Marcella.

"Treatment of Injuries and Rehabilitation" — Dr. M. J. Vuksta.



TB ASSN. HONORS DR. BAKER

Dr. Edgar C. Baker was honored recently for his many years of work with X-ray in the control of tuberculosis. The Mahoning County Tuberculosis and Health Association presented a plaque to Dr. Baker at a special board meeting held for that purpose. The presentation was made in a speech by Dr. Edwin R. Brody, past-president of the association.

In accepting the honor, Dr. Baker related the problems and needs of the early days of radiology in Youngstown. Dr. Brody lauded Dr. Baker as a true pioneer and cited his many contributions to the science of

radiology.

20 DON'TS FOR DOCTORS

James H. O'Connor, Phoenix attorney and member of the International Association of Insurance Counsel, recently had an opportunity to kick around some malpractice problems with many of the outstanding malpractice defense lawyers in the country. At one meeting, the lawyers discussed some various don'ts for doctors. A summary of 20 of these has been published by the Defense Research Institute as an aftermath of the meeting. They are:

Don't criticize a previously treating doctor without knowing all the facts.

Don't fail to keep adequate records.

Don't put personal SUSPICIONS in the records.

Don't change or add a record after an untoward event.

Don't guarantee treatment or make over-optimistic statements

Don't fail to have an advance understanding about your charges where a substantial fee is expected.

Don't press for collection of a bill from a dissatisfied patient without

thinking twice.

Don't unnecessarily withhold from the patient the dangers incident to your treatment particularly with drugs not yet time-tested.

Don't unnecessarily withhold from a patient suffering from a serious ill-

ness the material facts thereof.

Don't fail to call in a specialist where this need is indicated.

Don't fail to get the patient's consent if someone else is to be called in to do surgery or diagnostic procedures.

Don't fail to use the indicated diagnostic procedures (X-rays, rabbit test,

Don't fail to take a complete history which shows why certain procedures should not be used (penicillin, barbiturates, reactions, etc.) and see that proper warnings are given.

Don't fail to confirm your instructions in writing where you have reason to believe the patient is not cooperating or where serious consequences may

result.

Don't leave the city without advance notice to a patient needing continuing care.

Don't fail to respond promptly to emergency calls from your regular patients.

Don't give privileged information on only oral authorization. Don't disclose the fact that you are covered by insurance.

Don't assume that the old fashioned doctor-patient relationship still exists.

Don't be a member of the do-it-yourself school when a malpractice claim is asserted.

Report it at once so it may be handled expertly.

There were 206 active, 9 non-resident, 7 associate and 5 honorary

members.

TWENTY YEARS AGO — DECEMBER 1947

The nursing shortage was critical and Dr. F. S. Dr. Reilly brought in a resolution at the Society meeting on December 16th which paved the way for the establishment of the Medical Service Foundation. It provided that fees paid by the Mahoning County Relief for in-patient medical care in the hospitals should be put into a fund administered by the Society to be used for educational and scientific purposes. The Bulletin gave very little space to this routine business which was to be of such importance later.

TEN YEARS AGO — DECEMBER 1957

President Ondash reported a year of great progress: The health amendment to the Youngstown City charter was passed, giving us a Board of

MEDICAL LEGAL COMMITTEE REPORT

In 1957, the Ohio State Medical Association and the Ohio State Bar Association adopted a "model" suggested Code of Cooperation between Physicians and Lawyers.

It was a statement of principles governing the relationship between the two professions and was recommended to the county societies for

adoption.

Occasional interrupted negotiations toward an agreement between the Mahoning County Medical Society and the Mahoning County Bar Association over many years finally came to a successful conclusion with adoption of the agreement by the Mahoning County Bar Association Board of Trustees on April 12, 1967 and the Council of the Mahoning County Medical Society on May 9, 1967. The Code of Cooperation was published in full in the August 1967 Bulletin of the Mahoning County Medical Society.

The Ohio State Model was altered by only one minor amendment. The agreement should serve as an excellent basis of a permanent relation-

ship of cooperation between the local medical and legal professions.


