

# From the Desk of the President

#### AN EYE ON THE HORIZON

The beginning of the New Year is a time for beginning anew; a time for a fresh start; a time for setting the record straight; a time for resolutions and a clearing out of the cobwebs of the mind. So it is with our private lives and so it must be also in our Medical Society. The beginning of a new year calls for a re-defining of our aims and objectives. Where are we going? What are we doing? Why do we need a County Medical Society?

The constitution of this Mahoning County Medical Society sets forth the purpose of our organization as follows: "To promote the science and art of medicine and the betterment of public health . . . ". Each year a new president has set out to interpret that statement in his own personal way, and each has contributed something to our heritage. We have done positive things, like well-baby clinics, and polio and measles vaccine campaigns; and we have considered it important to do negative things, like opposing medicare and other welfare plans that impose a restraint on our desire to practice medicine to the best of our ability. Oddly enough, we have become far more famous for our negative actions than for our positive ones.

The objective of the coming year will be to "Accentuate the Positive". Although it cannot be denied that postive effects can result from negative actions, we hope to be able to dispel any notions that our organization is reluctant to keep pace with social progress. On the horizon locm scme dramatic changes in the social and economic aspects of our community which will have drastic and perhaps permanent influence on our profession. Many of us have only the vaguest notion as to the extent of the changes which are in the blue print stage of our community. Most of these plans have a direct effect on our organization in particular, and on the practice of medicine, in general. Already we have seen urban renewal in action, with the centralization of medical facilities on the North Side. Associated with this is the possibility of a medical school in our community, probably affiliated with Youngstown State University. Our Society has also been working with the Cleveland Academy of Medicine and Western Reserve University group to organize a regional medical program for this section of Ohio.

These are some of the things that your society is doing in a positive manner, to "promote the science and art of medicine". During the coming year we hope to keep you abreast of these exciting changes which are in store for our community. Dr. Richard Murray, as program chairman, is planning programs which will approach these goals with meetings designed to keep an "eye on the horizon". Dr. James Anderson, new editor of the Bulletin, will convey his ideas via the printed word each month in his editorials. Our goal is to keep our eyes on the horizon, and to take our rightful place of leadership in the medical affairs of the community and

in the exciting events of the future.

#### Editorial

The primary purpose of a medical school is to train physicians. Is this a self-evident statement? Perhaps a generation ago it was, however, today

it may be a thought-provoking one.

The fresh-from-the-mold M. D. may now follow many a path: He may become an administrator; he may go to work for a pharmaceutical house; or he may spend his productive life in the laboratory. If he chooses clinical medicine he may pursue further training as a sub-subspecialist, or he may become a General Practitioner and "just take care of sick people". There must be teachers. The aerospace program needs medical personnel.

Many of the opportunities presented to the modern medical school graduate do not include direct contact with patients. The importance of these non-clinical disciplines certainly should not be underestimated. However, one might ask how much of the medical student's time should be

spent preparing for such endeavors.

The student is now spending more time conducting research than he did in earlier years. When this teaches him the scientific approach to a problem and gives him a scientific background for his medical knowledge, it is good; when it takes time away from percussing chests and palpating abdomens, it is bad. The multiplication tables must be memorized before calculus can be attempted and to memorize requires repetition (even with the "New Math"). One might also say that a test tube in the hands of a clinician is safer than a patient in the hands of a reseacher, and goals set by students in medical school only too often change.

Some would reason that a student with great research potential is wasting time in studying clinical material that he will never use. In answer to this, one may point out that the value of research is ultimately in its practical application and that the investigator, with a good clinical background, is in the best position to apply basic research. Also, one may conclude that the student who is not suited for clinical medicine might better pursue a more academic course and join the ranks of the many medical school faculty members who have earned the Ph. D. degree.


#### PHARMACISTS ELECT OFFICERS

#### **Prescribing Information**

Indications: "Symmetrel" is indicated for the prevention (prophylaxis) of influenza  $A_2$  in persons of all age groups. Early use is recommended, preferably before or as soon as possible after actual or suspected contact with individuals suffering from influenza  $A_2$ . "Symmetrel" should especially be considered for high influenzarisk patient groups such as those suffering from chronic debilitating diseases and elderly persons.

Contraindications: Not indicated for the prevention of influenza or respiratory disease other than influenza  $A_2$  or for the treatment of established illness. Availability of "Symmetrel" should not affect the physician's usual vaccine practices.

Warnings: Administration to patients with central nervous system disease, particularly geriatric patients with cerebral arteriosclerosis, and patients with a history of epilepsy or other "seizures", requires strict observation for possible untoward effects (see Adverse Reactions). Patients taking psychopharmacologic drugs, central nervous system stimulants, or alcoholic beverages should be observed for possible evidence of intoler-Those patients who experience central nervous system effects or blurring of vision should be cautioned against driving or working in situations where alertness is important.

No teratogenic effects have been seen in reproductive studies in rats and rabbits. Studies in pregnant women have, however, not been done and use of this drug in women of childbearing age should be undertaken only after weighing the possible risks to the fetus against benefit to the pregnant patient. It should not be administered to nursing mothers since it is not known whether the drug is secreted in the milk.

Precautions: Ineffective against bacterial infections. Patients should be observed for idiosyncratic reactions as with all new drugs. Geriatric patients with pre-existing serious medical illnesses with mental or physical deterioration should be followed carefully while taking "Symmetrel". (See Adverse Reactions.)

Adverse Reactions: With higher than indicated doses manifestations of central nervous system effects such as nervousness, insomnia, dizziness, lightheadedness, drunken feeling, slurred speech, ataxia, inability to concentrate and some psychic reactions including depression

and feelings of detachment were seen. Occasional blurred vision was reported at higher doses. Some of the milder and less pronounced symptoms above have been reported in a small number of patients taking the recommended dosage of 200 mg per day. These were mostly transient and disappeared with continued administration of the drug. Some geriatric patients developed paranoid or hallucinatory behavior and became unmanageable while taking 200 mg daily. Medically unselected seriously deteriorated geriatric patients showed poor clinical tolerance after several weeks of daily dosing with 200 mg per day. One elderly patient with a history of prior cerebrovascular accident developed visual hallucinations and grand-mal convulsions while on the drug at 800 mg per day. Some cases of dry mouth, gastrointestinal upset and skin rash and, rarely, tremors, anorexia, pollakiuria, and nocturia have been also reported.

**Dosage:** Adults: Two 100 mg capsules (or 4 teaspoonfuls of syrup) as a single daily dose; or the daily dose may be divided into one capsule of 100 mg (or 2 teaspoonfuls of syrup) twice a day.

Children: 1 yr.—9 yrs. of age: Calculate total daily dose on the basis of 2 mg to 4 mg per pound of body weight per day (but not to exceed 150 mg per day). Daily dose, given as the syrup, should be given in 2 or 3 equal portions.

9 yrs.—12 yrs. of age: Total daily dose 200 mg, given as one capsule of 100 mg (or 2 teaspoonfuls of syrup) twice a day.

How Supplied: Capsules: Bottles of 100. Each red gelatin capsule contains 100 mg amantadine HCl.

**Syrup:** Bottles of 1 pint. Each 5 ml (1 teaspoonful) contains 50 mg amantadine HCl.

Just as the phylician wants the latest equipment and up to the minute knowledge for treating his patients, he should want his waiting room to be up to date.

This is easily done. Buy new magazines. At the end of the month, throw out all the old issues. Automatically, this keeps the reading material up to date and mollifies the patient who has been kept waiting. After the first month, the job is relatively easy.



#### THIRTY YEARS AGO - JANUARY 1938

criticism if it were constructive.

The Board of Health and the hospital laboratories were busy that winter with Neufeld tests for the typing of pneumonia. When the type was determined, serum was available to combat all the 32 types of pneumococci. In serious cases the serum was administered intravenously in amounts from 40 to 100 cc. To quote from the *Bulletin*, "The quality of the serum is wonderful, the technique of administration very simple, but the cost is prohibitive to the average patient." No antibiotics then.

Dues were increased to \$20.00. The reason given was that Postgraduate Day was an established activity of the Society and should be included in the dues so that everyone would attend. When Postgraduate Day was dis-

continued no one thought to reduce the dues.

TWENTY YEARS AGO — JANUARY 1948




