



From the Desk of the President

CONTROL OF MEDICAL PRACTICE AND INCENTIVES

With the mounting propaganda against the private practice of medicine in this country in the recent past, the pattern appears to emerge that all this is tending to push us into a completely state controlled system. Criticism pointing to high costs of medical care, including high physician incomes, criticism pointing to unsatisfied demands for medical care, criticism exposing shortages of hospital beds and physicians, etc., all either hint at, imply, or have been coupled with suggestions that under a controlled system these problems would be solved.

Various plans have been recommended to reduce medical care costs. Those plans emanating from government, welfare, insurance, industrial or labor agencies or individuals, tend to emphasize marked reduction of physicians' incomes. Plans proposed by physicians or by their representative organizations tend to emphasize quarantees that all people, regardless of income or lack of same, will receive medical care at all times when it is needed, and through some form of insurance, pay for it without imposing

financial burdens on the patients.

The proposals originating from the medical profession have the merits of not tampering with physicians' incomes, avoiding excessive paper work for physicians, and in general avoiding regimentation of an important group in the community. Proposals originating from outside of the medical profession appear not to be much concerned with these items, and are willing to sacrifice these in the name of economy in the furnishing of medical care. To put it bluntly, what will be sacrificed is incentive to do good work! Physicians are no different than other individuals in a community, and need incentives to work hard and render good service. If any plan is introduced that severely reduces physicians' increases, increases their paper work, multiplies regulations to be followed, reduces physicians' prestige, makes physicians beholden to political officials, increases the rising numbers of unwarranted malpractice suits, etc., it is certain to finally wind up with reduced incentives for physicians and eventually will result in decreases of the quality of medical care. It would also be difficult to attract the best students to medical schools if we reduce the incentives and constrict the freedom of physicians to practice their profession.

Humans still need freedom, incentives and free competition in order to produce excellent work. Let us face it, there are not enough dedicated men and women who will remain dedicated for a lifetime in any profession or in any calling to render good service for an entire country in the face of providing no continuing incentives, such as good income with betterment factors, such as social status and prestige, and especially freedom from excessive

political control and regimentation.

During the past year there were five deaths. Five members moved from Mahoning County, and three members retired from active practice. Eight doctors were added to the roster.


CHECK THESE DATES





S. Q. LAYPIUS OBSERVES:

Fifty years ago the Uptown District at Market and Indianola Ave. was known as Kyle's Corners. The old Kyle Farm occupied the area from Market Street over to Oak Hill Avenue. When the owner died he provided in his will that a part of the farm be preserved for pasture for his favorite horse and for many years the old white horse could be seen grazing in a pasture where the Mansion Restaurant is now. After the horse died most of the land was given to the city for a playground which can be entered from Oak Hill at Earle Ave.

Down Indianola Avenue at Glenwood was Fosterville. There was a blacksmith shop there where Ben's Appliance Shop is now. In 1916 the blacksmith saw that times were changing and installed a gasoline pump. This writer would drive up in his spanking new 1916 Hupmobile touring car and say "Fillerup" at eleven cents a gallon. Those days we had touring cars and roadsters. No coupes, sedans or convertibles. A few rich people had limousines.

They talk now about car safety. Cars then were much safer. They had no seat belts, no bumpers, no windshield wipers, no defrosters, no rear view mirrors but they were safer. Why?

Because they were slower. The average driver went 25 miles an hour. Anyone who went 45 was a speeder. A 45 horsepower engine was average and 90 horsepower was super.

At Market Street and Midlothian there was a dead end. Market Street Extension, known as the Boardman Road started one block west and ran south to North Lima. It was a brick road on the east side and dirt on the west side. Market and Midlothian Blvd. was known as "Dead Man's Curve" because so many cars failed to make the turn on Midlothian. One night Dr. Sam Sedwitz failed to make it and his car rolled over three times. He walked away unhurt.

Going south down the Boardman Road people would drive on the left, which was brick until they met a car coming north. Then they would get off on the dirt, raising a cloud of dust until the car passed and they could get back on the bricks again. There was not much traffic and they did not need to get off very often.


In downtown Youngstown, parking was no problem. You parked in front of the store and went in. Sometimes on Saturday you had to park in the next block and felt very put out about it. Most people went down town by electric trolley (five cents).

Now everybody has a car and there is no place to park and the trolley car is no more. Ain't it wonderful?

For many years, the incoming president of the Mahoning County Medical Society received a gift which he treasured long after the acclaim and the headaches were but a memory. This was a gavel turned out in the wood-working shop of Dr. Earl Brant. Dr. Brant loved beautiful wood and his gavels were made with loving care. Grom the Rulletin



THIRTY YEARS AGO — DECEMBER 1939

In 1939 the Medical Society had a good year. The financial report showed a net profit of \$196.11 from the Bulletin. There was a profit of \$46.33 from the Annual Banquet, \$407.83 from Post Graduate Day and \$187.05 from the lecture course. The Society purchased \$1,500.00 of Government Bonds and ended the year with a surplus of \$12,484.00.

Speaking of attendance and interest in Society affairs, Editor Patrick summed it up in words which well apply today when he wrote, "The future of medical practice is in the hands of the medical profession. Your responsiveness to and handling of the changing conditions will determine whether medicine is to be a leading and constructive force in a changing society. You cannot ignore the situation. If you don't make it right someone else will. So get out to meetings, get on committees, acquaint yourself with the problems to be solved and give of your time and thought. You are the best educated of any group in the community of which you are a part. Why not put that education to work for yourself and the community?"

Annual dues were twenty dollars of which five went to the O.S.M.A.

TWENTY YEARS AGO — DECEMBER 1949

There were 240 active members 2, Associate, 7 Intern, 11 Non-resident and 10 Honorary.

Those days Staff meetings were held once a month. Someone read a paper or a group gave a symposium, memorial resolutions were presented for departed members, some current business was transacted and everyone went home. Due to the regulations of the Joint Committee on Accreditation, Staff meetings now consist of committee reports and a critical appraisal of the work done in the hospital. Section meetings extend the appraisal to a more detailed study of deaths and procedures in the various departments. These sessions are informative but the only formal scientific programs are the clinical-pathological conferences and the Visiting Professor programs.

Medical Society meetings now have to compete with very good programs in the hospitals. It is difficult to offer a scientific program with general appeal. A speaker on Diabetes may not attract the orthopedist, the dermatologist or the psychiatrist even though the disease affects every organ in the human body. Consequently, attendance is falling off. A recent meeting to consider changes in the Constitution had to be adjourned because there was not a quorum present.

TEN YEARS AGO — DECEMBER 1959

President Neidus expressed pride in our Executive Secretary, Howard Rempes and well he should. He made special mention of Schreiber, Kiskaddon, McGregor, Randell and Shensa for their notable contributions during the year.

R. M. Kiskaddon published a thorough and informative report from his "Committee On Aging." Some of the things recommended are now being done.

O.S.M.A. dues were raised \$5.00 for the coming year. Council voted to absorb the raise so that our dues would remain the same: \$125.00 for M.C.M.S., O.S.M.A., and A.M.A.

Fifty year service pins were awarded to F. J. Bierkamp, E. Henry Jones, Robert G. Mossman and Walter B. Turner.

Andy Detesco opened his new office building on Market St. James Patrick and Robert Tornello moved in to share the place.

Dr. and Mrs. Joe Campolito welcomed a baby boy to share affection with

their two daughters.

Bamadex was new from Lederle and Percodan from Endo. Isaly's recommended Yoghurt for the intestinal side effects of some antibiotics. Lyons was down at 32 Fifth Avenue.

O'Linn's Pharmacy was in the Bus Arcade and Blair's Cleaners out on Glenwood. Brown's was on Central Square. They are gone now. Central Tower had empty space for doctors. Downtown Youngstown was on the downgrade.

> In Memoriam HENRY SISEK, M.D. 1904 - 1969

One who was born and raised in this community, who went away to school, again went away to war, and returned to his hometown to practice, must have had a special feeling for the people of this town. Such a man was Dr. Henry Sisek, who died on November 20th.

He was a member of the medical staff at Youngstown Hospital Association, where he had once interned; and he engaged in general practice in Youngstown for more than 30 years. He went to Rayen High School and West-

ern Reserve Medical School.

After taking graduate work in surgery at the New York Polytechnical Clinic, he performed emergency orthopedic surgery here for a number of years.

During World War II, he served with the Medical Corps for 3 1/2 years in the Pacific, coming home a major with three battle stars earned in the

Leyte and Philippine campaigns.

Many will remember him as an enthusiastic gardner. At one time he owned a farm at Coitsville. In 1965, he was picked by the renowned Jackson-Perkins Rose Gardens to be a member of their board.

He was a member of the American College of Surgeons, Youngstown Elks Lodge 55, and was an active participant in the Medical Alumni Fund of Western Reserve University. He was a member of St. Edward Church.


He was a part of this community, and when he passed away, he left α void that will not easily be filled. We pause to mourn the passing of α fine physician.

PROCEEDINGS OF COUNCIL NOVEMBER 11, 1969

The regular meeting of the council of the Mahoning County Medical Society was held on Tuesday, November 11, 1969, at the Mural Room, Youngs-

town, Ohio.

The following physicians were present: J. W. Tandatnick, president, presiding: J. J. Anderson, Louis Bloomberg, L. P. Caccamo, K. E. Camp, D. J. Dallis, F. A. Friedrich, Henry Holden, R. L. Jenkins, J. C. Melnick, J. V. Newsome, S. F. Petraglia, C. E. Pichette, M. C. Raupple, E. T. Saadi, Kurt Wegner, L. J. Zehr, S. V. Squicquero, R. A. Wiltsie. Also present were: Dr. Robert L. Gilliland and Dr. William E. Sovik. Absent were: G. E. DeCicco, R. R. Fisher, R. D. Murray, F. L. Schellhase, Jack Schreiber, Charles Waltner, Herman Allen, R. W. Fenton and Dave Belinky.

The meeting was called to order at 7:20 p.m. The minutes of the previ-

ous meeing were read and approved.

Bills were read. The motion was made, seconded and duly passed that

each bill be paid.

The any-doctor call report of the Medical Dental Bureau was passed around for each member to see.

The following applications were presented by the censors:

The applications were approved. The above applicants will become members of the Mahoning County Medical Society within fifteen days after publication in the *Bulletin*, unless objection is filed in writing with the secretary

during that time.

Dr. Caccamo, reporting for the Medical School Committee, announced that copies of the summary of the medical school report are being mailed out. He reported meeting with Youngstown State University officials and that the university has taken steps to develop a Department of Allied Health Education in the graduate school. He stated that his committee should continue to work in the area of graduate education. The motion was made by Dr. Wegner, and properly seconded, that a letter of high commendation be sent to Dr. Caccamo and his committee. Motion was passed.

Discussion was introduced by Dr. Tandatnick concerning direct referral of school children to paramedical persons without the physician's knowledge. The following doctors spoke on the subject: Dr. Anderson, Dr. Bloomberg, Dr. Sovic, Dr. Wegner and Dr. Gilliland. The motion was made by Dr. Anderson, and properly seconded, that the president appoint a committee to study the problem concerned with children's learning problems. The motion was passed. Dr. Tandatnick appointed Dr. Anderson to be chairman and recom-

mended that Dr. Wegner and Dr. Gilliland be on the committee.

Dr. Pichette recommended that the Ophthalmological resolution, which is attached to the minutes, and which had been quoted by Dr. Sovik, become

part of the minutes of the new committee.

Dr. Tandatnick introduced discussion concerning a news item announcing a \$15 million hospital in Boardman. There was speculation concerning the hospital and the 30 physicians mentioned in the news article. No facts were forthcoming. A motion was made by Dr. Caccamo, and properly seconded, that Mr. J. Stanley Johnstone look into the problem of a 500 bed hospital being built in the community without consultation with the Mahoning Valley

Health Planning Association and reply by letter to this council at the earliest

possible time. Motion was passed.

Dr. Wegner reported on the progress of the Rubella Vaccine Program to be sponsored by the Mahoning County Medical Society in Mahoning County. He announced that the program would take place in the schools in January, that Girard and Liberty schools would be included through the proper channels, that the suggested costs would be \$1.50 per child, that the Ohio State Health Department will make 10,000 free doses available for indigent children and that no stations will be set-up for the public outside the schools.

Dr. Saadi announced that he has served three years as representative of the Mahoning County Medical Society on the Regional Medical Program. He desires to retire from this position and asked that another be appointed. Dr.

Tandatnick had the consent of council to make the appointment.

It was noted that several members, being retired, were eligible for honorary membership. Dr. Bloomberg will present the names at the next meeting of the Medical Society.

Dr. Tandatnick announced that next council meeting will be Monday,

December 8th.

He reported to council on a successful medical assistants dinner. A brochure on vacation tours was passed around for any interested.

A letter from Mrs. Petraglia was read concerning Auxiliary interest in a Suicide Prevention Center. The motion was made by Dr. Wegner, and properly seconded, that the matter be referred to the mental health committee. Motion was passed.

Meeting was adjourned.

DR. TANDATNICK QUOTED
