

From the Desk of the President

A COMMUNITY OF DOCTORS

The state of fragmentation of the doctors in our community into two staffs is neither practical, desirable nor does it serve the best inter-

ests of the doctor or his patients.

There has been too much of the division of doctors in the past and what we need is increasing identification with the Mahoning County Medical Society rather than emphasis on which of the two staffs we belong. Efforts need to be made to bring about the necessary changes in the by-laws and constitutions of the two hospitals to permit a doctor to be an active member of both staffs rather than an active member of one staff and on the courtesy staff of the other hospital.

This position would bring about more flexibility and freedom of choice for both the patient and the doctor. I believe that both would feel more at home under this situation.

The more intermingling of the doctors would make peer review performed on a broader base encompassing the entire segment of a specialty particularly where there are only a few doctors on each of the current "two staffs". The increased communication among doctors could result in more "curb-stone" consultation and lead to more formal consultation to the benefit of the patient.

The best of two worlds in medical records, conferences, teaching and other areas could improve efficiency, quality of medical care and

more uniformity in the medical practice in this area.

We need each other for learning and teaching as well as to provide a united front against those who would use the divide and conquer method. The Mahoning County Medical Society as a community of physicians has provided group plans for a variety of insurances. A new Socioeconomic committee to begin functioning in 1974 has many areas where they may be of great assistance to young starting doctors such as office design, equipment, loans, medical ethics, fee schedules, consultation and many, many others.

The orientation committee is also to be revitalized this year to help

new members of the Society.

The new doctor, as well as the older doctor, can avoid the trial and error method, and instead utilize, on a voluntary basis, methods that have proven successful by experienced practitioners.

Our county medical society should be first and foremost. It should lead in helping doctors and in the improvement of our lot with government, hospitals and insurance companies. We should strive for more simplicity in form, more rigid peer review, continued improvement of the quality of medical care and a truer fraternity of doctors.

Through professional unity we can maintain our integrity of medical ethics, private doctor-patient relationship and service to those in need of medical care. In this way we will preserve the sacred heritage of our noble profession and walk with pride and not be pushed by our adversaries.



NEW LAW FROM OHIO STATE LEGISLATURE

"EVERY PREGNANT WOMAN MUST HAVE A PRENATAL TEST FOR GONORRHEA EFFECTIVE DECEMBER 19, 1973", so say sections

3701.46-3701.50 of the Revised Code of the State of Ohio.

This is the latest step taken in the attempt by public health authorities to get on top of the rampant VD problem. It is clearly a result of recognition by physicians of the problem's existence, their understanding of the newer methods for diagnosis and treatment, and their total cooperation with classic

public health methodology.

During 1970-71, I reported success locally with use of the special Thayer-Martin media for culturing N. Gonorrhoeae, on 600 females from our venereal disease clinic. In the summer of 1972, the State of Ohio initiated a screening program with federal funds designed to make the GC test available to every woman free of charge. From planned parent clinics, various health centers, and a small nucleus of participating private physicians, we found ourselves performing 500 cultures per month early in 1973. As we begin 1974, it is indeed gratifying to have well over 50 physicians routinely contributing cultures along with regular clinic providers, so that we are now performing 1,500 cultures each month.

If this be indicative of the story elsewhere in the nation, then the tip of the iceberg has got to be melted. Since GC testing has become mandatory in prenatal examinations, and must be done in an approved laboratory, we welcome inquiries from any doctor desiring to avail himself of our service to his patients. Please call the Youngstown Health Department Laboratory in City Hall, 744-8988, or drop us a note in the mail and we will bring you the kit

of supplies to start you upon the program.

In Memoriam

JOHN ALLAN ALTDOERFFER, M.D. 1898 - 1974

Dr. J. Allan Altdoerffer, obstetrician, died at his home in Negley, Ohio.

on Wednesday, Jan. 9th at the age of 75.

Dr. Altdoerffer was born Feb. 17, 1898, in Youngstown. He was graduated from South High School, received his pre-med schooling at Ohio State University and his medical degree at Northwestern University in 1928. He spent the next five years interning in various hospitals in Cook County, Ill., before returning home in 1933. As an intern he was on E.R. duty when Chicago police brought in bodies from the "St. Valentine's Day Massacre."

On the staff at Youngtsown Hospital Association, he was chief of obstetrics at North Side and was a gynecologist as well. He also was chief of staff at the Florence Crittenton Home for some 20 years. He belonged to Phi Rho Sigma Medical Fraternity and to Pi Kappa Alpha and Pi Kappa Epsilon.

both medical honoraries.

The Curbstone Coaches honored him in 1961 for his outstanding achievements in track and field during his scholastic career. As a sports lover he formed a strong friendship with the late Dike Beede and attended all possible YSU sporting events. His autumn vacations were spent at the YSU football training camps at Camp Fitch. He made a practice of following the team on its trips during the football season.

He was a past president of the Four-Square Club and also served as a trustee of the Butler Institute of American Art. He had a strong interest in both Boy and Girl scouting, serving on the Camp Development Committee for the Girl Scouts and as Soil and Water Conservation and Forestry Coun-

sellor for the Boy Scouts.

His interest in forestry began as a youngster and continued throughout his life. Since 1962, he had planted more than 100,000 white pine and Norway spruce on his 100-acre farm here. He also helped to plant 10,000 more trees

at the Girl Scout Camp over the years.

Dr. Altdoerffer was especially proud of the remodeling program that was done in the Maternity Section of Youngstown Hospital, which he said was specifically modernized for the purpose of obstetrics. He established an outstanding record of having delivered more than 7,000 babies.

His contributions to medicine and to the community cannot be surpassed.

His works live after him and he will be long remembered.

MORRIS I. BERKSON, M.D. 1896 - 1974

Dr. Morris Berkson, general practitioner in Youngstown for 45 years, died

at Heritage Manor on Sunday, Jan. 20th, at the age of 77.

Dr. Berkson was born Nov. 19, 1896 in Pittsburgh. He was a 1924 graduate of the University of Maryland, coming to Youngstown in 1925 to open a medical practice at 721 Himrod Ave. His last office was at 630 Gypsy Lane, where he moved in 1968. In 1970, having retired, he was elected to Honorary Membership in the Mahoning County Medical Society.

He was a member of Anshe Emeth Temple, Phi Delta Epsilon Medical Fraternity, B'nai B'rith, Zionist organization of America, and was a charter member of the Jewish War Veterans. He was an Army veteran of World

War I.

Dr. Berkson was on the staff of Youngstown Hospital Association. He will be missed by his patients and his friends.

JOHN U. BUCHANAN, JR., M.D. 1884 - 1973

Dr. John Buchanan, an early general practitioner in Youngstown, died at Clearwater, Florida on Thursday, Dec. 6, 1973, at the age of 89. He had made

his home in Clearwater since 1954.

Dr. Buchanan was born Oct. 9, 1884 in Buchanan, N. Y., a town named for his ancestors. He received his medical degree from the University of Pennsylvania in 1911, and returned to Youngstown to practice, having moved here

from Buchanan in 1905.

Dr. Buchanan was plant physician for Republic Steel Corp. He was a 50-year member of Western Star Lodge 21, F. & A.M., and member of Buechner Council R. & S.M., Youngstown Chapter Royal Arch Masons, St. John's Commandery, Al Koran Shrine, and American Legion Post 7 of Youngstown. In 1963 he was elected to Honorary Membership in the Mahoning County Medical Society. In 1949 he was named to the American College of Surgeons. During World War I, he served as a member of Base Hospital No. 31 in France.

For many years he was the area medical examiner for the U.S. Bureau of Air Commerce and successor agencies, such as the Civil Aviation Administration and Federal Aviation Administration. He examined periodically most of the older pilots as well as applicants for new pilot certificates and was

widely known and highly regarded by this group.

Because of his interest in this field, he later was taught to fly in a small

aircraft, and was probably the area's first "flying doctor."

He gained a reputation for his meticulous examinations of pilots and often commented, "I hope no one ever dies in an air accident resulting from anything I've missed."

With the passing of Dr. Buchanan, the area has lost another pioneer, and

the medical profession has lost a fine physician.

EDGAR C. BAKER, M.D. 1895 - 1973

Dr. Edgar C. Baker, emeritus chief of radiology for Youngstown Hospital Association and one of the pioneers in X-ray here, died on Saturday, Dec. 22,

1973, at the age of 78, at Park Vista Presbyterian Home.

Dr. Baker was born Nov. 20, 1895, in Harrisburg, Penna. He was educated in Philadelphia, where he was valedictorian of his graduating class at Downington High School. Following a B.A. degree at Hiram College, he

earned his medical degree at Western Reserve University in 1921.

He interned at South Side Hospital, went into practice in Cleveland, and returned to Youngstown in 1923 to work with Dr. Sidney M. McCurdy at the Youngstown Sheet and Tube Co. He later was associated with Dr. C. R. Clark, became interested in X-ray and joined Dr. John Heberding full time at South Side.

In 1927, he operated a double fluoroscope while Dr. E. C. Goldcamp re-

moved a tack from a lung—an amazing operation at the time.

Dr. Baker, with the aid of the hospital shop, built a photoflurographic unit before commercial equipment for chest examinations could be obtained.

He helped lead the fight to let people know how to recognize some of the symptoms that might spell cancer. In addition to being first chairman of the Ohio Cancer Society, Dr. Baker served as a trustee on the executive committee and then was made a life trustee. He received the American Cancer Society's Gold Medal Award for organizing the Women's Field Army in Ohio and Youngstown. This was a forerunner of the Ohio Chapter of the ACS.

Hiram College gave him a distinguished service award in 1954 for his X-ray work and the Mahoning County TB and Health Association gave him a plaque for his efforts in fighting TB in 1967. In May, 1964, the Ohio State Radiological Society honored him at a state meeting. He was a founder and

past president of the organization.

Dr. Baker was very active in the Mahoning County Medical Society. He was editor of the *Bulletin* in 1945, a member of council and chairman of a number of committees including the Postgraduate Day Committee, charged with presenting an all-day program for the entire Sixth District.

In 1971 he joined the fifty-year club when the Ohio State Medical Association honored him for 50 years in the practice of medicine with the pre-

sentation of a pin and plaque.

He was past president of the YHA staff and of the Cleveland Radiological Society, a diplomate and fellow of the American Board of Radiology, a member of the American Thoracic Society, American College of Chest Surgeons, Association for the Study of Neo Plastic Diseases, World Photographers Association, World Medical Association, the Welcome Society of Philadelphia and was made president of the Pennsylvania Radiological Society in spite of bylaws that only Pennsylvania practicing physicians could be officers.

He pioneered in a then new field of medicine and both the medical profession and the lay community are better off for his having been among

us.

RESOLUTION DEADLINE SET

Physicians wishing to submit resolutions to the Ohio State Medical Association House of Delegates must have the resolutions at OSMA headquarters no later than March 12th. To be considered, a resolution must be introduced on the floor of the House at the opening meeting, May 12, by a delegate from Mahoning County. The 1974 Annual Meeting of the OSMA will be held at Cleveland.



FORTY YEARS AGO — FEBRUARY 1934

The New Deal was spending a great deal of money to boost employment. The purpose of the National Relief Administration was briefly: Hire more neople and pay them more so they will have money to buy the stuff you make so you can hire more people and pay them more. The present administration is against that. They call it Inflation.

It was the fashion to ridicule some of the projects of the N.R.A. It was said that all the Works Project Administration did was put a shovel in every man's hand. But a great deal of lasting benefit which changed the appearance

of Youngstown was accomplished by the W.P.A.

Federal Street was widened and the old street car tracks removed. If you want to see what Federal Street used to look like go down east of Watt Street.

Market Street and Mahoning Avenue were widened. They used to be narrow streets with street car tracks in the center and trolley wires overhead. Every street car was followed by a long queue of automobiles. It was forbidden to pass a trolley car on the left and impossible on the right if there were automobiles parked at the curb.

THIRTY YEARS AGO — FEBRUARY 1944

It was a hard winter. The 150 doctors here at home were struggling to keep things going. There was much sickness. Other County Medical Societies had simply given up and suspended any pretense of organization activity but Mahoning County never missed a meeting and the BULLETIN appeared every month.

TWENTY YEARS AGO — FEBRUARY 1954

Dr. Henri Schmid said that syphilis was declining but he reported 387 cases treated at the V-D Clinic in 1953 and 362 cases of gonorrhea.

TEN YEARS AGO — FEBRUARY 1964

James Calvin and Robert Jenkins were elected Fellows of American College of Physicians. Robert A. Wiltsie was made Diplomate of the Board of Pediatrics.

PROCEEDINGS OF COUNCIL Jan. 8, 1974

The regular meeting of the council of the Mahoning County Medical Society was held on Tuesday, Jan. 8, 1974, at the Youngstown Club.

A treasurer's report was presented showing a \$307.28 bank deficit as of Dec. 31, 1973, excluding 1974 dues collected during 1973.

Applications were read, as presented by the censors:

ACTIVE — John H. O. Bleacher, M.D.

Narciso Domingo, M.D.

The applications were approved. Applicants will become members of the Mahoning County Medical Society fifteen days after publication in the Bulletin, unless objection is filed in writing with the secretary before that time.

The application of Robert H. Whittlesey, M.D. for associate membership was delayed when it was noted that one of his sponsors was an associate member and that the constitution calls for active members to sign applications

as sponsors.

A thank-you note from Auxiliary president, Mrs. K. F. Wieneke was read. She and Mrs. P. E. Ruth were guests at the December council meeting.

A letter was read from the Mahoning County Welfare Department giving answers to the questions that we asked (see December minutes) concerning their program for "Early Periodic Screening Diagnosis and Treatment" for eligible children. Following lengthy discussion, the motion was made by Dr. Anderson, and properly seconded, that a reply be sent stating that in general we consider this against the best interests of the patient, and enclosing a copy of the welfare resolution passed by the Mahoning County Medical Society at the Sept. 19, 1972, meeting. Motion was passed with stipulation that the letter in its final form be reported to council.

A letter from the Ohio State Medical Association was noted. It stated that the recently passed constitutional amendment had been received and

would be acted upon.

A letter was read from Dr. Meader, who, although dues-exempt, enclosed a check for \$50 which he asked the Medical Society to accept as a dues contribution. The motion was made, seconded and duly passed that the money be accepted with a thank-you note to Dr. Meader.

An article entitled, "If They Won't Renew Your Malpractice Umbrella," from Medical Economics, was submitted by Dr. F. A. Schellhase, with the request that Council be made aware of this problem. The article was referred

to Dr. Abdu for a report.

A request was reported from Paul Kline, Health Educator for the Youngstown Health Department for a medical advisory committee for the health screening bus. Dr. Melnick appointed Dr. Mahar, Jr. and Dr. Pichette to the committee.

A letter from the Northeastern Ohio Health Care Foundation (HMO) enclosing resumes from 36 physicians seeking to relocate was filed. The names are from the placement bureaus of the Ohio State Medical Association

and the American Association of Medical Clinics.

The motion was made by Dr. Abdu, and properly seconded, that a letter be sent to the Board of Trustees and the Executive Committee of both hospitals asking them to send us in writing their views and the attiude of the hospital toward the HMO concept with the statement that the information is needed by us in order to formulate the stand to be taken by the Mahoning County Medical Society. Motion was passed.

Dr. Tandatnick, chairman, reported for the constitution committee. It was noted that a constitutional amendment requiring attendance at council was not needed inasmuch as the constitution provides that council may "declare vacant any office, elective or appointive, in the event the incumbent thereof shall fail to perform the duties of his office in a manner satisfactory to the Council." A motion relating to delegate attendance at OSMA meetings

and council meetings was referred to the Constitution Committee.

Dr. Melnick introduced discussion concerning the Physician's Family Welfare Fund, which is supported by an annual \$5.00 assessment per member. Dr. Melnick appointed Dr. Pichette, Dr. Abdu and himself (the Board of Censors) to be the committee to administer the Fund. Any inquiries are to be addressed to this committee.

Dr. Sovik reported that he had been named chairman of the OSMA committee on Health Man-power. He explained that this committee was concerned with primary physicians' assistants, and that he would keep council

informed of committee progress.

Dr. Tandatnick noted that alternate delegates are expected to vote in the place of absent delegates at any meeting. He referred to a Sixth District meeting misunderstanding last year where delegates only were included in a

vote

Dr. Pichette announced that the Medical Society has nine copies of the book, "Case for American Medicine," by Harry Schwartz. The motion was made by Dr. Abdu, and properly seconded, that we purchase enough books to give one to every hospital trustee and put one in each hospital library. Motion was passed.

Dr. Melnick reported on the number of reservations for the Annual Banquet. He noted that every council member must be there to be installed.

Additional reservations were made by council members present.

Dr. Melnick brought to council's attention an instance were an industry is questioning a physician's fee and another instance where an insurance company is asking for review through the OSMA. The council restated that policy of accepting complaints from patients through the Grievance Committee, but not doing review for a third party.

Meeting was adjourned.


