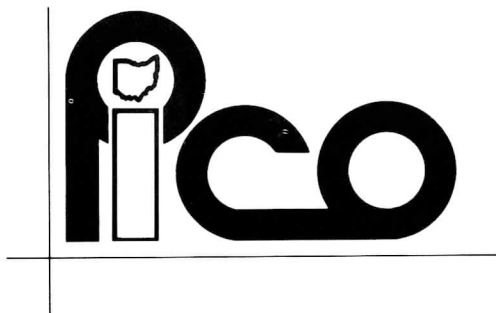

## Editorial

Recently it was called to my attention that a legal donnybrook involving several physicians had taken place in a nearby community. The conflict had its origin in the so-called "residence clause" and specifically involved the dissolution of a medical group and the legal rights of one of its members to re-establish practice in the same community after separating from his previous partners. The issue was resolved in a local courtroom, but the decision was ultimately appealed to a higher court and at this time the problem remains unresolved as it passes through the judicial system. In the process, the problem has received wide local publicity, and public emotion ran high as claims and counter-claims from all parties involved received significant attention.

As one read the press accounts, as well as the letters to the Editor regarding this problem, one could not help but feel remorse in observing competent practicing physicians damaging one another's reputation in the public eye. While the economic factors involved in this case were only a small part of the entire issue, to the public this appeared to be the major issue involved in the legal battle.

It is indeed unfortunate, at a time when public disdain and distrust of physicians runs rampant, that we see medical practitioners battling one another publicly over the right of an individual to practice in the area of his choosing. Such arguments are petty and, when given wide publicity, only tend to undermine the confidence which the public has in the medical profession. While much of the unfavorable publicity regarding physicians is unfair, we as physicians must bear the responsibility for publicity such as this, and do our level best to avoid such unnecessary internal conflict.

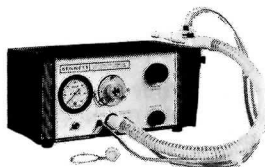

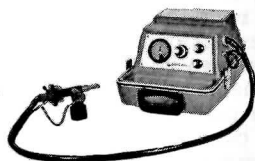

### HERMAN H. IPP

1910 - 1977

Dr. Herman H. Ipp, 67, died on Wednesday, August 25 at Miami Beach following a brief illness.

Dr. Ipp was born in Youngstown, where he attended school and was graduated from The Rayen School in 1928. He received his B.A. degree from Ohio State University in 1932, and his M.D. degree from the same school in 1935.

He practiced in Youngstown from 1937 until 1970, specializing in internal medicine and cardiovascular diseases. Upon leaving Youngstown, he continued his practice in Miami.

Dr. Ipp served in the Army Air Force in World War II and earned two battle stars.

He was president of the Mahoning County Chapter of the American Academy of General Practice in 1955. He was a fellow of the American College of Angiology, the American College of Cardiology and the American College of Internal Medicine. He was a member of the American Heart Association, the American Diabetes Association, Alpha Omega Alpha and Phi Delta Epsilon medical fraternities, and was a member of Rodef Sholom Temple.

## PROCEEDINGS OF COUNCIL

(Excerpts from the June 14 and Aug. 2 meetings)

Dr. Anderson called attention to the results of the Generic Drug Substitution poll, which was printed in the June *Bulletin*. He announced that he had presented the poll results in his testimony before the House Judiciary Committee in Columbus.

Dr. Abdu, insurance chairman, reported that the dental coverage offered to the Physicians' Hospitalization Group had been rejected by group members by a vote of 95 to 56.

Dr. Lambert, treasurer, reported that the Massachusetts Investors Growth Fund investment had been terminated and the money placed in the general fund for current expenses.

Dr. Anderson reported that he attended the testimonial dinner for Dr. B. B. Burrowes and presented the plaque that Council had approved.

A motion was made by Dr. Abdu that the president appoint a Physician Effectiveness Committee to work with the Ohio State Medical Association physician effectiveness program.

Dr. Anderson reported that the liaison committee met with the committee from the Health Systems Agency on June 23.

A letter was read from Dr. Pass, blood bank committee chairman, in which he explained the changes in the blood bank situation for this area.

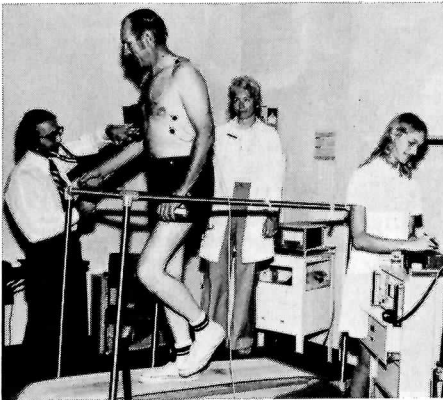
Council agreed to a joint meeting with the Trumbull County Medical Society. However this was later cancelled when the Trumbull Society was unable to obtain their desired speaker.

## From the Bulletin

### FORTY YEARS AGO — SEPTEMBER 1937

The new Constitution and By-Laws were approved and ready for distribution.

L. J. Karnosh from Cleveland addressed the Society on "Three Mile-Posts of Modern Psychiatry": 1. Fever therapy, 2. Vitamin therapy in deficiency diseases and 3. Insulin shock from dementia praecox.

President Fuzy was trying to organize a Bowling League.

Thompson with his new Packard Invalid Coach, Humphrey Drug Company (the oldest drug store on the Square) with Ben Kelley back of the counter. The Central Square Garage, Antiphlogistine for salpingitis, The Scott Company on Phelps St. with the latest in men's shirts and cravats. Cross Drugs, Soricin for irritable colon, the Allergy Research Institute face mask for hay fever, Paul Schmidt the florist, Treudley's office supplies, James and Weaver on Wood St., Lewis Surgical Appliance Co. in the Bus Arcade and Jones Laboratories in Cleveland.

### THIRTY YEARS AGO — SEPTEMBER 1947

There was much in the *Bulletin* that month about the new Board of Health and Health Commissioner but it failed to materialize. It never even got on the ballot.

At the Youngstown Hospital Fred Schlecht was resident in Surgery. Dean Stillson was resident in Medicine, Edward A. Shorten was resident in Proctology and S. G. Patton resident in Pathology. Internes were: Don Covert, William Gross, John Guju and Louis Loria.

### TWENTY YEARS AGO — SEPTEMBER 1957

There was much discussion of Social Security for doctors and polls were being taken. Editor Pichette urged us to acquaint ourselves with the facts so that we could make a judicious decision when the time came. When the time came, the decision was made for us.

There was much concern about the pandemic of Asian type influenza and a new vaccine was prepared for the supply was very limited.

The AFL-CIO warned "medical power groups", "fee-minded physicians" and "monopolistic elements of organized medicine" that they had better go along with union labor medical programs, or else.

### TEN YEARS AGO — SEPTEMBER 1967

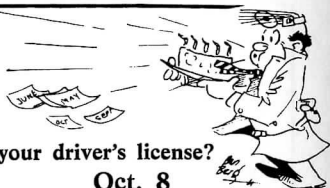
President Harold Reese was concerned about the fact that our local area boys and girls who graduate from Medical School were not returning to their home town for internship or to practice medicine, thus leaving a shortage of practicing physicians in our area.

Editor Eli Saadi came up with a formula that INF (Inflation) plus BMC (Better Medical Care) equals \$MC (Increased Medical Costs). The Wall Street Journal predicted accurately that hospital costs in big city hospitals would reach \$100.00 per day by 1970. And that was before everybody had to have a "cat" scanner.

Dr. John McCann was appointed as first chairman of the board of the new Youngstown State University. Dr. Wm. H. Bunn, Jr. was named Chief of Medicine at the Youngstown Hospital Association, succeeding Dr. Fred S. Coombs. Dr. Paxton Jones was named Chief of Obstetrics at YHA. Dr. Arnoldus Goudsmit left Youngstown to become Chief of the Division of Oncology at the V. A. Hospital in Dearborn, Michigan.

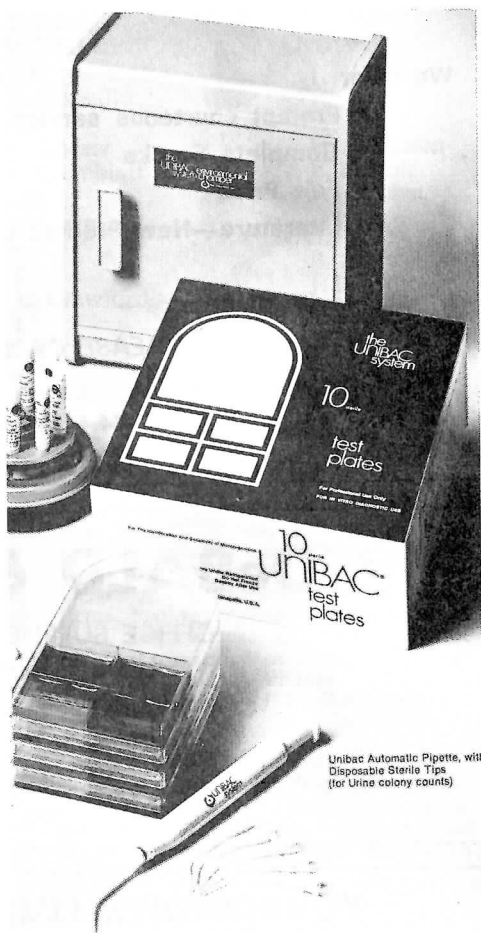

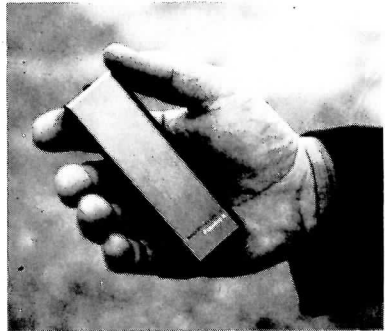
