Ranksta' Rap

I'm not much for watching game shows, but of those I've seen on occasion the one that bothers me most is Family Feud. In case you've been blessed and never seen it, its idea is based on contestants' guessing responses to surveys by a population at large, on all sorts of meaningless things. The game requires no knowledge, no intellect, and contains no facts – just percentages of responses, given by people who know nothing, but do have opinions apparently.

I was reminded of this premise the other day as I saw the annual US News issue ranking the "Top 100" colleges and universities in the country. As many of you have done or are doing, my wife and I are shopping higher education for our oldest child, and it seems impossible to avoid the ranking hysteria. Top 100, top 361, most competitive, best/worst food, most/least parties, most selective, and on and on the ranksters' surveys say, using predominantly polling data reflecting little more than opinion of those people chosen to be asked.

A number of colleges have opted out of this process, feeling that such an approach to college selection distorts the perception of education, substituting popularity and reputation gleaned from surveys for what should be a highly individual decision based instead on what is right for any one student – the so-called "best fit."

Such an approach has also been applied to hospitals, as we know, and the same magazine puts out its annual list of the "Top 100", invariably led by the Mayo, Cleveland Clinic, and the usual university suspects. These rankings too are primarily a result of surveys of people's opinion, which is nothing more than a self-propagating popularity contest.

Why do we care what they say? Who they? Such rankings are simple to produce and require little actual investigation of the facts, and meaningful facts themselves are hard to identify. Furthermore, our culture is a competitive one which puts a premium on being "first / best" even if only in a matter of opinion, which is probably as good as it gets since it is impossible to truly objectify the quality of such things as education or health care beyond such gross parameters as graduation or mortality rates, respectively.

A person's choice of health care, like education, should be individual and based upon a best-fit relationship. Most important considerations should be centered on trust and knowledge of each other by patient and physician, convenience of and access to consistent, reliable services, responsibility for care and follow up, and comprehensive assessment and treatment, all of which is easily had in one's own community in the vast majority of situations. While important, these concepts don't lend themselves well to surveys, and having all these qualities doesn't stand up against headlines in newspapers and magazines. We are unfortunately becoming victims of a push for objectification of what we do – what used to be a profession but is becoming more of a commodity every day, which trend is only enhanced by participation in the nonsense of ranking exercises. I say save the surveys for game shows and leave the health care to us.

Tamper-Proof Prescription Requirement for Medicaid Patients Gets Six-Month Reprieve

A federal requirement due to go into effect on October 1, 2007 that Medicaid prescriptions be on tamper-proof prescription pads has received a sixmonth delay to help physicians, pharmacists and patients better prepare for implementation. Both the OSMA and the AMA had pressed for the delay in implementation. The new effective date for implementation is April 1, 2008.

OSMA-Backed Healthcare Simplification Act Passes Ohio House

The Ohio House of Representatives passed, by a vote of 91-5, House Bill 125 - the Healthcare Simplification Act, which was spearheaded by the Ohio State Medical Association. The bill is designed to provide remedies for many of the excessive administrative demands faced by doctors in their interactions with health plans.

The bill is composed of four common-sense reforms that bring more balance, uniformity and clarity to interactions between physicians and HMOs. It will bring transparency to the contracting process, fairness in contracting, a standardized and time-efficient credentialing process, and web-based insurance eligibility verification.

"This legislation will help eliminate bureaucratic, unfair and anti-competitive practices imposed on physicians by Ohio's HMOs and other health insurers," said Craig W. Anderson, MD, OSMA president and a Columbus neonatologist. "By getting rid of some of the bureaucracy in our healthcare system, we can get physicians back to what they do best - taking care of patients."

Since the introduction of HB 125 in March, there have been 12 committee hearings where more than 32 different witnesses have offered proponent, opponent and interested party testimony.

The OSMA has been working over the past year to pursue legislative remedies to problems that Ohio's physicians and patients have been encountering when dealing with Ohio's HMOs and other health insurers.

"The passage of the bill in the Ohio House of Representatives is great progress," added Dr. Anderson. "We hope that the Ohio Senate will follow suit so that we put patients first ahead of paperwork."

DR. RAYMOND DUFFETT NAMED 2007 OUTSTANDING TEAM PHYSICIAN

Raymond Duffett, MD, was named one of the Outstanding Team Physicians for 2007 by Joint Advisory Committee on Sports Medicine of the Ohio State Medical Association, the Ohio High School Athletic Association, and the Ohio Athletic Trainers Association. Dr. Duffett has served as team physician for Shaker Heights High School while an orthopaedic surgical resident, at Amelia High School during his Sports Medicine fellowship at Christ Hospital in Cincinnati, and at Austintown Fitch High School upon returning to Youngstown to practice. He currently serves as team physician for Youngstown State University. Dr. Duffett was nominated for the award by the Council of the Mahoning County Medical Society, on which he serves as an Alternate Delegate. Letters of support for his nomination were submitted by former Fitch athletic director Gene Chepke, and YSU Executive Director of Athletics, Ron Strollo. Dr. Duffett was recognized between quarters at the September 22nd YSU game.

OSMA Physician Victorious Against Frivolous Lawsuit

OSMA member Michael Banks, MD, will finally receive his court-ordered payment from a plaintiff's trial lawyer. The order to pay Dr. Banks became final when the Ohio Supreme Court refused to accept the appeal of the plaintiff's trial lawyer. The lawyer had challenged the award of sanctions to Dr. Banks, a Cleveland-area orthopedic surgeon. The OSMA Frivolous Lawsuit Committee and the Litigation Center of the AMA and the State Medical Societies submitted a friend of the court brief in the case on Dr. Banks' behalf. The case unfolded as follows. In October 2004. a Motion for Sanctions requesting \$23,000 was filed on Dr. Banks' behalf. This \$23,000 figure was based upon the facts of the case, the fact that the increase in the doctor's insurance rates was solely due to the pending suit, and Dr. Banks' legal expenses. On Thursday, May 11, 2006, the Cuyahoga County Court of Common Pleas awarded Dr. Banks \$4,500 personally against the lawyer in his case. The lawyer then filed an appeal with the Eighth District Court of Appeals. On May 3, 2007, the appellate court unanimously ruled that the trial court was correct in awarding Dr. Banks sanctions. However, the lawyer then appealed to the Ohio Supreme Court. The Supreme Court declined to take the case and dismissed the trial attorney's appeal. By doing this, the sanctions award was upheld and this case has reached its final conclusion. "I think that lawyers who bring and then pursue a frivolous lawsuit should pay a price. My time and my money are just as valuable as a lawyer's time and money. It is only when physicians stand up for their rights that we can expect the system to change," said Dr. Banks. "It's significant that the courts did not ignore the egregious behavior of the trial lawyer in this case. The decision lets Ohio physicians know that they have recourse in the courts when a plaintiff's lawyer engages in frivolous conduct," said OSMA General Counsel Almeta E. Cooper.
