YOUNGSTOWN, Ohio - Young Ohioans who attend or plan to attend Youngstown State University or some other state-related university will be penalized if they haven't registered with the U.S. Selective Service System.

Under a law recently approved by the Ohio Legislature, men between 18 and 26 who do not file a completed "Statement of Selective Service Status" form with YSU will be charged the nonresident tuition surcharge of \$350 per quarter even though they are Ohio residents.

The new law requires the student to indicate on a form provided by the University that he has registered with Selective Service or that he is exempt from registering. Males who have registered are also required to indicate their Selective Service number on the form.

Federal law requires all men between 18 and 26 to register with Selective Service unless they are on active duty in the Armed Forces or are aliens.

In addition to the nonresident fee, the Ohio Board of Regents has announced Ohio student financial aid will be withheld from men who are required to be registered with Selective Service but who have failed to do so.

Since Fall Quarter registration is already under way, the penalties will not apply until Winter Quarter, which begins Jan. 5.

However, James E. McCollum of YSU, assistant to the president for legislative relations, urged men who haven't registered with Selective Service to do so
