## IV. Report of the President of the University

President Tressel, noting that the Spring Semester is coming to a close, thanked faculty for their work and thanked students for their patience and hard work. He said the university will hold in-person commencements on Friday and Saturday, May 7 and 8, in Stambaugh Auditorium, for both the class of 2020 and the Spring class of 2021. He said the new Excellence Training Center is being finalized, announced that the women's golf team won the Horizon League crown, and noted the recent Student Awards program, college convocations and the annual student fashion show held at the downtown amphitheater.

Chair Hackstedde noted that the **University Affairs Committee** recommends one resolutions for adoption by the board:

# a. RESOLUTION TO SUPPORT A FACULTY VOLUNTARY SEPARATION/RETIREMENT PROGRAM

WHEREAS, Youngstown State University has undertaken the Academic Program Enhancement and Effectiveness Initiative as a component of the Plan for Strategic Actions to Take Charge of Our Future to optimize the portfolio of academic programs and to gain appropriate curricular efficiencies; and

**WHEREAS,** a compliment to this process includes optimizing the instructional/academic needs of the university; and

**WHEREAS,** YSU-OEA leadership proposed to Administration the development of a program whereby faculty would be given the opportunity to separate from the University and receive an incentive; and

**WHEREAS,** the Administration and YSU-OEA leadership collaborated in developing a possible Voluntary Separation/Retirement Program.

**NOW THEREFORE, BE IT RESOLVED,** that the President and President's designees have the authority to sign any documents relating to a Voluntary Separation/Retirement Program; and

**BE IT FURTHER RESOLVED,** that the University shall make cash payments for the sole purpose of a one-time offer to participants under a Voluntary Separation/Retirement Program; and

**BE IT FURTHER RESOLVED,** the Board of Trustees authorizes the President and designees, with respect to a Program, to take any and all actions necessary or desirable to implement, maintain, and administer such a Program.
