The dream of Youngstown State University students for more than a decade is about to become reality. A campaign to secure funding for a student Recreation & Wellness Center was initiated in January 2002. Thanks to the leadership and generosity of area individuals, foundations, and corporations, the campaign has raised over 94% of the \$12.1 million goal to date. A \$600,000 challenge grant from The Kresge Foundation, a private, national foundation, has now positioned us to complete the final phase of our campaign. At this writing, YSU must raise \$700,000 to meet the Kresge Challenge and has established June 30, 2004 as the target date for completion of the campaign.
