RESOLVED, that Paragraphs I and IV of the Regulations and By-Laws of The Youngstown College be and they are hereby amended so that, as amended, they shall read as follows:

- I. Annual meeting. The annual meeting of the Trustees of the corporation for the election of Trustees and Officers and the transaction of such other business as may come lawfully before the meeting shall be held on a day in Farch of each year, the day to be fixed by the Chairman of the Board of Trustees and the President of the college.
- IV. Meetings of the Trustees. Three regular meetings of the Board of Trustees shall be held annually, such meetings to be in March, in May or June, and in October of each year on dates to be fixed by the Chairman of the Board of Trustees and the President of the college.

Special meetings of the Board of Trustees may be held on the call of the Chairman of the Board or five of the trustees. At least three days previous to a meeting of the board, written notice shall be mailed or delivered to each member thereof.

\* \* \* \* \* \* \* \*

As now in effect, Paragraphs I and IV provide as follows:

1. The annual meeting of the trustees of the corporation for the election of officers and the transaction of such other business as may be lawfully before the meeting shall be held on the third Fonday of March of each year.

IV Regular meetings of the Board of Trustees shall be held on the third Monday of March and the first Monday of June and the third Monday of October of each year. Special meetings of the Board of Trustees may be held on the call of the Chairman of the Board or of five of the Trustees. At least three days previous to a meeting of the Board written notice shall be mailed or delivered to each member thereof.
