I. Aims of Research

My aim is to participate in a cooperative venture in which I would be the co-author of a book entitled: Hungary in the Late Middle Ages, 1386-1526. The other author is Prof. Joseph Held, Associate Dean, Rutgers University. (See attached letter with outline describing the areas covered by each contributor.) Both Prof. Held and I have spent extended time in Europe doing research in the archival sources pertinent to our project. Our objective is to produce a book of about 180-200 pages which could be used as a text in University courses dealing with East Central Europe. At this time there is nothing available in English which covers this phase of history and thus our work would be able to fill a major need. Chronologically the period which would be covered by me would be the political history of Hungary from 1458 to 1526, as well as the intellectual and artistic developments from 1386 to 1526, i.e. the flowering of Late Medieval culture and the beginnings of the Renaissance in Hungary.

II. Background of Information.

The need for a scholarly study dealing with the Late Middle Ages in Hungary in a western language has been recognized for some time. In response to this need, Prof. C. A. Macartney of Cambridge University wrote his study The Magyars in the Ninth Century.

Cambridge University Press, 1930. A few years later Dr. B. Homan of the University of Budapest wrote his classic Geschichte des ungarischen Mittelalters, Vol. I-II, Berlin, 1943. These volumes cover the history of Hungary up to the fourteenth century. The book Dr. Held and I are writing would in essence complement as well as continue the work of Macartney and Homan and would carry

the events up to 1526, the date which marks the destruction of the Hungarian state by the Ottoman Turks.

In October of 1981, Prof. Held and I met at a historical conference and finalized plans for writing the volume. (See attached letter). The Coordinator of the project will be Dr. J. Bak, Professor of History, University of British Columbia, Vancouver Canada. Since the inception of the plan we have frequently consulted with each other and Prof. Held has contacted several major academic publishers who seem interested in the project.

III. Current efforts on project.

At the present I am in the process of finishing a major monograph of about 600 typed pages entitled: The Renaissance in Fifteenth Century Hungary: Political and Cultural History in the Age of Matthias Corvinus. (Completion date September 1982. This volume, which has been accepted for publication, covers the period 1450 to 1490. It is aimed at a highly specialized audience, has extensive critical apparatus and bibliography.

One of the major tasks in writing my section of the volume Hungary in the Late Middle Ages would be to summarize and synthesize the material presented in the above mentioned monograph, making it available to a non specialist reading audience since the projected volume is intended as a college text.

The period 1458-1490 has been my area of research for the last fifteen years. I have read numerous papers and published articles dealing with the political and cultural history of Hungary during this period.

IV. Project Plan.

All archival research in the major primary sources for the project has been done. Six months spent in Europe in 1979 enabled me to lay the groundwork for this undertaking.

There are three phases of work which I plan to follow:

- Political history of the period 1458-1490.
 Using my monograph Renaissance in Fifteenth Century
 Hungary as the basis, I would be able to complete this phase of my work quite quickly.
- Political history of the period 1490 to 1526.
 Primary sources and archival material have been consulted. Secondary sources are either in my possession or are accessible through Inter-library Loan. This second phase would require the most of my time.
- 3. Cultural history 1386-1526.
 Most of my publications have been in the history of intellectual currents and cultural growth. I am very much at home with the material and therefore writing this phase of the volume would not require excessive amount of new research.

All these projections are based upon the assumption that a Research Professorship would enable me to devote major blocks of time to this project during the 1982-1983 academic year. I need time!
