Pursuant to a call by the President, dated October 22, 1986, and to Notices sent by the Secretary of the Board by certified mail on October 27, 1986 to each Trustee, copies of which precede these Minutes (with copies to the President of the University, the President of the YSU Chapter of the OEA, to Alan R. Kretzer, Special Counsel appointed by the Attorney General of Ohio, and to the Executive Director of YSU Alumni Association) a special meeting (one-hundred and fourteenth) of the Board of Trustees of Youngstown State University convened at 4:00 p.m., Friday, November 7, 1986 in the Board Room in the Tod Administration Building.

Eight Trustees were present at the meeting, to wit: Earl W. Brauninger, Mrs. Elizabeth C. DeLuca, Paul M. Dutton, Dr. John F. Geletka, Mrs. Emily P. Mackall, Michael I. Monus, Dr. Earnest Perry and Frank C. Watson. William J. Lyden was absent.

Also present were Dr. Neil D. Humphrey, President, Dr. Bernard T. Gillis, Provost, Alan R. Kretzer, Special Counsel to the Attorney General of Ohio, Franklin S. Bennett, Secretary to the Board of Trustees, and Patricia D. Martin, Secretary to the President. Also present were approximately 30 other persons, including deans, members of the faculty, and members of the news media.

Paul M. Dutton, Chairman of the Board, presided.

ITEM I - Proof of Notice of Meeting

An Affidavit of the Secretary of the Board was available, with official post office forms attached, which showed that copies of the President's call of the special meeting dated October 22, 1986 and the Secretary's Notice of the meeting

dated October 27, 1986 were mailed by certified mail to each Trustee and the President on October 27, 1986 and by regular mail to the President of the YSU Chapter of OEA, Attorney Alan R. Kretzer, and to the Executive Director of the Alumni Association.

ITEM II - Minutes of Meeting Held on September 26, 1986

Chairman Dutton announced that the minutes of the meeting of September 26, 1986, would be considered at the next regular meeting of the Board on December 19, 1986.

ITEM III - Recommendations of the President of the University

Dr. Humphrey stated that he had no recommendations.

ITEM IV - Report of the President of The University

Dr. Humphrey stated that he had no report.

EXECUTIVE SESSION

The Trustees retired into Executive Session at 4:10 p.m. for about twenty minutes, after a Motion duly made by Mr. Watson, seconded by Mr. Brauninger and carried for the purpose of discussing matters pertaining to the disposition of a unique gift made to the University by Dr. John J. McDonough before returning to the open meeting in the Board Room.

ITEM V - Reports of the Committees of the Board

1. Public Services

Dr. Perry reported that the Public Services Committee was recommending two Resolutions for adoption by the Board. He then read and moved for adoption the following Resolution:

a. Resolution Concerning a Gift to the University

WHEREAS, John J. McDonough, M.D.,

has offered to give the University the
painting entitled "Antoinette at Her
Dressing Table," painted by Mary Cassatt,
which has an estimated value in excess of
one million dollars and which is presently
located in New York City;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Youngstown State University does hereby accept this gift with pleasure and sincere appreciation.

BE, IT FURTHER RESOLVED, that:

- 1) The President of the University is directed to sell this painting utilizing the Coe Kerr Galleries of New York City as agent;
- 2) Dr. McDonough be invited to counsel with the President concerning appropriate procedures to insure early sale of the painting at market value;
- 3) The proceeds of the sale of the painting be used to design, construct and equip a museum of art on campus and that such facility be known as the John J. McDonough Museum of Art;
- 4) The Building and Property Committee report back to the Board at the December, 1986 meeting concerning a proposed location for the museum and progress in selection of an architect;
- 5) The administration is directed to make appropriate plans for the operation of the museum utilizing personnel of Kilcawley Center and the College of Fine and Performing Arts and scheduling the closing of the present art gallery in Kilcawley Center thereby releasing that space for other use appropriate to the student center; and
- 6) The administration is directed to consult with officials of the Butler Institute of American Art, the Mahoning Valley Historical Society which operates the Arms Museum, and the Ohio Historical Society which will operate the Industrial History Museum, in an attempt to further strengthen the cooperation among the four institutions and to assure the maximum educational and public service impact of the John J. McDonough Museum of Art.

The Motion was seconded by Mr. Brauninger and, after discussion, received the affirmative vote of all Trustees present. The Chairman declared the Motion carried and the Resolution adopted.

Dr. Humphrey stated that the gift from Dr. McDonough was the largest gift offered Youngstown State University and he joined Chairman Dutton in expressing appreciation to Dr. McDonough for his generosity.

Dr. Perry next read and moved for adoption the following Resolution:

b. Resolution Concerning a Gift of Land

WHEREAS, Joseph Goldberg and Norman YR 1987-29 B. Goldberg of Canoga Park, California, former residents of Youngstown and former students of Youngstown University, have offered Youngstown State University a gift of seven lots on Madison Avenue (approximately 350' x 175') and one lot on Custer Avenue (approximately 40' x 107') which is adjacent to the Madison Avenue property.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Youngstown State University does hereby accept this offered gift of land and expresses its appreciation to Joseph and Norman Goldberg.

The Motion was seconded by Dr. Geletka and, after discussion, received the affirmative vote of all Trustees present. The Chairman declared the Motion carried and the Resolution adopted.

2. Personnel Relations

Mr. Brauninger reported that the Personnel Relations Committee had a matter relating to the employment of personnel and wished to have the Trustees retire again into Executive Session.

Before acting upon Mr. Brauninger's request, Chairman Dutton asked the Secretary if there were any communications or memorials. No communications or memorials were presented.

There being no unfinished business or new business the Trustees retired into Executive Session at 4:30 p.m. for

about fifteen minutes, after a Motion duly made by Mr. Brauninger, seconded by Dr. Perry and carried for the purpose of considering matters relating to the employment of personnel before returning to the open meeting in the Board Room.

The meeting was duly adjourned at 4:45 p.m.
