

MINUTES OF SPECIAL MEETING
OF
BOARD OF TRUSTEES
OF
YOUNGSTOWN STATE UNIVERSITY

Kilcawley Center
January 26, 2000

Pursuant to call of the chairperson, and notice duly given, a special meeting (the two hundred fifth) of the Board of Trustees of Youngstown State University convened at 6:00 P.M., Wednesday, January 26, 2000 in the Coffelt Room in Kilcawley Center.

All nine trustees were present at the meeting, to-wit: Mr. Bruce R. Beeghly, chairperson of the board, who presided, Dr. Y. T. Chiu, Mrs. Ruth Z. Wilkes, Mrs. Eugenia C. Atkinson (who arrived at 6:15 p.m.), Mr. Joseph S. Nohra, Dr. Chander M. Kohli, Mr. Larry E. Esterly, Mr. Charles B. Cushwa III (who arrived at 6:20 p.m.), and Mr. F. W. Knecht III. Also present was student trustee Ms. Carrie A. Wilson.

Also present were Dr. James J. Scanlon and Franklin S. Bennett, Jr., secretary to the board.

The chairperson called the meeting to order.

ITEM I - PROOF OF NOTICE OF MEETING.

Evidence was available to establish that pursuant to Article II, Section 2, of the board's Bylaws; written notice of the call for today's special meeting was timely provided to each of the nine trustees, the student trustee, and to the president. The purpose of the meeting was to meet with Dr. James J. Scanlon, a candidate for President of Youngstown State University.

ITEM II - EXECUTIVE SESSION.

The chairperson recognized Dr. Kohli who moved that the board of trustees enter executive session to consider matters pertaining to the appointment of a successor to Dr. Cochran as President of Youngstown State University. The motion was seconded by Mr. Esterly. The chairperson asked the secretary to the board to conduct a roll call vote on the motion to enter executive session, the results of which are as follows (YES is a vote in favor of the motion):
