Dear Mr. Amon:

I have your communication of October 17 in which you advise that Dr. Beane moved to Hamilton, Ohio, and that you cannot get a reply to any of your letters to him.

As you know, at the hearing at which this doctor was discussed you were advised of the importance of this physician's evidence and it is apparent that the statement that you had with you would be of no value to you because it was not under his signature. I would suggest that you address a communication to the Commander of the American Legion, Hamilton, Ohio, requesting that he advise you whether Dr. H. Beane is residing in Hamilton, Ohio, and whether his condition is such that he could be called upon to execute an affidavit in your behalf, and if so, if you cannot yourself go to Hamilton, you might give the Commander full facts which would enable him to contact this physician and secure the necessary affidavit for you.

Should this physician have passed away, it is also necessary that the Veterans' Administration be advised so that the rating board can then proceed with the case with the definite knowledge that further evidence cannot be secured from Dr. Beane. It is necessary for us to dispose of this issue one way or the other inasmuch as this is holding up your case at this time.
