percenter 51, 1873, is accepted as the date of the veteran's birth unless he is able to establish an earlier date. Accordingly, the veteran is not at this time entitled to an automatic increase of pension under the provisions of Public 561, Act of May 24, 1938.

The veteran in his first declaration for pension stated that he was born January 5, 1866. In a supplemental declaration for increase of pension he makes affidavit to the effect that he was born December 31, 1873. In view of the above mentioned discrepancies in the evidence furnished by the veteran relative to the date of his birth, he should forward to this office, if obtainable, a certified copy of the public or shurch record of his birth over the eath or seal of the custodian of such records.
