## From the President's Desk

When I realize that this is the Spring issue of **Guidelines**, I warm to the thought that we will soon be enjoying the sights of blossoming flowers and new life everywhere in nature. Perhaps you will share with me the joyous expectation that comes from saying "good-bye" to winter's blast and "hello" to springtime. I'm made ever more aware that all things do change. And OCA is on the threshold of a significant change!

The Executive Council of OCA has deliberated over the past several months on the question: **Should**

**OCA maintain the services of a legislative lobbyist?** OCA signed a twelve month contract with a lobbyist in January, 1995, at a rate of \$1500 per month. That contract expired at the end of December, but the Executive Council extended the contract by one month so that a decision could be made in the January meeting as to whether to continue the relationship. Much discussion was generated both pro and con.

There was no question that OCA desired to be able to maintain a lobbyist, given legislative concerns and the needs of the profession. The pertinent question was: **How can OCA afford the cost?** Current revenues are not sufficient in themselves to include a budgetary line item in the amount needed. Accordingly, the discussion boiled down to alternatives which might provide the necessary monies. None of the alternatives were without pain.

Because the budget for the current fiscal year does not contain monies to support the lobbyist beyond January, chapters and divisions voted their confidence by contributing several thousands of dollars. This support can only carry OCA through June of this year,

however. This type of financing could not be expected to continue past June, as it places inordinate strain on the financial resources of the divisions and chapters.

The alternative deemed most reasonable by the Executive Council was to fund the lobbyist through an increase in annual dues, commencing at the beginning of the new fiscal year, July 1, 1996. After much discussion, the following dues structure was adopted:

<b>Professional/Associate</b>	<b>\$70.00</b>
<b>Retired</b>	<b>\$27.50</b>
<b>Student</b>	<b>\$18.75</b>

Dues increases are regarded with fear and trembling by any organization. The potential for members to vote their disapproval by nonrenewing is daunting. The Executive Council has expressed its confidence that its constituent members will not react to the dues increase in such a manner, but will rally to support this action.

We believe the decision has been made in the interest of advancing the state of professional counselors throughout Ohio. We seek your strong support as we contemplate the movement OCA will make in the coming year as a consequence.

## Ethics and Diagnosis

There are serious ethical issues being raised by the increased influence of insurance companies in the mental health field. Practitioners need to constantly be aware of their primary ethical responsibilities to the client and be certain to act in a manner that is in the best interest of the client. It was recently reported in a counselor education class that a counselor working in an agency was told to "find a diagnosis that the insurance company will cover".

Some questions that need to be pondered in this day of "find a diagnosis the insurance company will cover" are listed below. All responsible counselors need to consider these questions.

Is this a true diagnosis or is it the one for which the insurance company will pay?

What impact will this diagnosis have on this client in the future? Medical records from insurance companies are not always kept confidential.

Will this diagnosis keep my client from ever holding office, getting a job, or being accepted in a graduate program?

Am I meeting the needs of my bank balance or the agency for which I work rather than the needs of my client?

Sometimes an incorrect diagnosis is made so that the real issue can be treated, because if the insurance did not cover the treatment, the client would not come. This is a very caring attitude, but the ethical ramifications still need to be considered.

At best, it is often difficult to arrive at a correct diagnosis, and at the worst, it can be permanently damaging to the client if incorrect. The incorrectness of the diagnosis creates some serious ethical issues when the primary motivating factor is whether the insurance will cover.

There are no easy answers to these questions. As in all ethical dilemmas, issues may be quite unclear. BUT professional counselors need to be aware of these issues and have dialogue with their colleagues about them.

### OMHCA

Martin Williams began the year as President of OMHCA. Due to health concerns, he resigned. A meeting of members of the OMHCA board followed the OCA Executive Council meeting of January 20. Issues discussed included SB 223, which would amend the present licensure law. Hearings on the bill are expected before the end of February. The bill would increase educational requirements to CACREP standards while making LPCs license eligible immediately upon graduation. It would make operational changes as well within the board designed to increase effectiveness of the board in regulating counseling and social work. ### SWOCA

SWOCA continues to strive to identify its role and find its appropriate niche in the counseling field. Struck by the characteristic that this may be the best of times and the worst of times for counselors and in attempting to find the appropriate placement for counselors under the current mental

health changes and push for affiliation with various mental health units, we could perhaps say we have met the enemy and the enemy is us. This is particularly true when we consider the almost hysterical need on the part of counselors to survive a world where efficiency, reduction in force, and trimming in budgets precede any desire for treatment and care of individuals from a mental health standpoint. As a past president of OCA, I remember well, 20-25 years ago, when the national conference for the ACA would draw 12,000 to 14,000 individuals, spanning in interest from college counseling to those working in private agencies throughout the United States. Today, we see the gradual and progressive disintegration of that organization, loss of central focus and defined definition of what represents a counselor.

It has been therefore the purpose of SWOCA to attempt to redefine more specifically the role of the counselor as it relates to what we may be able to offer the clients and emphasize the rudiments of a helping relationship.

In January, we hosted a card exchange networking session. In the near future, we plan to offer three workshops; one in the area of forensic counseling, one in the area of counseling and spirituality, and lastly, vital skills for counselors in the 1990s. We have initiated advertising with local TV and radio stations and developed a pictorial directory to be submitted to the local community for reference. All of these attempt to create a professional atmosphere which would be basically impossible without our strong affiliation with OCA. It is viable for us as well, as the state organization will be based on developing new lines of

professionalism and changing the formats of previous professional affiliation and basically returning to the simplicity of early counselor education, fundamentals of a helping relationship.
