

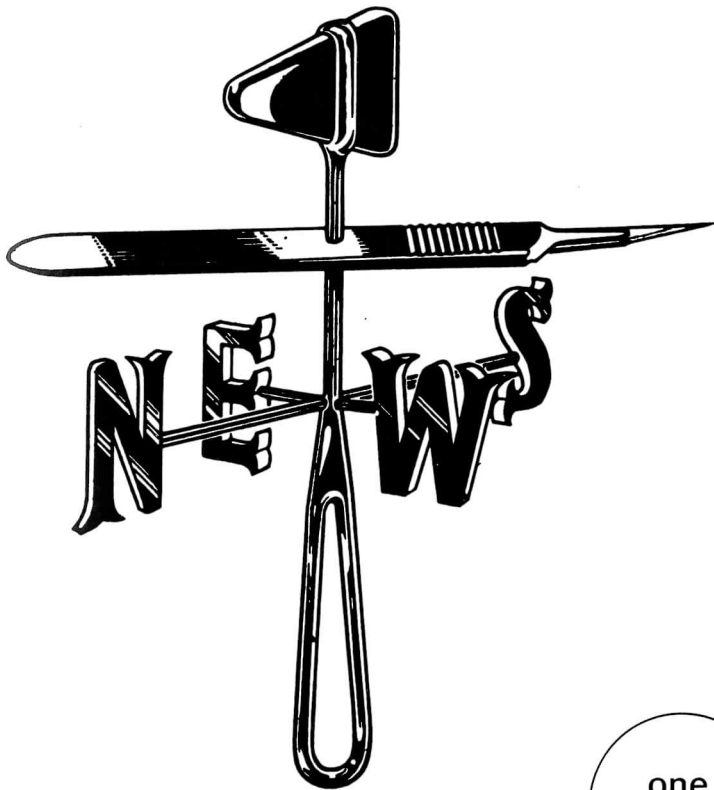

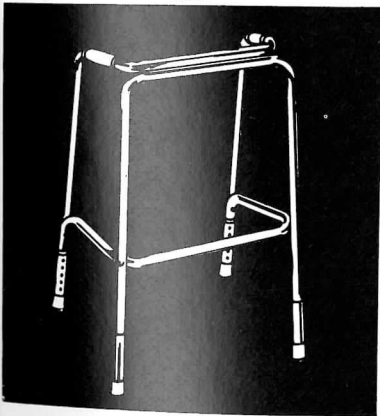

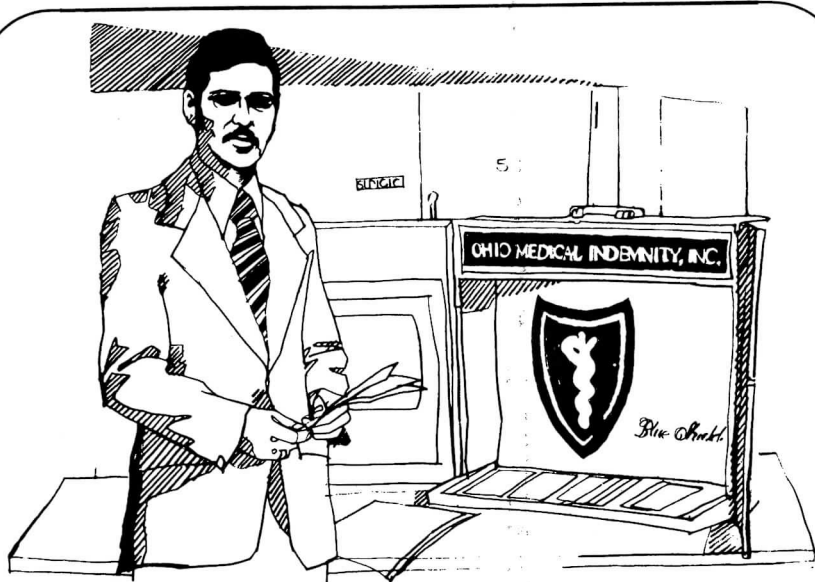

From the Desk of the President



Several weeks ago each member and associate member received a letter and questionnaire which was honestly and sincerely conceived in the hope that we would bring about a majority of the membership to decide the course and fate of the society. To date only about 1/3 have responded. About 1/3 of those who responded offered criticism, observation or suggestions. Their responses were genuine and well thought of. They all share the same concern for the future of the society and the private practice of medicine. I shall honestly try to personally contact those colleagues and seek their advice and further help.

Except for three, all those who responded felt that we do need a Mahoning County Medical Society. Views varied on how it should be run and what it should do. The implementation of these suggestions will be left to the democratic process of majority rule.

With respect to committees, a list was sent to the membership which included 48 committees. To date 42 members have responded for 32 committees. Of the 42 only 3 active members requested that they be considered for an office in the society next year.

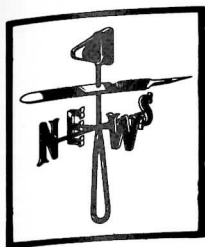
The over 100 members who attended the Dec. 17 meeting got a sample of what the medical community is faced with. The government and its bureaucrats have the manpower and facilities, at the taxpayers' expense, to expound their schemes and to plan for us and our patients. But our resources and time are very limited and become more so with less participation of our membership. The unity and strength of our society becomes so important when the state and national organizations seem ready to compromise or even surrender!

Some of those who responded to the questionnaire felt that the society is being run by a small minority. This happened **BECAUSE THE MAJORITY WAS ABSENT!**

However, this minority, who so far have carried the ball, is made of dedicated men who have given freely of their time, energy and resources for the rest. They so vary in ages, background, specialty and views, that the only "clickish" aspect of their being is that they are dedicated to what they strongly believe in: the preservation of the private practice of medicine and the integrity of the physician.

Some said that the society has been negative and reactionary. This perhaps has been due to the overwhelming assault on medicine in recent years. It leaves the busy practitioner with little time other than to be on

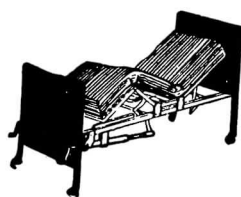
In conclusion, may I add that it is my privilege to greet you and wish you a very successful year.

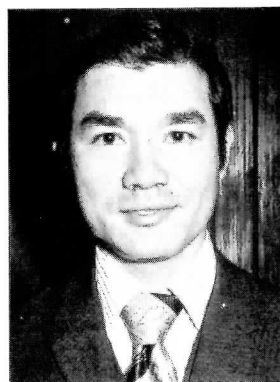

The proposal from the Allen Photographic Corporation was removed from the table. The Executive Secretary was asked to bring to the next meeting of council complete information as to exact costs and obligations to the Medical Society and exactly what the photo company would provide to both the members and to the Society. Council expressed no interest in a printed book, but some interest in a composite photo of all members.

A proposal was read from Burroughs Wellcome Co. asking the Medical Society to permit them to state that their MEDIX television series is being brought to the public by them in "cooperation with the physicians of your local county medical society." Council examined the program resume and the commendation of the producer, the Los Angeles Medical Society, and agreed that the series is worthy. It was noted that if the program came out of a Cleveland TV station as planned, our permission would be irrelevant. The motion was made by Dr. Mahar, and properly seconded, that we go along with their request, and also to asked them to get the program on a Youngstown TV station. Motion was passed.

Dr. Melnick discussed a newspaper article which quoted Ezell Armour, Mahoning Welfare Director, as saying he was having a difficult time getting a doctor for the county nursing home, "apparently because the statutory pay of \$15 an hour is not enough." He wrote to Mr. Armour and had a phone call from Mr. Armour as a result. He believes that he made it clear that the statement as printed in the paper was not correct. Since the situation became very complex, council decided no further action was necessary, and commended Dr. Melnick on his prompt action.

A letter was read from Nancy Childress of the Quota Club asking for approval for an awareness campaign on the need for immunization against rubella. The motion was made by Dr. Anderson, and properly seconded, that we approve their campaign, commend them for undertaking it and offer them help if they need it. Motion was passed.

A letter was read from Dr. Virginia A. Fulcomer, Director of the Child and Adult Mental Health Center asking about the peer review system for this area. It was noted that the letter had already been answered, giving her the status of Dr. Anderson's peer review committee. Council asked that a letter be sent to Dr. Gelbman, chairman of our Mental Health Committee, asking that his committee look into the proper relationship between psychiatrists and psychologists, and come up with a recommendation as to the proper place of the psychologist in the care of the patient.

A letter from the Youngstown Board of Health was read asking the Medical Society to review a health examination form and give them help in revising it. The form was referred to the Government Medical Care Committee, Dr. Tandatnick, chairman.

Dr. Anderson reported that work on the Peer Review Committee is progressing and that two sub-committees have met, with a third scheduled for next week, and that a report will be made to the full committee soon. He reported no further action on the District level.

Dr. Melnick reported the results to date of the vote concerning Region Six Peer Review Corporation being the PSRO for this area. 148 members returned the vote saying "no." One member voted "yes", and one member wanted more information. Council members agreed to make personal phone calls to those members who have not returned their vote.

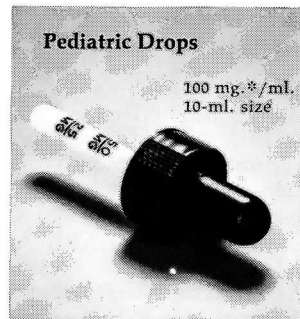
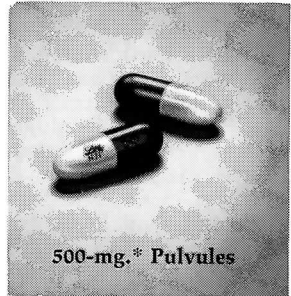
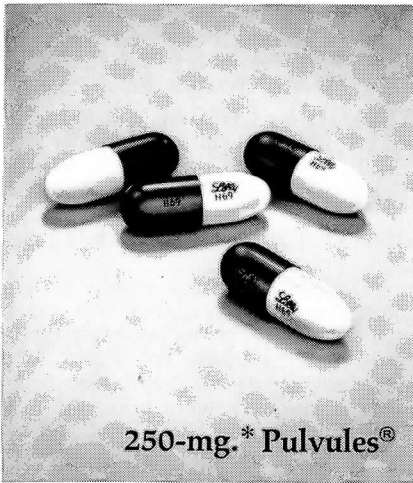

Precautions:

ORAL: In the elderly and debilitated and in children over six, limit to smallest effective dosage (initially 10 mg or less per day) to preclude ataxia or oversedation, increasing gradually as needed and tolerated. Not recommended in children under six.

INJECTABLE: Keep patients under observation, preferably in bed, up to three hours after initial injection; forbid ambulatory patients to operate vehicle following injection; do not administer to patients in shock or comatose states; use reduced dosage (usually 25 to 50 mg) for the elderly or debilitated and for children age twelve or older.

ORAL AND INJECTABLE: Though generally not recommended, if combination therapy with other psychotropics seems indicated, carefully consider individual pharmacologic effects, particularly in use of potentiating compounds such as MAO inhibitors and phenothiazines. Observe usual precautions in presence of impaired renal or hepatic function. Paradoxical reactions (e.g., excitement, stimulation and acute rage) have been reported in psychiatric patients and hyperactive aggressive children. Employ usual precautions in treatment of anxiety states with evidence of impending depression; suicidal tendencies may be present and protective measures necessary. Variable effects on blood coagulation have been reported very rarely in patients receiving the drug and oral anticoagulants; causal relationship has not been established clinically.

Adverse Reactions: Drowsiness, ataxia and confusion may occur, especially in the elderly and debilitated. These are reversible in most instances by proper dosage adjustment, but are also occasionally observed at the lower dosage ranges. In a few instances syncope has been reported. Also encountered are isolated instances of skin eruptions, edema, minor menstrual irregularities, nausea and constipation, extrapyramidal symptoms, increased and decreased libido—all infrequent and generally controlled with dosage reduction; changes in EEG patterns (low-voltage fast activity) may appear during and after treatment; blood dyscrasias (including agranulocytosis), jaundice and hepatic dysfunction have been reported occasionally, making periodic blood counts and liver function tests ad-

visible during protracted therapy.

With the injectable form, isolated instances of hypotension, tachycardia and blurred vision have been reported; also hypotension associated with spinal anesthesia, and pain following I.M. injection.

Usual Daily Dosage: Individualize for maximum beneficial effects. *Oral: Adults:* Mild and moderate anxiety and tension, 5 or 10 mg t.i.d. or q.i.d.; severe states, 20 or 25 mg t.i.d. or q.i.d. *Geriatric patients:* 5 mg b.i.d. to q.i.d. (See Precautions.)

For Parenteral Administration: Should be individualized according to diagnosis and response. While 300 mg may be given during a 6-hour period, do not exceed this dose in any 24-hour period. 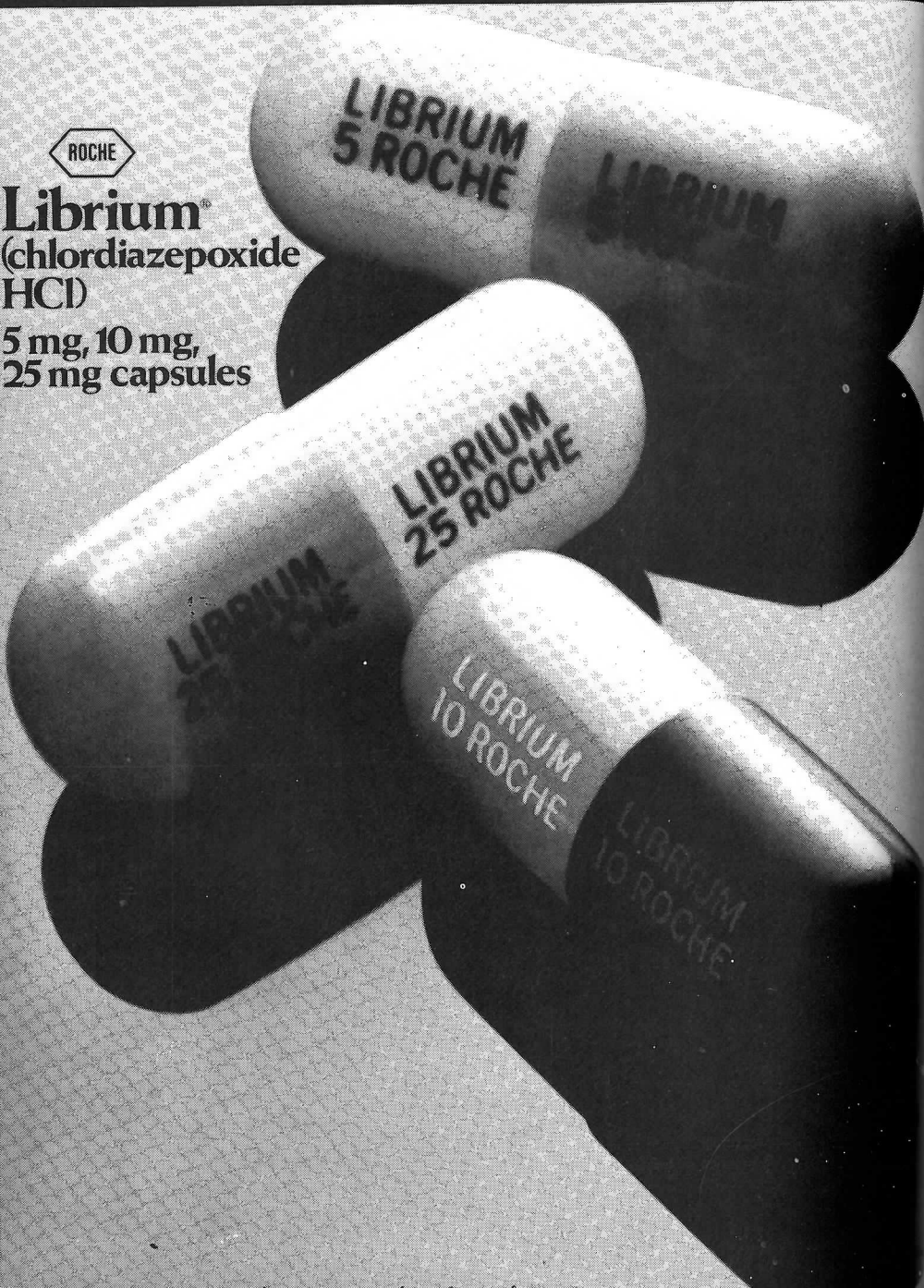
