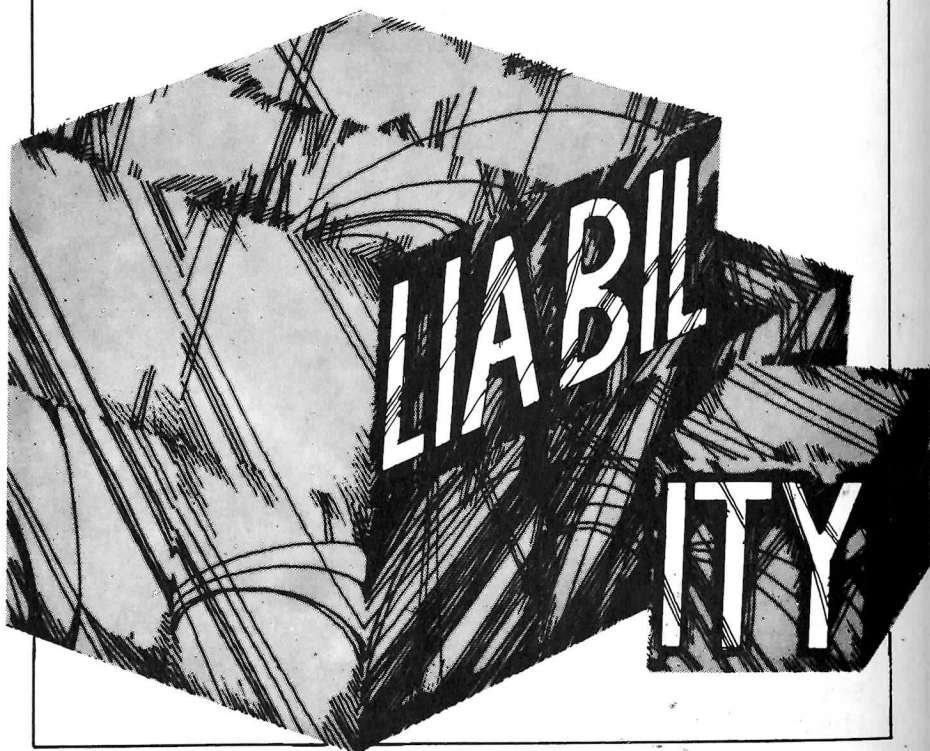

## *From the Desk of the President*

Over the past several years there has been a steady escalation in the number and amounts of malpractice claims against the physician. In the vast majority of cases, when litigation goes to the courts the doctor is exonerated. One can hardly measure the intangible, but nonetheless substantial, non-monetary damage in mental and emotional anguish the physician goes through in the trying times of a law suit. I know all too well, having gone through that route myself.

Undoubtedly, there has been an increased amount of tension and hostility between the two professions of law and medicine. The doctor has become suspicious of his legal colleagues and feels little disposed to cooperate with the attorney when a non-malpractice personal injury case comes into being. Regardless, the physician has a responsibility to care for his patient to the best of his ability; but over and above this, he has some legal, if not moral, obligation to furnish the necessary information when litigation is initiated by his patient to recover for damages.

The Mahoning County Bar Association has in general agreed to the following:

- a) Setting guidelines to provide for taking the deposition of physicians as often as possible (to minimize court appearances).
- b) Setting guidelines for giving reasonable advance notice to physicians when their presence in court will be required.
- c) Setting guidelines for prepaying the reasonable charges for requested medical reports.
- d) Setting guidelines for protecting the physician fee bill balance.

These are, in general, reasonable initiatives on the part of our legal brethren. In exchange they are desirous of setting guidelines for basic reasonable charges for medical reports, court appearances and depositions. It is my feeling that, as an officer of your County Medical Society, I have absolutely no authority to set or recommend fees that you charge your patients. To extend this further, in no way can I set up a fee schedule you charge attorneys. You must decide that which you consider just and reasonable and I have so informed the Bar Association representative.

Obviously, there are a small few who charge fees that are abnormally high or even outrageous. To those I can only advise "fiscal temperance". As to a final guideline, that of furnishing a medical report within a reasonable time, I can only say that common courtesy, if not to the lawyer, to the patient you have cared for, at least demands it.

In many ways, I disagree with the attorneys as to the fee for services. We as physicians care for patients on a strictly fee for service basis. The size of our fee remains the same whether the patient and attorney collect a windfall settlement or lose the case completely. We do not give care to patients "on contingency". I therefore must make a plea to our legal colleagues that they urge their clients to set up some mechanism for paying their just medical bills, since these are not contingent upon legal settlement. They exist as a financial obligation, over and above the outcome of any legal maneuver. I can not understand the proposition that a physician be forced to wait for as much as two and three years to collect a fee for services rendered. If you are so forced to wait, is your bill then null and void (after this undue wait) on the unsuccessful legal action??

## Editorial

**PROCEEDINGS OF COUNCIL****Feb. 14, 1978**

The regular meeting of the Council of the Mahoning County Medical Society was held on Tuesday, Feb. 14, 1978 at the Youngstown Club.

The following applications for membership were presented by the Censors:

ACTIVE: Charles R. Luttenton, M.D.

ASSOCIATE: Escarlito U. Sevilla, M.D.

The applications were approved. The applicants will become members of the Mahoning County Medical Society 15 days after publication in the *Bulletin*, unless objection is filed in writing with the secretary before that time.

Atty. Eugene Fox came into the meeting and was introduced. He discussed what he considered to be problems between the two professions, mainly in the area of the doctor's role in court cases involving the doctor's patient. Following a general discussion, Dr. Dietz offered to meet with Atty. Fox for further discussion. Dr. Reed presented Atty. Fox a copy of "Standards of Practice Governing Lawyers and Doctors" from the Cleveland Academy of Medicine, and offered to arrange a meeting between representatives of the Bar Association and the Medical Society.

A letter from Mrs. Phyllis Kramer was noted, thanking the Medical Society for the honor extended to Dr. Nelson.

A legislative bulletin was read from the OSMA stating that the Ohio Medical Board now permits D.O.s and M.D.s to get CME credit from programs sponsored by either OSMA or OOA, interchangeably.

A letter was read from Stark County Medical Society announcing their support for the Michigan State Medical Society in their controversy with Michigan Blue Cross Blue Shield. The motion was made, seconded and duly passed that we send a letter of support to the Stark County Medical Society for their resolution.

Dr. Dietz announced that Dr. Felix Pesa has been appointed as the Medical Society representative on the Heart Association's Hypertension Advisory Committee. He will report at the next council meeting.

Dr. Lambert made a report for the Ad Hoc Blue Shield Committee. The report included suggestions for a resolution to OSMA. The motion was made, seconded and duly passed that the report be accepted and that any further suggestions on a resolution be forwarded to our delegates.

The motion was made, seconded and duly passed that the former osteopathic committee be reactivated. The secretary was instructed to check to find the names of members of that committee.

The motion was made, seconded and duly passed that Council approve that all future Bylaw editions be printed in loose-leaf format.


**APRIL 15th SET FOR DINNER DANCE**

### TWENTY YEARS AGO — MARCH 1958

President Detesco wrote: "We must work to make life richer for our senior citizens . . . Every retired individual must be impressed with the basic philosophy that purposeful activity is the stimulus to life that prevents physical and emotional deterioration."

Editor Morris Rosenblum predicted that we would be traveling to interplanetary scientific meetings. He didn't say how soon.

District Councilor Gustafson reminded us to urge our patients under 40 years of age to have Polio immunization.

Genevieve Delfs announced that Polio Reminder Cards were available for the members to send to their patients.

There was an absorbing account of the exploits of "Andreas Vesalius of Brussels" in this issue, written by Richard Murray.

New members that month were William Howard Taake of Struthers and William H. Bunn, Jr. of Youngstown. Dr. Taake left soon after to serve in the Air Force. Dr. Bunn was associated in practice with his distinguished father, and later succeeded him as Chief of Medicine in the Youngstown Hospital.

Dr. Wayne Hardin published a most informative article on "Mediastinal Disorders".

Ralph White announced the 66th year of a White's Drug Store in Youngstown.

### TEN YEARS AGO — MARCH 1968

Much interest was evident in this issue over the new Federal Regional Medical Program and the areawide comprehensive health planning agencies. Dr. Eli Saadi was elected Vice President of the Northeast Ohio Regional Medical Program. Dr. Richard Murray was Treasurer of the Mahoning Valley Health Planning Association which later became the local agency for the Comprehensive Areawide Health Planning Association. Editor J. James Anderson devoted his editorial toward encouraging Medicine and Govern-

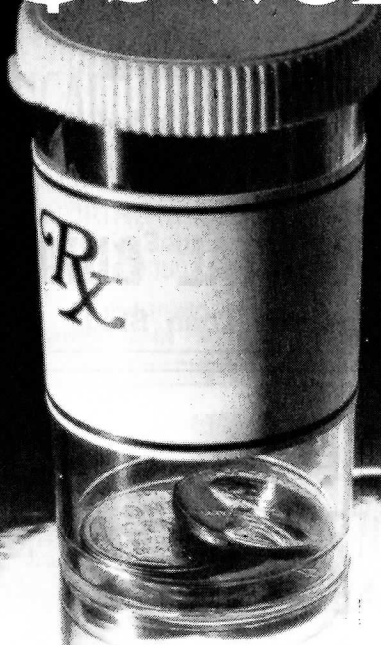

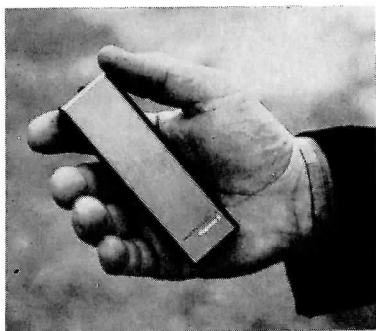

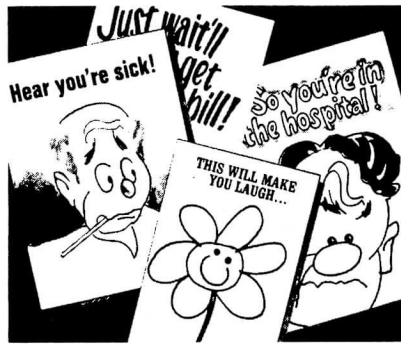
