February 15, 1983

1. The minutes of the January 11, 1983 meeting were approved.
2. Dr. Gillis mentioned that the selling of Summer assignments is illegal--Ohio Ethics Law - ORC 2921.43.
3. Dr. Gillis reviewed the subject of representation of the University. A file is being maintained in the President's office on who is representing the University.
4. Dr. Gillis opened up the discussion on coordination of dates for lectures, colloquia, and symposia. It was emphasized that the task was necessary for forward planning. Dr. Gillis volunteered to bring up the subject with senior administration.

SUBJECT Catalog Statement Regarding Transcript Revision

The statement below is intended to convey the meaning the motion approved at the January 11, 1983 Deans' Council meeting. I suggest it be edited/revise as you and the secretary see fit and included in the next set of minutes.

Following the awarding of a baccalaureate or an associate degree, the students' transcript is intended to retain a complete record of the students' academic performance while earning that degree. Therefore, a graduates' transcript may not be revised using RECALCULATION OF POINT AVERAGE, "F" TO "W" PETITIONS or STATUTE OF LIMITATIONS. This policy does not apply to a student who has completed an associate degree and is currently enrolled in a baccalaureate degree program.
