Abstract:	Materials contain funding, scholarship and asset information which includes wills and trusts with bequest to the university. Dates range from 1940-1974 with most of the information dating before Youngstown University became a state-funded institution.

Historical Background

Alan G. Rorick, a Cleveland area lawyer with Baker, Hostetler & Patterson (currently Baker & Hostetler), sent these records to Joseph Rook, Vice President of Financial Affiars at YSU, with the intention that they be stored for archival purposes.

Baker, Hostetler & Sidlo was founded by former Cleveland Mayor NEWTON D. BAKER, JOSEPH C. HOSTETLER, and THOMAS L. SIDLO in 1916. Three months later, Baker was appointed secretary of war by Pres. Woodrow Wilson and left for Washington. When he returned in 1921, his stature helped the firm acquire a national reputation.

Over the years the firm changed both its location and name. Needing larger quarters by 1924, it moved from its original office in the Union Natl. Bank Bldg., to the Union Trust Bldg. (HUNTINGTON BLDG.). It stayed there until 1980, when it relocated to the Natl. City Ctr. Bldg. Baker, Hostetler & Sidlo added Patterson to its name in 1931, and in 1938 changed it to Baker, Hostetler & Patterson. It was shortened to Baker & Hostetler in 1979. The firm merged with McCutchen Black Verleger & Shea of Los Angeles in 1990, giving it access to West Coast legal business. In 1995 the firm's Cleveland office, with approx. 140 attorneys, has represented many of the city's major developers during the largest downtown revitalization in Cleveland's history in such projects as SOCIETY CENTER, TOWER CITY CENTER, and Jacobs Field.¹

Many of the clients, whose files are in this collection, refer to some of the wealthiest people in the Youngstown area who contributed to Youngstown University. Names such as L.A. Beeghly, Olive Arms, John Tod, Clarence Strouss, Frank Purnell and William F. Maag among others are included. Many of the contributions were given as scholarship funds, endowments, or awards for students. The funds included (approx. 10 million dollars) were transferred from the Youngstown University Corporation account to a Foundation account prior to the University becoming a state funded institution.² Essentially, this collection documents the birth of the YSU Foundation.

Scope and Content

The collection is arranged by type of materials, correspondence and assets. The collection maintains its original order. The dates range from 1940-1974, with a majority of the information from the 1950s and 1960s. The Correspondences series contains one folder while the rest of the collection pertains to assets. Most of the assets describe donations and bequests to the University and include wills and trust information. Some Board of Trustee minutes are included which reference the donation to the University.

Colophon

This collection came to the University from the law offices of Baker, Hostetler & Patterson. Alan G. Rorick sent the materials to YSU's Vice President of Financial Affairs, Joseph Rook, in 1974 according to a correspondence included in the collection.

"I have been editing out files with respect to the transition of Youngstown University to Youngstown State University. We have several jackets of material which I belive ought to be kept in the archives of Youngstown State University with respect to some of the records of The Youngstown University which we considered in connection with the transition. We do not have room to keept this materal, and I am therefore having it shipped to you under separate cover with the suggestion noted above that it be kept in the archives of Youngstown State University." ³

In 1974, an archives did not exists. The records were kept in storage in Tod Hall. In 2005, Holly Jacobs, General Counsel, transferred them to the newly established archives. The box contained 4 jackets of information and were kept in original order.

This collection was processed by Lisa Marie Garofali, who also wrote the finding aid. She holds an M.A. in History from YSU and is a 12-year employee of Archives & Special Collections.
