Historical Background

The history of the College of Arts and Sciences can be dated back to when the Youngstown Institute of Technology (later Youngstown College/YSU) started to offer Liberal Arts classes in 1921 with Dr. Joseph Smith as Dean of the Liberal Arts School. It was because of the growing Libral Arts program that the school changed its name from the Youngstown Institute of Technology to Youngstown College. In 1937, Youngstown College was official ranked as a college of arts and sciences with the Ohio State Department of Education. Around 1950, The College of Arts and Sciences unit was split into two divisions. Dr. Karl Dykema as director of the Division of Language and Literature (Classical Languages, English and Foreign Language) and Dr. O.L. Reid as director of the Division of Social Sciences (Economics, History, Philosophy and Religion, Political Science, Psychology and Sociology). In 1963, Dr. Karl Dyekma started signing his correspondences as The Dean of Arts and Sciences. In 1970, Karl Dyekma died of cancer. Dr. Robert K. Smith served as acting dean until Dr. Bernard J. Yozwaik was appointed Dean effective in August 1971. He remained Dean of the College of Arts and Sciences throughout the dates of this collection.

Scope and Content

This collection contains three series: Faculty Directories, Faculty Handbooks, and Subject Correspondence. While the dates range from 1948-1991, a bulk of the material ranges in the 1960s and 1970s. Most of the material are publications of directories and handbooks. A majority, if not all, the correspondences in the collection are during Dr. Karl Dykema tenure of Dean or as Director of Languages and Literature. The only matrials truly original to the office are the last two folders of Subject Correspondences which pertain to Dr. David Ives and President Howard Jones.

Colophon

The collection came to the Archives and Special Collections in 2014 as a Records Transfer from the Dean of C.L.A.S.S., Dr. Shearle Furnish. It is a relatively small collection from the office. Additions to the collection are anticipated in the future.

This collection was processed by Lisa Marie Garofali, who also wrote the finding aid. She holds an M.A. in History from YSU and is a 13-year employee of Archives & Special Collections.

SERIES III: Subject Correspondence

This series is probably the most interesting and personal in the collection. This is a series of various correspondence from the Dean of C.L.A.S.S. which pertain to Dr. David Ives and President Howard Jones. Most of the correspondences date from 1950-1970 and are written from or addressed to Karl Dykema, who was Dean or department director at the time. Topics

in the David Ives folder include his obituary in 1991 and correspondences between Ives and Dykem which pertain to issues in the Foreign Language department, sabbatical, health issues, Ph.D classes, schedules and edits for the college catalog, *The Bulletin*. The President Howard Jones folder contains his memorial service program in 1982, correspondences between Jones and Dykema (many of which refect hiring needs), the President and Mrs. Howard Jones Scholarship (which was established in 1947), correspondences from the Building Committee and President Jones' Memorial Dinner in May 1966 for his retirement as President of Youngstown University.
