

Historical Background

Youngstown State University went through several stages in its growth and the same can be said for the Human Resources department on campus. Prior to becoming a state institution, the College/University was small and very personal. Staffing decisions appeared to be made specifically by President Howard Jones and/or Dean Joseph Smith with the approval of the Board of Trustees (previously Board of Governors when the college was under the auspices of the YMCA). There was no specific "Human Resources" or "Personnel Department" only "The Administration" which consided of a handful of persons.¹

When the University became a state-funded in 1967, a more hierarchy of administrative structure appeared. In January 1967, Stuart L. Aubrey is named as Director of Personnel under the Vice President of Financial Affairs. Prior to leaving the University in 1973, Aubrey state he saw the University develop from very few minimal staff to a "very strong operation administratively." Aubrey tried to develop the personnel office into a service operation rather than a hiring firing operation. ³

Scope and Content

This collection was kept in original order with material arraged by type. A bulk of the dates in the collection range from the late 1970s/early 1980s to late 1990s/early 2000. Much of the collection is dedicated to Series I: Awards which contain nominations for the Distinguished Service Awards. Series II: Policies and Procedures contain two items, one from the state on civil service employees and a second on YSU information for retirement/separation from the early 1990s. The Publications series contains a hodgepodge of information from benefit booklets, newsletters, flyers, and the Buck Consultant Studies. The last series contains artifacts for the Hertiage Award which was established in 1982

Colophon

This collection is made up of several accession records and a transfer record. In the collection, the Buck Studies, for example, UA 2008.04 was given to the Archives and Special Collections by George Heller. Mr. Heller was the APAS representative who received a copy of the study which was conducted by Buck Consulants for the YUS Human Resouces Department to give a comprehensive review of the YSU's compensation practices.

Most of the collection comes from accession number 2009.8. This accessioned was made up of two boxes containing records in loose-leaf format (in three ring binders or report binders). Most of the times pertain to nominations for the PA staff Distinguished Service Awards and a lesser amount of information on retirement/separation.

The last part of the collection was part of a records transfer in 2019 from the Human Resources department. It contained the original artwork for the design of the Heritage Awards plaques and a large wooden plaque with a message from President John Coffelt explaining the Heritage Awards.

During the processing of the collection, four binders were deaccessioned. These binders contained position vacancies from 1993-2005. According to the Records Retention Schedule (PER 2000), they are to be active plus six years and then destroyed. This collection was process by Lisa Marie Garofali, a 12 year employee of YSU Archives and Special Collections with a M.A. in History.

BOX 1

SERIES I: Awards

This series contains information on the Distinguished Service Awards and Heritage Awards. The Distinguinshed Service Awards were accepted by the YSU Board of Trustees during their February 05, 1988 meeting. "Members of the University's full service Professional/Adminsitrative Staff who are excluded from participation in collective bargaining shall be eligible for consideration for a distinguished service award. Up to four such awards will be granted annually by the President of the University to Professional/Administive staff whose performace of duties at the university has been outstanding..." The award also included up to 5 APAS staff members.

The Heritage Awards Program was established in 1980 to recognize former faculty and staff whose unique contributions to the University have had amajor impact upon its development. The Standards are rigorouse and the number of awards are limited. The first five award winners were announced in 1982 and included: Louis A. Deesz, Nellie G. Dehnbostel, Karl W. Dykema, Vera R. Jenkins and Josph E. Smith. ⁵
