SPRING CONFERENCE SET FOR MAY 2 & 3

The Spring OPGA Conference has been set for May 2 and 3 at the Neil House in Columbus. See registration materials in this newsletter.

The conference will begin at 4:00 p.m. on May 2 (registration and/or pick up conference materials if pre-registered). Other aspects of the May 2 program include the banquet dinner at 6:30 p.m., key-note speaker at 7:30 p.m. (Dr. Michael Altekruise, Southern Illinois University), and a Hospitality Hour with cash bar at 9:00 p.m.

The program on May 3 will consist of various program presentations by teachers, counselors, counselor educators, state supervisors, school supervisors, etc.

A registration fee of \$16.75 includes a package plan for the banquet dinner on May 2, a smorgasbord luncheon on May 3, and conference materials. In addition, each may be selected separately (\$10.00 registration, \$6.85 banquet dinner, and \$3.75 luncheon).

On site registration will be available for \$12.50 on the conference only basis, as reservations for meals will not be accepted after April 30.

The map is a composite of maps submitted by the president's of each of OPGA's five chapters. It should be noted that the Miami Valley Personnel and Guidance Association territory overlaps both Central Ohio's and Cincinnati's boundaries. No attempt has been made to change this.
