

Joe Saunders, Ph.D., LPCC

Book Review

Stanley, Scott and Trathen, Daniel (1998). A lasting promise: A Christian guide to fight for your marriage. Jossey-Bass Publishers.

The authors have written a useful, easy to read, pragmatic, self-help book for protecting and nurturing a marriage relationship based on Christian principles. In addition to drawing on marital research to support their approach and conclusions, they offer Biblical citations and commentary that they believe support, for the most part, the findings derived from couple research.

There are three sections to the book and each section is filled with case material that illustrates common marital issues, useful suggestions on ways to resolve conflicts or lesson tension, and practical exercises that couples can use to deepen the lessons outlined. All of the preceding components are permeated with Christian principles in which marriage is viewed as a committed and sacred relationship.

Part One of the book is a straightforward discussion problems communication and conflict resolution strategies for resolving difficulties. Part Two complex describes more antecedents to marital problems including the impact of family of origin patterns, unmet needs, different expectation, hidden issues, cultural differences, and different religious and spiritual beliefs. Counselor educators and family counselors will resonate to this section because it presents the most interesting and useful material for class purposes or for couples counseling. For couples using this book as a self-help guide, the content in Part Two contains a helpful series of checklists and exercises that enable couples to identify and reflect on the finer and more hidden points of their conflicts and ways to improve the relationship. It is unlikely, however, that the information and exercises alone would be sufficient to resolve deeper disagreements. Follow-up counseling, in most cases, would be needed.

The book will have a strong appeal to couples who desire clear and sound marital advice blended with Christian principles. The prescription-like style and the brevity of particular recommendations, however, may be viewed by some as an oversimplification, perhaps, and, By others, the pollyannaish. simplification and skill-based approach will be user friendly.

Carl Graf Dies

Carl F. Graf, Sr., public member of the Ohio Counselor and Social Workers Board for the past four years, died in Columbus on June 21. He emigrated from Germany nearly 70 years ago. He was a bank executive. The economic depression in Germany forced Carl's family to come to America. They settled in the German Village area of Columbus. He was president of Maennerchor, the 142year-old German singing society.

Carl dedicated his life to helping others. He was president of Charity Newsies and other crganizations which assisted people in need. He will be sorely missed by the Columbus community.

Liability Update

ACA Insurance Trust liability insurance through OCA was projected to be available by July 1, 1998. Fine-tuning the program to the needs of professional counselors in Ohio, however, has set back the projected date of availability to September, 1998.

The insurance will be made available to professional members of OCA. Students are not covered under the plan. A mailing will be sent to all members and licensees in

Ohio School Counselor Association

The annual OSCA Leadership Development Institute held at the Radisson North in Columbus on June 12-13, 1998, was a great success. Board members were excited, motivated, and inspired to become better leaders counselors during the 1998-99 school year. A special feature of the LDI was the presentations by Luvern C. Cummingham, a copartner in Leadership Development Associates, Gahanna. Ohio. Cummingham has been a research professor and university administrator for more than thirty years. He served as Dean of the College of Education at Ohio State from 1967-1973. He has lectured and served as a consultant throughout the United States and in other countries.

Cummingham introduced the board to the KIVA, a group technique used in identifying and refining leadership initiatives. The KIVA, developed by Cummingham, is a convening mechanism in which large groups can examine transcendent issues surrounding a program, project, concept, or The KIVA helps to problem. stimulate thinking and allows for broad and diverse participation. The objectives of the KIVA were (1) exposure to and experience with the KIVA as a leadership learning (2) concentration on practice professional and organizational growth, and (3) applications within school district and community settings. KIVA helped board members to better realize what we must do to advocate for children and promote the image of school counseling and OSCA. The second presentation was on environmental scanning. The objectives were (1) exposure to and experience with environmental

scanning as a tool for strategic planning, (2) focus on long/short term personal and organizational development needs, and (3) review of the information sources that enhance daily professional practice. The LDI concluded with discussion of the OSCA Strategic Plan and members setting goals and completing their plan of action for 1998-1999.

Five members of the OSCA Executive Board attended the School Counselor American Association Delegate Assembly and Conference in San Antonio, Texas, June 24-29, 1998. Representing OSCA were Jeannine Studer, Judy Howard, Jean Howes. Pregitzer, and Stephen Peck. Other Ohio attendees were Diana Byrum, Carolyn Columbus; Collins, Canton; Susan Faulkner, Cleveland; Bruce Fritch, Delaware; Christina Akron; Daniel Kutchief. MacDonald. Cleveland Heights; Judy Morgan, Dresden; James Seals, Cincinnati; Susan Sears, New Albany; Amy Stockdale, Newark; Ann Tye Shimels, Strongsville; and Ron Waterwash, Richwood.

During the ASCA Conference there were twelve pre-conference sessions, four keynotes, and 71 presentations in skill development and interest sessions. A wide variety of topics were covered for counselors at all levels.

During the Delegate Assembly, the Ohio School Counselor Association was presented with two grants from ASCA. Ohio was the only state to receive two grants. One grant was the Leadership Development Grant to provide assistance to presidentelects to attend the yearly ASCA leadership training. This training provides leaders with strategies, opportunities, networking professional development emerging leaders. The second

grant is the Innovative Initiatives Grant for the purpose of developing and implementing new programs. This grant will be used for a fullday workshop to train school counselors in internship site supervision.

Thank you for your interest in our professional organization. Your suggestions and concerns help give the OSCA board new ideas to consider so that we can better support you and, in turn, the children and adolescents in Ohio's schools.

Dates for future OSCA meetings are as follows: October 2 and 3, November 4 - 6 (AOCC), February 5 and 6, April 30 and May 1, and ASCA Conference June 26 - 29, 1999, Phoenix, Arizona.

Legislative Update

State Issue 2, the proposed state sales tax increase to fund public education, was resoundingly defeated. The margin of defeat, 80% opposing to 20% supporting, was higher that most pollsters had predicted. The reaction of Republican leadership has been to state that the new formula is funded by current allocations through next

fiscal year. But by July 1, 1999, additional resources will be required. Accordingly, the next governor and General Assembly will be expected to address the problem.

The General Assembly is now recessed for the summer. This means many bills will not receive sufficient action for passage before the *sine die* adjournment on or before December 31, 1998. Bills which OCA supports which are threatened with inaction are:

HB 719 Morgan legislation in which OCA has coalesced with other mental health organizations to provide guidelines to mental health professionals regarding their obligations when an outpatient client threatens to harm a third party; and

HB 718 Mental health parity.

Bills OCA does not support which will probably die:

HB 589 Licensure of art therapists; SB 157 Licensure of recreation therapists; and

SB 261 License of marriage and family therapists.

Opposition to the above centers upon the following: (1) exclusive nature of some of the bills which would prevent counselors now practicing some of the above therapies from continuing to do so; (2) overextending an already overloaded Ohio Counselor and Social Worker Board by adding the oversight of some of the above practitioners to its responsibilities; and (3) lack of sufficient rigor in training comparable to that of the training for licensed counselors.

All 99 House seats and 18 of 33 Senate seats are up for election this November. Please support those who have supported the profession of counseling and its issues.


