From the President's Desk

abreast of and promoting the use of technology, and documenting the OCA story connecting our past to our present and future. It is my plan that we will make advancements in each of these six areas by the end of this year.

What Advancements Should OCA Have Accomplished by the Year 2006?

It is pretty risky business looking five years down the road, especially when we are all working feverishly to keep our heads above water on a daily basis. And furthermore, who knows what will happen tomorrow that will push us to drastically alter plans and efforts for the future? On the other hand, if we don't look ahead towards our potential futures. how can we make choices about taking reasonable actions to move forward? Without some future planning the actions we take are likely to keep us stuck where we are, and others will be the deciders of our future.

Legislative Update

The Ohio General Assembly has recessed for the summer and is not expected to return for committees sessions until and voting September. Session and are scheduled committees sporadically throughout the fall and early winter. Among the issues being followed by the Ohio Counseling Association and its government relations committee are the following.

Senate Bill 9 (Spada, R-Parma Heights) The original version of this bill would have created a new crime of "sexual exploitation of a mental health client or patient" for circumstances in which a mental health professional engages in sexual relations with a current client. Due to opposition from the Counseling Association Ohio (OCA) and others, this legislation was significantly changed from its "As Introduced" version. substitute bill was passed by the Senate in June.

Under the revised version of the bill, existing crimes of sexual battery and sexual imposition are expanded to include situations where a mental health professional engages in sexual activity with a patient and has represented to the patient that the sexual activity is necessary for mental health

treatment purposes. In addition, changes are made to provisions in current law to stipulate that consent is not a defense to a civil charge of assault or battery stemming from a situation where a mental health professional has engaged in sexual activity with a patient, unless the mental health professional proves by a preponderance of evidence that the patient was not emotionally dependent upon the therapist at the time the sexual activity occurred. The mental health professional would also have to prove that he/she did not falsely represent that the sexual activity was necessary for medical or mental health purposes.

The Ohio Counseling Association opposed the original version of Senate Bill 9 because it imposed criminal liability on a certain category of professionals with a exploitative for potential relationships, but ignored others who were similarly situated. OCA testimony and lobbying on this bill was successful in delaying action on the proposal until concerns were addressed. The bill in its current form is far more acceptable and was approved by the Senate with no dissenting votes. The measure now proceeds to the House consideration.

House Bill 33 (Olman, R-Maumee) This legislation requires equality of coverage for mental illness and addiction treatment under group health insurance contracts issued in Ohio. It is under consideration in the House Insurance Committee where it has had two hearings. As required by law, the Legislative Service Commission hired an independent firm to conduct an actuarial study of the legislation and its impact on health insurance in Ohio. This report was released in late May, and forecasts a potential increase in insurance

premiums of only 1 to 1.5 percent. Proponents of the bill, including OCA, consider this to be an persuasive important and development in an uphill legislative campaign. The bill remains in the House Insurance Committee, but the sponsor, Representative Lynn Olman (R-Maumee), an insurance agent himself, has requested additional hearings when the legislature returns in September. The business community and insurance industry remain opposed to the legislation regardless of the negligible cost increases associated with equal coverage of behavioral health services.

Licensure of CCDCs

Representatives of OCA met with representatives of a coalition that is promoting legislation to provide for state licensure of CCDCs I, II, and III. This coalition is seeking to create an independent state board to license and regulate only CCDCs. The legislation under discussion would also set forth the education and training requirements for each level of licensure, and would establish a statutory scope of practice for each category of Currently, there license holder. exists in administrative rule a scope that has been practice problematic for OCA. It is hoped that many of our concerns can be addressed when legislation is introduced. To date, no proposal in bill form has been released. This is likely to become an active issue in the fall and in 2002.

<u>Licensure of Marriage and Family</u> Therapists

Also seeking independent licensure are marriage and family therapists. Although legislation creating an independent license for these practitioners has yet to be introduced, it is expected in late summer or early fall. OCA has not yet been contacted by the group

promoting this issue but fully expects to be engaged in active review of such a proposal. Legislation to license marriage and family therapists has been considered by the Ohio General Assembly in previous years and has not received significant leg slative support. The details of the current proposal remain to be seen and will be presented to OCA's government relations committee and board when available.

School Counselor Grants Available

Ohio School The Counselor Association is offering grants to support innovative school guidance projects. Last year we awarded funding for five projects on anger management. character development, and assistance to a program promoting parents and students working together. Grants can vary from \$200 to \$100C. You must be a member of OSCA to receive a grant.

Government Relations

Welcome to the world of politics! Yikes! I know, I did not like the idea of politics; after all, I am a counselor, not a politician. However, as a counselor I have come to realize that being aware and active in politics is a necessity for my profession and my personal and family life as well.

Certainly on a state level there are many issues of which we as counselors need to be aware and take action, such as: watching the wording of the Senate Bill 9 and insuring that the mental health field represented fairly objectively; striving for treatment for mental health and addictions disorders as House Bill 33 is advocating; and to monitor the licensure activities for chemical counselors dependency and marriage and family therapists.

Not only do we have to watch our own yard, but our neighborhood as well. On the federal government (our neighborhood), scene counselors need to watch and be aware of the funding of the Elementary School Counselors Demonstration Act (Ohio receives more than \$700,000), the Medicare Modernization Act (which would include LPCCs as providers and reduce the beneficiaries co-pay from 50% to 20%) and the much touted Patient Bill of Rights. Upcoming this year yet is mental health parity on a federal level.

The government relations committee is requesting that each chapter and division provide to the committee a representative so that OCA can represent counselors on a significant and prominent basis. All of these issues impact your family's income whether you are a counselor, counselor educator, or school counselor. So, OCA is asking you to step up and get involved.


Ohio Association of Marriage and Family Therapy to discuss potential collaboration on conferences in the future.
