The Senate Council recognizes that it does not have the power to amend minutes of the joint meeting of the Administrative Council and Senate Council. However, we feel that two changes should be made in the minutes of the joint meeting held on September 29, 1967, and we are therefore recommending to you, as the representative of the Administrative Council, that the following changes be considered:

In the <u>second paragraph</u> of the minutes of the Joint Meeting of Administrative Council and Senate Council held September 29, 1967:

The sentence:

"A discussion was held regarding the problem presented by the fact that the incumbent President of **Student** Council, Kenneth **Tomko**, is technically ineligible to hold this position since he does not have the 2.75 accumulative grade, average required by Student Council regulations."

be amended by deleting the last four words, "by Student Council regulations,"

The sentence:

"Moved by Dr. Mahn, seconded by Mr. Dykema, that Kenneth Tomko be allowed to continue as President of Student Council until further action can be taken by the Student Council itself."

<u>be amended</u> by deleting the last five words, "by the Student Council itself."

MINUTES OF MEETING OF YOUNGSTOWN STATE UNITERSITY SENATE COUNCIL HHLD OCIOBER 23, 1967

The Senate Council met on October 23, 1967, at 4 PM in Room 309 of the Science Building with Chairman Irwin Cohen presiding. Also present were Edward Reilly, Marilyn Solak, Frank Tarantine, Donald Byo, Philip Hahn, Esther Niemi, Margaret Pfau, and Gus Mavrigian.

Dr. Cohen announced that he had attended the first meeting of the Student Affairs Committee.

A discussion was held regarding the minutes of the joint meeting of the Administrative Council and Senate Council held on September 29, 1967. It was moved by Dr. Hahn, seconded by Dr. Tarantine, that the Senate Council recommend to the Administrative Council through Dean W. H. Coffield that the minutes of the joint meeting be corrected to read: "Moved by Dr. Hahn, seconded by Mr. Dykema, that Kenneth Tomko be allowed to continue as President of Student Council until further action can be taken." (thus deleting the words "by the Student Council itself.") Motion carried.

Moved by Dr. Hahn, seconded by Mr. Reilly, that the Senate Council recommend to the "dministrative Council through Dean W. H. Coffield that the minutes of the joint meeting be corrected further to read: "A discussion was held regarding the problem presented by the fact that the incumbent President of Student Council, Kenneth Tomko, is technically ineligible to hold this position since he does not have the 2.75 accumulative grade average required." (thus deleting the words "by Student Council regulations.") Motion carried.

Moved by Dr. Pfau, seconded by Mr. Reilly, that the Senate Council ask the Student Affairs Committee to consider the matter covered in the second paragraph of the minutes of the joint meeting of the Administrative Council and Senate Council held September 29, 1967. Motion carried,

Moved by Mr. Reilly, seconded by Mr. Byo, that we ask the Academic Affairs Committee to consider the suggestion that it should be combined with the Curriculum Committee, and that we ask the Curriculum Committee to consider the suggestion that it should be combined with the Academic Affairs Committee. Motion carried, Mr. Reilly offered to inform Dr. David Behen, Chairman of the Academic Affairs Committee, of this motion, and Dr. Pfau offered to inform Dr. Thelma Miner, Chairman of the Curriculum Committee, of this action.

A discussion was held regarding President A. L. Pugsley's suggestion made at the Senate meeting of October 13, 1967, that student representation should be included in a number of the standing committees. No agreement was reached on this matter, but it was agreed to continue this discussion at the next meeting to be held on October 25, 1967, at 4 PM in Room 309 of the Science Building.

Meeting adjourned at 5 P.M.

A list of committee appointments for the 1967-1968 academic year, as approved by the Administrative Council and the Senate Council, has been sent to you. The following applies to all these committees:

- 1. Committee actions on routine or procedural matters are effective immediately.
- 2. Policy matters are subject to approval by the appropriate authority, which is the Senate for Faculty Committees, the appropriate administrative reference for Administration Committees, and the Senate plus the appropriate administrative reference for Joint Committees.
- 3. Faculty and Joint **Committees** are required to report regularly to Senate Council. Administrative Committees are invited to report on matters of faculty interest.
- 4. Included in the list of committee appointments is a brief charge to each committee. As a first order of business, each committee is to study and, where advisable, improve this charge, subject to paragraph 2, above. Faculty and Joint Committees are requested to submit a preliminary report on this by November 24.
- 5. Committees are to proceed to consider matters they deem appropriate but are requested to inform the relevant authority (paragraph 3) of areas of study in order to avoid duplication of effort.
- 6. The Senate Council will request meetings with committee chairmen during the winter quarter in order to discuss changes in membership and possible changes in committee structure for next year.
