NEC has operated on authority of The Erecutive Committee of the University Senate. Through a mail ballot by the entire Full Service Faculty of Youngstown State University, taken in June 1971, the proposed plan of election to The OFS Elections Board, as shown below, was approved by the vote tally of: 218 for passage and 49 against passage.

Immediately upon the establishment of a list of nominees, an election will be structured to appoint:
a) A member of the College of Arts and Sciences to a three (3) year term;
b) A member of the School of Business Administration to a two (2) year term;
c) A member of the School of Education to a one (1) year terms

Also, in accordance with the approved plan, for development of The Elections Board, all future appointees to the Board shall serve a three (3) year term.

The membership of The OFS Elections Board shall bear all responsibilities in planning and conducting elections for Faculty Representatives (from Youngstown St ate University) to The Ohio Faculty Senate. The Board shall also structure the election for future membership to The Board. Thusly, this Board inherits the role served by NEC.
