BUSINESS EDUCATION AND TECHNOLOGY

Engineering Technology 618 (Change)

Data Processing Application. This course is designed to acquaint the student with business data processing applications. Practical case studies include payroll, accounts payable, budget control, inventory control, production control, etc. Three hours of lecture and three hours of laboratory per week. Prereq.: CPT 601 and 607 (SP) 4 q.h.

Accounting and Finance 731 (Change)

The Stock Market. Considers organization, operation, and regulation of security market. Practices, procedures, and regulations relating to the listing of securities and to the buying and selling of securities are covered. Prereq.: Finance 720 or consent of the department chairman. 3 q.h.

Elementary Education 630 (Change)

Creative Experiences for Child Care Centers. Designing educational programs for the pre-school child through discovery, manipulation and evaluation of materials and activities in art, music, movement, dramatics, literature, and science to help the young child express individuality in relation to his/her world. Includes work with children. 4 q.h.

Health and Physical Education 531 (Change)

\*\*Aquatics II. Intermediate Swimming. Introduction to back crawl, breaststroke, and butterfly. Techniques in underwater swimming; use of mask, snorkel, and fins. Elementary lifesaving skills and refinement of basic springboard diving. Prereq.: HPE 531 or its equivalent. 1 q.h.

Health and Physical Education 630 (Change)

\*Lifesaving Techniques. Water rescue, use of mask, snorkel,
poolside first aid, resuscitation, and pool maintenance. Red
Cross Lifesaving certificate granted upon satisfactory completion of course. Prereq.: Ability to swim 100 yards of each
of the following strokes with correct form: front crawl, back
crawl, side stroke, elementary back stroke, and breast stroke.
3 q.h.

Health and Physical Education 650 (Change)

Techniques of Officiating Soccer. Analysis and interpretation of rules; theory and practice of officiating soccer.

Prereq.: HPE 501 or equivalent. 2 q.h.

Health and Physical Education 655 (Change)

Techniques of Officiating Track and Field. Analysis and interpretation of rules; theory and practice of officiating track and field. Prereq.: HPE 506 or equivalent. 2 q.h.

Health and Physical Education 656 (Change)

Techniques of Officiating Volleyball. Analysis and interpretation of rules; theory and practice of officiating volleyball. Prereq.: HPE 502 or equivalent. 2 q.h.

Health and Physical Education 657 (Change)

Techniques of Officiating Swimming. Analysis and interpretation of rules; theory and practice of officiating swimming.

2 q.h.

Health and Physical Education 660 (Change)

Techniques of Officiating Field Hockey. Analysis and interpretation of rules; theory and practice of officiating field hockey. Prereq.: HPE 500 or equivalent. 2 q.h.

Health and Physical Education 555 (Addition)

Jogging. A holistic approach to the theory and practice of jogging with an emphasis on the physiological benefits. 1 q.h.

English 511 (Change)

Individual Instruction in English as a Second Language.
Individualized attention to special problems for non-native speakers of English. Students are divided into two sections by the instructor. The class is conducted in a laboratory format. Section I concentrates on drills in pronunciation and grammatical constructions; Section II focuses on problems in written composition and vocabulary expansion. This course, which may be repeated as many times as necessary, carries no credit toward a degree. 3 q.h.

English 640 (Addition)

Science Fiction/Fantasy. A literary study of significant novels and short stories--primarily modern--which treat of futuristic, fanciful or whimsical worlds. Prerequisite: 551 4 q.h.

English 617 (Addition)

Women in Literature. An examination of works written by and about women, drawn primarily from American and English writers. Prereq.: English 550 (Basic Composition I) or its equivalent, and sophomore standing. 4 q.h.

Secondary Education 800C (Addition)

Special Methods: Speech Communication. Exploration of the content and methodology involved in the handling of traditional speech subjects. Emphasis on the identification of core concepts, planning, instructional strategies, and evaluation. Same as Speech Communication 800C. Prereq: Senior standing; Education 706. 3 q.h.
