84-1 Honors (change)

701H, 702H, 703H. University Honors Seminar. A critical investigation of selected ideas underlying civilization, embracing and integrating the particular studies of science, society, and the humanities. Prerequisite: Eligibility for the Honors Degree Program. 3+3+3 q.h.

84-3 English (deletion)

710. Juvenile Non-Fiction. Study of non-fiction trade books appropriate for all levels of reading ability in the schools. Introductory to the full range of bibliographic aids for the teacher, with attention to the quality of various series and to criteria for evaluation. Does not count toward the University requirement in Humanities area, nor toward a major in English. Prereq.: English 709 or consent of instructor. 4 q.h.

84-4 Geography (change)

722. Historical Geography. A study of the methodologies used in historical geography and applied to selected regions. Prerequisite: Geography 640. 4 q.h.

84-7 ROTC, Military Science (change)

704. Advanced R.O.T.C. Summer Camp. Six weeks of field training, normally between junior and senior years, conducted at an Army installation. This concentrated practical training provides an opportunity to evaluate the student's application of academic knowledge to daily leadership situations. Prereq.: Permission of department chairman. 6 q.h.

REPORT OF THE AD HOC COMMITTEE ON UNCONDITIONAL ADMISSION

November 10, 1983

Following the adoption of the course requirements for unconditional admission, this Committee was charged with "the responsibility for developing 'a designated list of courses' from which students may draw for purposes of overcoming deficiencies". The Committee took into consideration the recommendations of the two committees who had previously made recommendations in this regard and now recommends approval of the following motion:

MOTION 1: Students admitted to the University who do not completely satisfy the course requirements for unconditional admission are required to correct those deficiencies by taking certain designated courses. The courses that a student takes depends upon the area in which the deficiency exists as follows:

English: The English Placement Test (EPT) determines placement regardless of whether a student has 3 or 4 units from high school so no course need be specified.

Mathematics: For a deficiency in Algebra I, a student must complete Math 500; for Geometry, Math 501; for Algebra II, Math 502.

Science: For each unit of deficiency, a student must complete any 4 q.h. course in the science areas (Biological Sciences, Chemistry, Geology, Physics, Astronomy, and Geography 503 or 630).

Social Studies: For each unit of deficiency, a student must complete any 4 q.h. course in the social studies areas (Economics, History, Political Science, Social Science, Psychology, Sociology, Anthropology, Social Work, Black Studies 600, and Geography, other than physical geography courses).

Foreign Languages: For a deficiency of 2 units, a student must complete 501, 502, 503 in one language; for a deficiency of 1 unit, a student must complete 503 in the same language as taken in high school.

Fine & Performing Arts: For a deficiency in this area, a student must complete any 3-4 q.h. course in art, theatre, or music.

The Committee interprets the policy on unconditional admission to be applicable to all students who graduate from high school after September 1985 who desire to pursue a baccalaureate degree. On this basis, it would apply to such students whether they first entered this University to pursue an associate degree program or transferred to the University from another institution, as long as they choose to pursue a baccalaureate degree here. However for such students, a variation in the policy may be needed since they may have already completed 90 q.h. The policy on correcting deficiencies stipulates that the student admitted with deficiencies is required to "register for at least one course aimed at removing a deficiency each quarter until reaching unconditional status" and that "the student is expected to achieve unconditional status within the first 90 q.h.". Accordingly, the Committee recommends approval of the following motion:

MOTION 2: If a student with university credit enters a baccalaureate program without having satisfied the course requirements for unconditional admission, he/she must register for at least one course aimed at removing a deficiency each quarter until reaching unconditional status.

Finally, the Committee wishes to alert the faculty and academic advisors of the importance of proper and careful advising in implementing the policy on unconditional admission.

Report to ACADEMIC SENATE, December 7, 1983 Meeting:

Academic Standards & Events Committee

P.W. von Ostwalden, Chairman

The Committee consists of 13 members (9 faculty, one of which is ex-officio/Prof. Rost, Chm. of Acad. Program & Curr. Committee/2 administrators, and 2 students) and has 1 student secretary.

We meet weekly (except in weeks with Senate meetings) for at least 1-1½ hours.

The major project before the Committee is the old problem of "Minimum General Requirements for Graduation" at YSU. (The Committee intends to address other projects only after the conclusion of this main project.)

The complex problem of Gen. Grad. Requirements has been worked on by this and other committees for several years. Its history has been eloquently presented to the Senate and, separately, to our Committee by Prof. Gould. He was the chairman of the "Ad Hoc Committee on General Requirements." Their efforts were summarized in a memo of June 2, 1981, commonly known as the "Gould Report."

Subsequently, our committee under the chairmanship of Prof. Joan DiGiulio continued work on the problem during 1981/82. At the occasion of a report on the project to the Senate, some senate members felt that a broader input and hearings from all segments of the University were needed to address the problem properly.

Accordingly, during the past academic year under the chairmanship of Prof. Hugh Earnhart, extensive hearings of faculty, chairmen, and most deans were held. On May 26, 1983, a majority of the Committee voted for a proposal which forms the basis of our present considerations. The details of this proposal will be presented to the Senate at a later time since they are still under debate.

At our 2nd meeting (Oct. 12) I gave a draft of a comparison table of the present YSU requirements and the proposed requirements to our committee members which was strictly meant for internal use. While the table is not secret, it certainly is not as yet part of our official proposal.

At present, the Committee works on the formulation of a rationale for its proposal. As suitable starting point, we began to rewrite the present area requirements for graduation (YSU 1983/84 Bulletin, p.41). The rewriting is almost (80-90%) completed.

As for the presentation of our new proposal to the Senate, we plan to proceed as follows:

After the rationale has been formulated (presumably in the course of the Winter Quarter), we will distribute copies of the proposal, the rationale, and the rewritten area requirements to all Senate members. All members will have a chance to consider the material prior to a formal meeting of the Senate. At that time, a motion will be made to adopt the proposal.

- The status of State Issues 2 and 3 before election and implications since defeat of issues
- The status of Ohio's attempts to promote excellence in higher education with such programs as Eminent Scholar, Program Excellence, and the Thomas A. Edison Partnership (higher education and business).
- Possible speakers for FAC, including Governor Celeste, Duane Rogers of OBOR, Mr. Zimmerman of STRS, and Pat Skinner (Program Excellence, chairperson)

For specific details regarding the above, please see the attached "Official Minutes" of FAC. The next regularly scheduled meeting is set for January 18, 1984. Let me know your suggestions or questions that you wish for me to convey to FAC.

Remarks
by CM

CM thanked FAC for its openness with him. He said that it was the primary contact that he had as Chancellor that kept him in touch with faculty. He reviewed briefly his years in academia and what they had meant to him and his family.

CM discussed at some length the future of higher education and urged the members of FAC to continue to show leadership in their respective schools. He opined that the next few years were going to be difficult, but that the fight was worth it. He reminded everyone that education is the fabric of civilization and will survive. The issue is, he asserted, what its nature would be. He concluded that educators must become assertive advocates of the value of education to society.

Kent-Akron
Merger

CM explained the development of the merger story. In an interview with the Akron Beacon-Journal when asked about the idea of an Akron-Kent merger had replied that it was not desirable. He added, however, that cooperation/merger between Kent and Cleveland State, especially at the graduate level, did make sense, and that it should be seriously looked at by the two schools. This led to the headline that he advocated merger.

Dependent
Fee
Waiver

CM in response to a question about legislative interest in dependent fee waivers stated that each institutional president has been asked to supply precise figures on the cost of their respective programs. This has resulted from a request from a state senator. CM asserted that the OBOR stance on this matter is that such waivers are an integral part of institutional fringe benefit packages.

Issues
2 and 3

CM said that opinions are split on the possible outcome of the vote on the two ballot issues. It is clear that the yes margin has eroded, but whether enough is not clear. He expressed his regret at the fact that some politicians have begun to politicize the issues.

The next meeting of FAC will be on Tuesday, November 22 with the morning session beginning at 10:30 a.m. and the afternoon one at 1:15 p.m. Both will occur in the OBOR Conference Room

Minutes of the Meeting of October 24, 1983.

Chair Laushey called the meeting to order with the following members present: J. Armstrong, G. Beelen, R. Boyer, C. Budd, J. Coady, P. Falkenstein, E. Fankell-Hauser, S. Givens, E. Harden, J. Jacob, P. Jastram, R. Johnson, J. Kosan, L. Laushey, B. Leidner, P. Lootons, T. Lower, G. Makar, L. Moore, H. Munro, R. Niedzielski, G. Rothman, P. Scott, and T. Valvoda.

Minutes The Minutes of the meeting of September 22, 1983 were approved as circulated. However, it should be clarified that the figures about enrollments were not based on the final fourteenth day figures used by OBOR.

MORNING SESSION

FAC Business A number of matters of business were handled during the morning session. They included:

- 1) Approval of a motion made by Valvoda and seconded by Leidner to delay the election of officers until the November meeting.
- 2) An announcement that despite the departure of CM, FAC will meet as scheduled on November 22nd.
- 3) An announcement that Mark Sherouse has resigned from OBOR to accept a position as Assistant to the President at Southern Methodist University.
- 4) Agreement on two future agenda items. The first that a person from STRS be invited to attend a morning session to discuss the implications for higher education of H.B. 410, and second that one or more members of the Search Committee for a new Chancellor be invited to meet with FAC in November or a later meeting. The latter suggestion was approved by passage of a motion made by Leidner and seconded by Niedzielski.

Acting Chancellor Coulter Acting Chancellor Coulter (ACC) visited briefly with FAC. He expressed his desire to continue working closely with FAC. He informed the committee that he was not a candidate for the Chancellor's position, but would work diligently to perform the functions of the office.

Chancellor Search ACC said that a Search Committee has been formed composed of three members of OBOR. The committee members are C. William Swank (Chair), N. Victor Goodman, and Helen H. James. He stated that he was sure that Richard L. Krabach, Chair of OBOR, would work closely with the committee. A job description has been drawn up and the position has been advertised nationally. Additionally, the committee has met with Governor Celeste who supported their efforts to find a strong person for the position and agreed to meet personally with any of the serious candidates.

Miscellany Two items of interest were passed on to FAC. The situation of financing at the OSU-Marion Regional Campus is still unresolved, but is now in the hands of the OSU administration. The debate centers around the use by OSU officials of the OBOR Guidelines for fiscal distribution as binding law. Miami supplied the group with information about the STRS/H.B. 410 provisions. It became clear from the discussion that there were varying interpretations concerning its application.

AFTERNOON SESSION

Luncheon FAC hosted a lunch for CM at the University Club. Following the meal several presentations were made. Secretary Givens presented a certificate commending him for his service. Chair Emeritus Boyer, after a few humorous (?) comments, gave him a handsome pictorial book on Great Britain inscribed with the signatures of the FAC members, and a travel clock. Counselor Jastram made several apt remarks about the career and character of CM. The tributes concluded with Chair Laushey thanking CM and wishing him well.

H. Munro suggested that OBOR give thought to a program which would aid schools to improve/enhance programs that have suffered because of the recent fiscal cutbacks. ACC recognized that there is a problem when only programs that are already successful are those that are given special support. He added that real evaluation of the new programs will be an extended process, but that with the announcements in the Spring of the biennial awards there will be a political evaluation.

Role of
FAC

Two requests submitted to ACC led to prolonged discussion. The two requests were those for a meeting with the Chancellor Search Committee and for one with Governor Celeste. ACC felt that both requests expanded the role of the committee from that of an advisory group to the Chancellor. Various members of FAC plead the position of FAC which is one, not of intrusion but of learning and sharing. The example of the time spent with Representatives Christman and Sweeney were cited to demonstrate both the precedent and the informational nature of the contact. ACC did agree to forward the letter from FAC to the Search Committee and asked Chair Jacob to write him a similar letter concerning a possible meeting with the Governor. He did continue to indicate, however, his reservations about the process.

2/4 Year
Articulation

The question of articulation between two year and four year schools in the arts requirements was raised anew with ACC. He pointed out that there were two possible separate issues involved - that of course transfer and that of blanket arts acceptance. He stated that he would pursue the matter and raise it with the two and four year college presidents.

Respiratory
Therapy
Program

Boyer reintroduced the question of the Respiratory Therapy Program approved for the Firelands Campus of Bowling Green. ACC responded that the program had been approved by OBOR although it appears that BGSU had not asked for voluntary clearance from CHINO which OBOR prefers to have done. He admitted that it was a program that might have slipped through the cracks.

Credit For
Life Experience

ACC was asked about the program for Credit for Life Experience. He stated that a state statute allows an institution to give academic credit for life experience. The normal pattern is for an individual to develop a life experience portfolio which is then submitted for review and evaluation. OBOR holds that if credit is granted it should be related to a specific course(s). He added that Sinclair has been active in the development and use of this approach.

Next meeting of FAC will be on Wednesday, January 18, 1984 unless a special meeting is called. The January meeting will convene for the morning session at 10:30 a.m. and the afternoon at 1:15 p.m. Both meetings will be in the OBOR Conference Room.

Minutes of the Meeting of November 22, 1983.

Chair Laushey called the meeting to order with the following members present: J. Armstrong, G. Beelen, R. Boyer, P. Falkenstein, S. Givens, E. Harden, J. Jacob, R. Johnson, K. Kalinos, J. Kosan, L. Laushey, B. Leidner, P. Lootens, G. Makar, J. McCorquodale, H. Munro, G. Rothman, P. Scott, and T. Valvoda.

MORNING SESSION

Minutes The Minutes of the meeting of October 24, 1983 were approved as circulated.

Election of Officers A slate of officers was presented by R. Boyer. The slate was L. Laushey for Chair, P. Falkenstein for Vice Chair, and S. Givens for Secretary. The floor was then opened for nominations with the following being made: J. Jacob for Chair and B. Leidner for Vice Chair. Following a keen exchange of views concerning the procedure and its wisdom, secret ballots were cast with the following results: Chair - J. Jacob; Vice Chair - P. Falkenstein; and, Secretary - S. Givens.

Immediately following the election J. Jacob assumed the Chair. He expressed his appreciation for the honor and moved that FAC publicly thank L. Laushey for his service as Chair. The motion was unanimously seconded by the whole committee.

Future Agenda FAC discussed possible individuals who might appear during morning sessions and the topics that they might discuss. The following possibilities were agreed upon:

- 1) That the Governor be asked to come to discuss the role of higher education in Ohio. The date for the visit, if the invitation is accepted, will be that set by the Governor.
- 2) Duane Rogers to come in January, if possible, to explain the Information Reporting System.
- 3) Mr. Zimmerman of STRS to appear in February to discuss various phases of the state retirement system including the plan found in H.B. 410.
- 4) Pat Skinner to come sometime during the Spring to update FAC on the Program of Excellence.

FAC also discussed a possible meeting with the Chancellor Search Committee or some members of the group. A letter written by L. Laushey to Acting Chancellor Coulter asking him to express this interest to the Search Committee was circulated to the group. The reaction of FAC was most positive to the proposal and a willingness to meet whenever convenient was expressed.

H.B. 410 B. Leidner cautioned those schools who have collective bargaining about allowing H.B. 410 to become a bargaining item. The problem, he felt, was that 410 only affected a few and if put into a bargaining package might be at the expense of some other fringe benefit which probably benefitted many more.

AFTERNOON SESSION

Post-SET Period ACC characterized the post-SET period as one initially of elation succeeded by a muted reaction. He quoted the governor as saying that the election outcome was "not a vote to spend." He added that state legislators were concerned about a rising surplus and favor some type of capping of it. The availability of funds has allowed capital improvements projects to be renewed.

Selective Financing In the light of the funding by the legislature of selective programs for the current biennium, ACC asked FAC for its reaction. The programs are the Eminent Scholar, Program Excellence, and the Thomas A. Edison Partnership. In each case only a select number of schools or programs will be awarded money. He hopes that FAC will provide feedback on the reactions of faculty.
