APPENDIX I

The first section on Choosing General Education Requirements replaces a similar section of page 38 of the 2000-01 *Undergraduate Bulletin*. Old language has been put in parentheses or brackets. Items 2 and 6 are new additions to the policy; refer also to Additional Majors and Degrees on page 28.

CHOOSING OLD OR NEW GENERAL EDUCATION REQUIREMENTS

Old general education requirements are those distribution requirements in place prior to the fall of 2000. See the *Undergraduate Bulletin*, 1999-2000, for information. New general education requirements are the goal-driven requirements listed in this *Undergraduate Bulletin*.

- 1 INCOMING FIRST YEAR STUDENTS SINCE THE FALL OF 2000 such students must take the new general education requirements. [REPLACES Incoming freshmen for the fall of 2000—must take the new general education requirements.]
- 2 STUDENTS WITH A BACHELOR'S DEGREE students coming from another university or from YSU with an already completed bachelor's degree shall not have to complete any general education requirements at YSU. [A new policy statement]
- 3 TRANSFER STUDENTS WITHOUT A BACHELOR'S DEGREE all transfer students will take the new general education requirements. Students who have completed the transfer module at a recognized institution may transfer 36-40 semester hours of general education credit. Such students must check with an advisor to determine which courses must be taken beyond the 36-40 hours to complete the YSU general education requirements. Transfer students who have not completed a transfer module will be given credit for courses taken at another university which equate to courses offered at YSU for general education credit. See an advisor or the Coordinator of General Education to determine which courses equate, and can be counted. [REPLACES Transfer students for the fall of 2000—students coming from another university may take either the old or new general education options, but may claim up to 36 hours of transfer credit toward general education if they have com-

pleted the transfer module offered by that university. A student who has completed a transfer module must check with an advisor to determine which courses must be taken beyond the 36 hours to complete the YSU program. Students who have not completed a transfer module will be allowed to transfer some of their credits if they match either YSU model. See an advisor to determine which courses equate, and can be counted.]

4 STUDENTS ENROLLED CONTINUOUSLY SINCE BEFORE THE FALL OF 2000 – these students have the option of continuing with the old model or switching to the new general education model. It is easiest for such students to continue with the distribution model; there will be plenty of courses available to do so. [Delete the following: In order to determine the number of courses remaining in an area, such as social studies, subtract the number of credit hours already taken from the number required and multiply by two-thirds to determine the number of semester hours to be taken (round the result down to the next highest whole number.)]

Those students who choose the new general education program must have an advisor evaluate the courses they have already taken to see if they equate to any of the certified general education courses under the new program. A general education bulletin is available with the list of newly certified general education courses and their equates under the former system. Under the new system students must take a math course, an oral communication course, 2 writing intensive courses, 2 oral communication intensive courses, and 2 critical thinking intensive courses, which were not required by the old system.[Add intensive after "2 oral communication."]

- 5 STUDENTS RE-ENROLLING AFTER THREE OR MORE SEMESTERS OF ABSENCE OR ITS EQUIVALENT; STUDENTS WHO COMBINE RE-ENROLLING AND TRANS-FERRING students who are readmitted will take the new general education requirements. [RE-PLACES These students may also choose the best option after consulting with an advisor.]
- 6 STUDENTS IN CONTINUOUS ENROLLMENT WHO SWITCH MAJORS OR DEGREES WHILE AT YSU students taking the goal-driven general education model will finish whatever portion of those requirements remains. Students taking the old general education model must satisfy the requirements that are part of the degree they are seeking. [A new policy statement]

The following sections have changes in brackets.

Transfer Credit (page 10 under items 2 and 3)

Advisors, in conjunction with the General Education Office [CHANGE to Coordinator of General Education], will determine which courses being transferred will fit within the YSU general education model.

Additional Majors and Degrees (page 28 for Multiple majors/multiple degrees)

If a student wishes to complete the requirements for majors which are awarded under different degrees, the student must fulfill all requirements for each major and each degree. [ADD See page 38 for students changing majors or degrees.] Completion of the requirements for each major and degree must then be certified by the appropriate chairpersons and deans. The student must file Intent to Graduate and Graduation Application forms for each major and each degree in the appropriate colleges.

Any student who has received a degree from another institution and desires a second degree from YSU must complete a minimum of 20 semester hours for an associate degree and 30 semester hours for a baccalaureate degree, meet all requirements for the second degree, and complete the requirements for a new major. [ADD Students coming from another university or from YSU with an already completed bachelor's degree shall not have to complete any additional general education requirements at YSU.]

APPENDIX II

ORAL COMMUNICATION INTENSIVE COURSES

The General Education Committee has reviewed the requirement that students take two oral communication intensive courses as part of the goal-driven general education model. The Coordinator of General Education, Bill Jenkins, and the Chair of the Communications and Theater Department, Dan O'Neill, have met with department chairs regarding the number, and reported to the committee that a general consensus had formed that there should be one less course required. The particular problem that led to this recommendation was the time that would have to be spent in class on oral presentations. For many faculty there was too much conflict with the coverage of course content. Hence, the General Education Committee is recommending that the Academic Senate reduce the number from two courses to one.
