## Report On American Sign Language

1-20-94

At the request of the Chair of the Academic Senate, the Academic Standards and Events Committee has examined the University's current offering of a course sequence in American Sign Language (ASL).

The committee recommends that students who successfully complete the course sequence in ASL (501, 502, and 503) be given credit toward the satisfaction of the University's foreign language requirement.

The committee makes this recommendation based upon:
(1) current Ohio law, and (2) current University practice.

Current Ohio law, as per Ohio House Bill 216 which became effective June 13, 1990, states that "American Sign Language is hereby recognized as a foreign language, and any state institution of higher education may offer a course in American Sign Language. An undergraduate student who successfully completes a course in American Sign Language is entitled to receive credit for that course toward satisfaction of an undergraduate foreign language requirement of the state institution of higher education where the course is offered." — State Universities — General Powers (section 3345.09)

Effective Fall 1993, the department of Foreign Languages began offering an elementary sequence in ASL. This sequence of courses was approved by the University Curriculum Division on April 15, 1993, and subsequently was approved by Academic Senate on May 5, 1993. A review of Senate Minutes indicates that there was no mention that this course sequence would apply toward satisfying the

University's foreign language requirement, even though this has become the current practice. In some instances this has led to confusion, as some faculty have not been aware that ASL counts toward satisfying the foreign language requirement.

This recommendation does not restrict an individual academic program from requiring proficiency in specific foreign languages when this is deemed appropriate for the given program. In other words, an academic program should be permitted to have a foreign language requirement which is more specific than the University's requirement.
