1. To carry out the recommendation of the policy formulated by the committee at its meeting of February 24, the committee proceeded to review the grade prerequisites already in the catalog as well as those which the various departments and divisions wished to introduce.

Accounting: Mr. Bloom moved and Mrs. Bridgham seconded the approval of the following recommendations for courses in accounting:

A grade of C or better in Accounting 202 is the prerequisite for Accounting 301, 308, and 403. A grade of C or better in Accounting 302 and 309 is a prerequisite for Accounting 401 and 409. A grade of C or better in Accounting 205 is a prerequisite for Accounting 305.

The motion was unanimously approved.

Note: Mr. Miller explained that a D in the first semester of a dash course does not exclude the student from the second semester of that course.

Biology: It was moved by Mr. Werley and seconded by Mr. Westenfield that the grade prerequisites already in the catalog for biology and in the outline of new courses recently approved by the Curriculum committee be approved by this committee. The motion was unanimously approved.

Foreign Languages: It was moved by Mr. Dykema and seconded by Mr. Werley that the grade prerequisites already in the catalog for foreign languages be approved. The motion was unanimously approved by the committee.

Education: Mr. Wilcox moved and Mr. Westenfield seconded that the following recommendations in Education be approved:

1. Those requirements at present listed in the catalog will remain as they are.

2. Candidates for a Bachelor of Science in Education must qualify for student teaching, must complete one of the curriculums in Education listed in the catalog, and must satisfy the requirements for an Ohio State Provisional certificate.

3. Students will not be accepted as candidates for the

Bachelor of Science in Education degree until their application for such candidacy has been approved by the Department of Education.

The resolution was unanimously approved by the committee.

Engineering: The committee discussed at some length several recommendations made by the Engineering Department. The two following ones were only tentatively approved in view of their obviously extended ramifications:

1. Any candidate for the degree of Bachelor of Engineering, Bachelor of Science with a major in Mathematics, or a Bachelor of Science in Physics who has a cumulative scholastic point index of less than 1.00 at the end of any semester will be placed on probation during the next semester. The student will not be readmitted to candidacy for these degrees if he fails to raise the point index to the necessary minimum during the probation semester.

Note: If this ruling goes into effect it will apply only to students who enter in September of 1948 and later and it will eliminate the present grade prerequisite requirements in the departments of Engineering, Mathematics, and Physics.

2. It was moved by Mr. Miller and seconded by Mr. Wilcox that the high school graduation requirements for acceptance to candidacy for the degree of Bachelor of Engineering be altered for the class entering in September of 1949 as follows:

English, 3 units; Algebra, 2 units; Plane Geometry, 1 unit; Solid Geometry, $\frac{1}{2}$ unit; Physics, 1 unit, History, 1 unit; Mechanical Drawing, 1 unit; electives, $6\frac{1}{2}$ units.

Music: Mr. Wilcox moved and Mr. Dykema seconded that the following grade requirements in music courses be accepted with the proviso that the following courses be not connected to the preceding one with a dash:

A grade of C in Music 109 is the prerequisite for Music 103 and a grade of C in Music 104 is the prerequisite for Music 203 and a grade of C is the prerequisite for the following courses in applied music.

The motion was unanimously approved by the committee.

English graduation requirements: It was moved by Mr. Wilcox and seconded by Mr. Dykema that the present C grade requirement in English in the catalog be approved and it was.

2. Item 3 of the Academic Standards Committee minutes for January 28, covering the final examination period was re-discussed and re-approved as it stands in the minutes for January 28. The procedure is as follows: Tentatively the examination period for the first semester will be restricted to the 18th week and for the second semester will not begin until Thursday or Friday of the 17th week.
