RESOLUTION:

THAT the YSU Academic Senate endorses the announced goal of converting from a quarter-hour calendar to a semester-hour calendar, to be implemented Fall, 2000; and

THAT such conversion will be done in ways which:

- * reflect the highest of academic standards,
- * provide for minimal disruption of programs for existing students,
- * are compatible with various accreditation standards and requirements,
- * convert existing courses directly by a 4:3 ratio, normally,
- * convert exiting degree totals by a 3:2 ratio, normally, and
- * are consistent with college-level conversion plans.

REPORT

To help implement this RESOLUTION, the Academic Planning Committee now is conducting a survey of faculty concerns and of reports from other "converted" institutions. A compiled list of problems to expect and reported solutions will be provided to college DACs, who may use it in preparation of their individual conversion plans.

Also, the Academic Planning Committee intends to develop a universal form for application to all curriculum- and program-level change proposals whereby changes which meet specific criteria on the form are expedited directly to the Academic Senate for adoption.
