The members of the Committee were nearly unanimous in their disapproval of the advertisement, though for rather different reasons. The Committee asked Dean Smith to communicate to the President an indication of the attitude of the Committee (Dean Smith did carry this communication to the President and the offending advertisement no longer mentions the names either of Mr. Bare or of the College.)
