intent.

The intent was the previous three(3) quarters(Spring, Summer, and

Fall) and it was suggested that we maintain the current procedure and have on the docket a request for the change. When the programming need can be satisfied, we would switch

to the new policy.

A further clarification was made about the term "Previous Academic Year" being that any recognition at any ceremony would include those students enrolled in any one of the

previous 4 quarters, including Summer.

It was agreed that a final statement be developed for the committee's consideration which takes into account the

suggestions for Academic Events Committee

Allied Health:

In regard to the memo dated February 3, 1981, the following topics were discussed:

On page 5, the terms major concentration and major were somewhat confusing. If the major is Allied Health there would not be a selection of majors. A student might be confused by thinking he/she is getting a B.S. in A.S. in Dental Hygiene, but that is incorrect; he is getting a B.S. in A.S. in Allied Health with his major concentration area being Dental Hygiene.

- 2) In the selection of the minor the question was raised as to why they had chosen Biology and Management which are departments and then Education which is a School.
- 3) There were also no definite courses listed for the major.
- 4) The question was raised as to why the list of minors was restricted to 3 areas. It was suggested that a list of approved and/or recommended minors be drawn up (and also a list of courses to take within the minor).
- 5) Also the question was raised as to why there were no upper division courses in the Bachelor program of Allied Health. It was pointed out that the upper division courses are taught in the major concentration areas.
- 6) The question was raised as to why there was not more physical sciences in the four-year degree.
- 7) On page 4, under Note #1, the term "Health related profession" was discussed and was agreed upon that this term should be modified as such, "allied health or an equivalent two-year degree".

Dr. Yemma was asked to develop a model curriculum for each of the concentration areas, and give consideration to the points needing clarification raised at this meeting.
